## EPA's BEACH Report: Alaska 2010 Swimming Season

May 2011

## Introduction

The BEACH Act of 2000 requires that coastal and Great Lakes states and territories report to EPA on beach monitoring and notification data for their coastal recreation waters. The BEACH Act defines coastal recreation waters as the Great Lakes and coastal waters (including coastal estuaries) that states, territories, and authorized tribes officially recognize or designate for swimming, bathing, surfing, or similar activities in the water.

This fact sheet summarizes beach monitoring and notification data submitted to EPA by the State of Alaska for the 2010 swimming season.

## 2010 Summary Results

How many notification actions were reported and how long were they?
When water quality standards are exceeded at a particular beach, Alaska issues a beach advisory that warns people to avoid contact with the water. None of the three monitored beaches had an advisory issued during the 2010 swimming season.

What percentage of days were beaches under a notification action?
No actions were reported during Alaska's 2010 swimming season (Figure 3).

How do 2010 results compare to previous years?
Table 2 compares 2010 notification action data with monitored beach data from previous years.

## What pollution sources possibly affect investigated monitored beaches?

Figure 4 displays the percentage of Alaska's investigated monitored beaches possibly affected by various pollution sources. In 2010, two out of three of their beaches reported that sources of pollution were unknown.
