Prop 23 is an initiative that will be on the ballot this November in California. Prop. 23 would effectively put AB 32 on hold until California's unemployment levels fell to 5.5% or below for one full year, which has happened only three times since 1980

Arnold Schwarzenegger, George Shultz, Robert Redford, Bill Gates, James Cameron, Leonardo Di Caprio and Al Gore have all weighed in to oppose California's Proposition 23, a November ballot initiative. Now comes the uber-endorsement for the No on 23 campaign: President Obama.

"The president is opposed to Prop. 23 -- a veiled attempt by corporate polluters to block progress towards a clean energy economy," White House spokesman Adam Abrams announced Wednesday. "If passed, the initiative would stifle innovation, investment in R&D and cost jobs for the state of California."

But it is not just about the Golden State. Abrams added, "The impacts could affect us all. If successful, corporate special interests will set their sights nationwide."

The White House might well be worried: Both proponents and opponents of the measure, which would suspend the implementation of [California's sweeping global warming law](#), say that as California goes, so go national prospects for climate change legislation.

Congress last spring killed a comprehensive bill aimed at cutting greenhouse gas emissions and spurring alternative energy, leaving California with the only economy-wide greenhouse gas law in the nation. Scientists say that carbon dioxide and other heat-trapping gases, spewed into the atmosphere by cars, trucks and industrial plants, are trapping heat in the atmosphere and [disrupting the global climate](#).

Europe has forged ahead with strict curbs, and some U.S. states have adopted more modest laws than California's. California is set to enact rules in December aimed at slashing its carbon footprint down to 1990 levels by 2020.

Proposition 23 would suspend the regulations until unemployment in the state drops to 5.5% for a year -- a level the state has achieved only three times in the last four decades. It is backed by oil refiners that say their electricity costs and other fees would rise dramatically, as well as the California Manufacturer and Technology Assn., a Sacramento-based trade group.

Harsh Words for E.P.A. From Most G.O.P. Candidates

WASHINGTON — The [Environmental Protection Agency](#) is emerging as a favorite target of the Republican presidential candidates, who portray it as the very symbol of a heavy-handed regulatory agenda imposed by the Obama administration that they say is strangling the economy.

Representative [Michele Bachmann](#) of Minnesota wants to padlock the E.P.A.'s doors, as does former Speaker Newt Gingrich. Gov. [Rick Perry](#) of Texas wants to impose an immediate moratorium on environmental regulation.

Representative [Ron Paul](#) of Texas wants environmental disputes settled by the states or the courts. Herman Cain, a businessman, wants to put many environmental regulations in the hands of an independent commission that includes [oil](#) and gas executives. Jon M. Huntsman Jr., the former Utah governor, thinks most new environmental regulations should be shelved until the economy improves.

Only [Mitt Romney](#), the former Massachusetts governor, has a kind word for the E.P.A., and that is qualified by his opposition to proposed regulation of carbon dioxide and other gases that contribute to [global warming](#).

Opposition to regulation and skepticism about climate change have become tenets of Republican orthodoxy, but they are embraced with extraordinary intensity this year because of the faltering economy, high fuel prices, the [Tea Party](#) passion for smaller government and an activist Republican base that insists on strict adherence to the party's central agenda.

But while attacks on the E.P.A., climate-change science and environmental regulation more broadly are surefire applause lines with many Republican primary audiences, these views may prove a liability in the general election, pollsters and analysts say. The American people, by substantial majorities, are concerned about air and water pollution, and largely trust the E.P.A., national surveys say.

"Not only are these positions irresponsible, they're politically problematic," said David Jenkins of [Republicans for Environmental Protection](#), a group that believes that conservation should be a core value of the party. "The whole idea that you have to bash the E.P.A. and run away from climate change to win a Republican primary has never been borne out. Where's the evidence?"

But the leading Republican candidates are all linking environmental regulation to jobs and the economy, suggesting that the nation cannot afford measures that impose greater costs on businesses and consumers. Mrs. Bachmann drew loud applause 10 days ago at a [rally in Iowa](#) when she declared: "I guarantee you the E.P.A. will have doors locked and lights turned off, and they will only be about conservation. It will be a new day and a new sheriff in Washington, D.C."

In an earlier debate she said the agency should be renamed the "job-killing organization of America." She has called global-warming science a hoax.

The White House disputes the accusation that it is burdening the economy with regulations. It says that it issued fewer new rules in its first two years than the George W. Bush administration issued in its final two years.

"This administration has shown a clear commitment to taking steps to protect our families from dangerous pollution, while at the same time ensuring those steps are implemented in a way that minimizes costs, maximizes flexibility and does not impede our economic recovery," said Clark Stevens, a White House spokesman.

Mr. Perry has been at war with the E.P.A. almost since the day he took office as governor.

He is leading a group of states in a [lawsuit](#) seeking to block the agency from putting in place rules limiting greenhouse gas emissions from power plants, refineries and other large sources.

On Monday, Mr. Perry called on Mr. Obama to [halt all regulations](#) because, Mr. Perry said, "his E.P.A. regulations are killing jobs all across America."

In his book, ["Fed Up, Our Fight to Save America from Washington,"](#) Mr. Perry described global-warming science as "one contrived phony mess that is falling apart under its own weight" and a "secular carbon cult" led by false prophets like Al Gore.

Such regulatory and financial sentiments are shared by many Republicans in Congress and are encouraged by industries that are reliable financial supporters of Republican candidates — the petroleum industry, utilities, [coal](#) companies, heavy manufacturers and the U.S. Chamber of Commerce. Republican presidential candidates cross these interests at their peril.

"It remains to be seen of course, but my guess is that in order to get the nomination you're going to have to be pretty solid on these issues," said Myron Ebell, of the [Competitive Enterprise Institute](#), a libertarian research and advocacy organization in Washington. "It's going to be a litmus test or shorthand way for voters to see how the candidate thinks about not only big issues like global warming and energy rationing policies, but it's indicative of other things as well."

Mr. Ebell said that Mr. Romney, Mr. Gingrich and Mr. Huntsman, who have all said that global warming is real and at least tentatively attributed it to human actions, would suffer for it in the Republican primaries.

Mr. Perry's anti-E.P.A. stance has been popular with Republicans in Texas and could carry him far in the primaries, said Ken Kramer, director of the [Texas chapter of the Sierra Club](#). It may prove a liability in a general election, Mr. Kramer said.

"That kind of rhetoric is popular with a certain segment here," he said. "But a lot of other Texans, especially those in major cities with air pollution problems, are not necessarily supportive of the governor's war on the E.P.A."

He added, "My sense is there's definitely a difference between what plays well in Texas from a political standpoint and what plays well in other parts of country."

Mr. Paul holds rather more complex views of the environment and regulation. He generally favors a hands-off approach to federal regulation, although he has backed some tax incentives for clean energy development.

He opposes tax breaks for oil and gas companies but supports Arctic drilling. He is skeptical about climate change but said in 2008 that there were [unexplained anomalies](#) in global temperatures.

Mr. Romney's position may be the most complicated of all. In Massachusetts, he proposed plans to reduce greenhouse gas emissions and was a sponsor of a regional [carbon cap-and-trade](#) program. He has mostly backed away from those positions, but he says there is still an important place for regulation.

"I believe we should keep our air and our water clean," Mr. Romney said at [a town hall-style meeting](#) in New Hampshire last month.

"Do I support the E.P.A.?" he said. "In much of its mission, yes; but in some of its mission, no."

Despite a Supreme Court ruling to the contrary, Mr. Romney said the federal law did not give the agency authority to regulate carbon emissions. "I don't think that was the intent of the original legislation," he said, "and I don't think carbon is a pollutant in the sense of harming our bodies."

Dear Mr. President:

As the nation's largest network focused on climate change, representing millions of supporters and allied organizations across the country, we call on you to swiftly issue meaningful standards to reduce greenhouse gases from power plants under the Clean Air Act. We are deeply concerned that the Environmental Protection Agency will not meet the September 30 deadline to issue standards that limit climate-changing pollution from new and existing power plants. Any significant delay in setting this standard is unacceptable.

Americans and the rest of the world are already suffering from the impacts of climate change. A shift towards more extreme weather including devastating drought in Texas and the Horn of Africa, and violent wildfires in Arizona and Russia is an expected consequence of a continually warming world. Further delay in reducing carbon pollution will greatly increase the risks of economic, public health, and environmental consequences due to a warming planet and increased extreme weather events.

Power plants are the largest industrial sources of the dangerous pollution that drives climate change accounting for more than 2.4 billion tons of carbon dioxide emissions each year. The science continues to affirm it has never been more urgent to act boldly in the short timeframe needed to protect the public from the risks to health and welfare posed by climate change. Yet there are currently *no national limits* on the amount of carbon pollution being dumped into the air.

Strong action to reduce harmful emissions from power plants will improve the air quality and public health of local communities and move the U.S. one step closer to taking meaningful action to help reduce global greenhouse gas emissions. A national standard will be based on existing technology that is available, proven and affordable for power plants. Utilities and investors will benefit from the certainty provided by these standards so they can begin to make the necessary long-term investments to ensure an orderly transition to a cleaner, more efficient electricity system.

Clean Air Act standards for power plant greenhouse gas pollution are long overdue. The 2007 Supreme Court decision *Massachusetts vs. EPA* ruled that greenhouse gas pollution endangers

public health and welfare and again in June of this year the Court unanimously reaffirmed that it is the EPA's responsibility to protect Americans from climate-changing pollution. Yet the schedule for setting achievable limits has again been delayed.

The EPA must issue meaningful standards as swiftly as possible for new and existing power plants as the Clean Air Act requires addressing the harmful effects of climate change. USCAN is a network of 90 member organizations, working at the local, state, federal and international levels of the debate, to support the design and development of an effective, equitable, and sustainable strategy to reduce greenhouse gas emissions. We call on you to instruct the EPA to adhere to an aggressive schedule for proposing these standards without further delay and for completing them as soon as possible in 2012.

Dear Administrator Jackson,

Our Wisconsin Senate districts comprise approximately the northern half of the state, a largely rural area that is heavily forested and sustains countless jobs that rely on the forest industry. As you know, the forest products industry employs more than 160,000 people statewide. The industry contributes \$5.3 billion in GSP from private forests alone.

Despite 35 years of forest road management practices to the contrary, the U.S. Court of Appeals for the Ninth Circuit ruled in May 2011 that the Environmental Protection Agency lacked authority to designate forest roads and associated storm water runoff systems as "nonpoint" sources. This means that forest roads and their runoff systems will be subject to the Clean Water Act's National Pollutant Elimination Discharge System (NPDES) permit system, and each culvert or drainage ditch on a forest logging road will be considered a "point source," much like a factory or coal-burning power plant. The state of Oregon and other defendants in the case recently appealed the decision to the Supreme Court.

Pending that appeal, the decision by the Court of Appeals has left the EPA in a difficult position. As the Agency decides how to respond to the court's decision, I ask that you carefully consider the impact any action will have on the forest industry and choose the least burdensome solution possible.

Environmental practices in place over the last 30 years have both protected our valued forest resource and allowed the forest products industry to succeed. The forest industry is a critical employer in Wisconsin and thousands of families and businesses in the state are reliant upon the jobs the industry provides. With unemployment well over 9% in Northern Wisconsin we simply cannot afford to see more jobs lost at this time.

NLC is a strong supporter of the U.S. Environmental Protection Agency's (EPA) Clean Water
State Revolving Loan Fund (SRF). The Clean Water SRF, along with the Drinking Water SRF,
are integral tools used by our communities for providing clean, drinkable, and swimmable water
to the American people. Additionally, a new grant program for municipalities to carry out
projects to control municipal combined sewer overflows and sanitary sewer overflows will aid in
pollution control and help protect our nation's water resources.

As you know, despite the fact that local governments fund 95 to 98 percent of all water and
wastewater infrastructure investment, the needs in our communities continue to grow according
to EPA surveys. The EPA's most recent Clean Watersheds Needs Survey indicates that the 20
year investment needed to upgrade our nation's total wastewater and stormwater management
infrastructure to meet the water quality goals set in the Clean Water Act to be \$298.1
billion. And, according to our studies, these investment levels are actually an underestimate
given the advancing age of our infrastructure, the burden of unfunded federal regulatory
mandates, and factors not yet known as a result of our changing climate.



Blueprint for Communicating Risk and Preventing Environmental Injustice

Abstract: Toxic environmental emissions have the potential to harm already susceptible populations living in close proximity to industries with pollutant emissions such as coal-fired electrical power plants. The organized dissemination of information in communities that find themselves susceptible to occupation by industries with pollutant emissions is a crucial step in the long and arduous process of preventing such harm. Here, we present a blueprint that can be used by community organizations to prevent industries that pollute the environment from locating in communities that are already disproportionately exposed to pollution (referred to here as *environmental justice communities*). We base this blueprint on a specific case in Taylor County, Florida, where the steps outlined successfully prevented the Taylor Energy Center (TEC) consortium from obtaining the necessary permits for the operation of a proposed coal-fired electrical power plant, thereby minimizing the risks of additional toxicant exposure to the affected community.

Key words: Toxic emissions, polycyclic aromatic hydrocarbons, benzo(a)pyrene, environmental justice, risk communication, coal-fired electrical power plant, community-based participatory research, susceptibility-exposure paradigm, community-based organization, health disparities.

There are legitimate concerns regarding the deleterious effects upon human health and welfare caused by exposure to emissions from coal-fired electrical power plants. Environmental contaminants and pollutants emitted as a result of the combustion of fossil fuels include, but are not limited to, polycyclic aromatic hydrocarbons (PAHs), sulfur dioxide (SO₂), oxides of nitrogen (NO_x), carbon monoxide (CO), ozone (O₃), volatile organic compounds (VOCs), heavy metals and particulates. Exposure to such pollutants can lead to adverse effects on the respiratory, cardiovascular, nervous, urinary and digestive systems, as well as on the developing fetus.¹⁻⁵ As mentioned above,

EXECUTIVE SUMMARY

Submerged aquatic vegetation (SAV) has declined dramatically in the Chesapeake Bay and worldwide, largely as a result of stress from poor water quality. In response, the Chesapeake Bay Program established a goal of achieving 185,000 acres of SAV bay wide, recognizing that this level of restoration would be dependent upon improved water quality. As part of this restoration strategy, the Bay Program set a goal of “direct restoration” of 1000 acres of SAV via planting of whole plants or seeds in areas of historic beds, with the expectation that these restored beds would help to “kick-start” broader expansion of SAV beds. Years after establishing these goals, results have fallen far short of the original targets. Consequently, STAC was requested to conduct a review of the effectiveness of direct SAV restoration efforts, evaluate the efficacy of the direct restoration strategy for accelerating broader SAV recovery and, if appropriate, provide guidance on how to improve the restoration efforts.

To accomplish these tasks a committee comprised of STAC members and SAV experts from outside the region reviewed published and unpublished data provided by the Bay’s SAV Workgroup. The committee considered the success of these restoration efforts on several levels: (i) operational success (progress towards 1000-acre goal), (ii) functional success (persistence and spread of planted beds and performance of SAV ecosystem functions), and (iii) programmatic success (knowledge gained towards achieving restoration goals). The review committee evaluated program techniques, such as site selection, planting, monitoring and the implementation of adaptive management. It also considered the overall effectiveness of the direct restoration approach towards meeting the larger goal of restoring 185,000 acres of SAV. Finally, the committee made recommendations related to techniques, program evaluation and the need for more integration of research and adaptive management approaches towards restoring SAV to Chesapeake Bay.

The initial estimate of the cost to plant and monitor 1000 acres of SAV was \$31,386,000 (CBP 2003) of which only \$5,063,000 was provided. Within this context, the program was operationally successful in planting 150 acres, a proportion of the 1000-acre target that approximates the level of funding received. Nevertheless, the large funding shortfall limited the program’s ability to achieve its goal. Functional success was not generally achieved since the majority of beds planted did not persist beyond one year and did not spread beyond the original planting area. However, some important exceptions to this pattern were beds in the York and James rivers that persisted and expanded far beyond their initial planting areas. The restoration effort has shown modest programmatic success, employing adaptive management as new knowledge has been gained. Site selection tools and planting techniques were improved over time and some lessons learned from successes and failures were applied to improve restoration choices.

Our review generally supports the techniques used for planting and monitoring SAV. Evidence from the York and James rivers and from Virginia’s Coastal Bays supports the premise that SAV beds can be successfully restored using these techniques where water quality is sufficient. The majority of direct SAV restoration efforts were undertaken with eelgrass *Zostera marina*. The rationale for focusing most of the effort on this species—its wide distribution, established restoration techniques and historic low levels—was sound. However, if more resources had been available to develop techniques, direct restoration with other species would have been desirable.

The primary means of selecting restoration sites was a GIS-based decision tool, which incorporated information on water quality, water depth, current and historical SAV distribution, important fisheries habitat, and potential disturbance from clam fisheries. Though this site selection model was arguably state-of-the-art at the time it was developed, it fell short in meeting its intended use. A review of the

model's effectiveness revealed that it was adequate for predicting sites where germination of SAV seeds would occur, but not for predicting persistence of beds beyond one year. Shortcomings of the model include (i) limitations on the data available to parameterize it, (ii) failure to include temperature as a stressor, and (iii) perhaps most importantly, reliance on multi-year average water quality, rather than variances and even extremes. This latter limitation was evident in numerous instances when data used to select restoration sites were collected in dry or average rainfall years and restoration was then followed by high rainfall (and thus poor water quality) years. The need to incorporate longer-term data sets, multiple stressors and environmental extremes into the site selection model is now apparent.

This report is organized into four sections: 1. Charge to the Committee 2. Review of SAV Workgroup Efforts and 3. Summary and Conclusions. 4. Specific recommendations for any future program are provided at the end of the report.

Dear President Obama:

I am writing on behalf of the 14,566 members of UMWA District 12 because we are concerned about the loss of coal mining jobs due to proposed EPA regulations for Maximum Achievable Control Technology at electric utility plants. We believe that the recently issued Transport Rule for reducing utility emissions of NOx and SO2 will compound the risk of job losses at a time of high coalfield unemployment and weak growth prospects.

The Transport Rule's deadlines are simply not feasible. Utilities cannot reasonably be expected to retrofit controls by 2012. Many plants will not have time to retrofit scrubbers by the second phase deadline of January 1, 2014. We hope that you will request EPA to grant the petitions for an administrative stay and reconsideration of this rule.

Providing additional time for compliance with EPA's MACT and Transport rules would increase the number of coal-based generating units that are upgraded with retrofit controls, increasing construction jobs and reducing unemployment due to coal market disruptions and plant closures.

The UMWA knows from experience that cap-and-trade regulations like the Transport Rule can inflict unacceptably large job losses due to fuel-switching. More than 30,000 mining jobs were lost under the 1990 acid rain

program, as production shifted from eastern to western mines. We see little opportunity to meet the stringent reductions of the Transport Rule without large-scale fuel-switching. We particularly object to the rule's emission allocation scheme that severely penalizes many well-controlled plants equipped with SO₂ scrubbers and advanced NO_x emission controls.

Hundreds of smaller and older coal-based generating units may not be able to achieve one or more of the MACT emission limits proposed last March. Job losses would occur in economically-depressed areas already suffering from high unemployment. Worse, the MACT rule would preclude the construction of state-of-the-art new coal plants because of the stringency of its proposed emission limits for mercury and other air toxics.


A UMWA analysis indicates that 54,000 direct jobs and more than 250,000 total jobs related to utility, mining and rail transport may be at risk of near-term closure. Our estimates are confirmed by preliminary studies by the Federal Energy Regulatory Commission. FERC staff estimate that up to 81,000 Megawatts of coal-based capacity could be lost due to pending EPA regulations.

EPA lacks sufficient time to respond to the issues raised by comments on the proposed MACT rule. This is the most expensive utility rule ever proposed by EPA, and the agency should ask the court for additional time to develop a final rule.

Finally, we are asking that you use your authority under the Clean Air Act to provide at least a two-year extension of the three-year compliance deadline for MACT. Providing more time to install controls at more than 1,000 units impacted by this rule is critical given the 4-5 year lead time for retrofitting scrubbers at powerplants.

Thank you for your consideration of our concerns.

For the purposes of the Cross State Air Pollution Rule, DTE Stoneman, LLC is hereby submitting this petition to the USEPA Administrator requesting reconsideration of the allowance allocation provided to its facility located in Cassville, Wisconsin. We believe the facility was unfairly treated by providing very little allowances to cover its projected emissions after the repowering using 100% wood biomass renewable fuel. The Boilers at the DTE Stoneman facility, boilers B1 and B2, are treated by USEPA as existing units while they should be classified as "New Units" and allocated SO₂ and NOx allowances to cover 100% of their projected emissions according to the "New Unit" allocation methodology. The allowances provided by EPA, under the current approach, is well short of what the plant needs to cover its projected emissions as shown in the summary table below.

It is DTE Stoneman's position that the repowered renewable energy plant that underwent New Source Review permitting and resulted in fuel switching to wood biomass with low sulfur content and installation of SNCR and OFA as BACT for NOx control, be afforded sufficient allowances to cover 100% of its projected emissions (see table above) or

significantly increase its allowance allocation under the current approach by relying on projected heat input. The basis for this petition, besides the severe economic hardship that the current EPA approach will impose on the facility, are the errors we identified in EPA's application of the allowance allocation methodology and include:

- Classification of the units as "existing" versus "new"
- Erroneous inputs (e.g. projected actual emissions for 2012 and 2014) to the IPM model under the current approach
- Emissions Reductions already achieved through New Source Review consistent with intent of the CSAPR rule
- If classified as "existing", EPA should not rely on historical heat input from the facility as this data does not reflect future plans for plant operation. It should rely on projected heat input.

Severe Economic Hardship

USEPA's current allocation as finalized will unfairly impose an economic hardship on a plant that invested significant capital into the facility, the community, and in establishing a wood biomass renewable fuels market which created jobs during our current weak economic environment. DTE Stoneman invested significant capital to reconstruct and repurpose an aging coal plant and create renewable power for the plant's customer in Wisconsin. This is a merchant power plant. Purchasing the allowances necessary to operate the plant and to retrofit utility scale emission controls such as SCR and/or wet scrubber is not economical, both in initial capital costs and continuing maintenance costs for a facility of this size. This plant cannot file a rate case to recover the cost as a utility would be able to. Therefore, this rule imposes an unfairly severe economic hardship on the plant.

DTE Stoneman Repowering and Classification of Boilers as "New Units"

The facility consists of two 340 mmbtu/hr rated boilers serving through cross connected steam headers, 33 MW and 18 MW generators. Emissions are through a common stack. The two units were originally built in 1949 and 1951 and designed to burn coal. DTEES purchased the facility in May 2008. Prior to the purchase, the previous owner operated the plant intermittently, selling the electricity through the Midwest Independent System Operator (MISO) at market rates. After the facility was purchased by DTEES, the units were operated intermittently to burn down the remaining coal pile in preparation for the conversion from coal to wood biomass firing. The remaining coal pile was depleted in March 2009. The facility was shut down during the March 2009 to August 2010 period while the units were permanently disabled by removal of the lower half of each unit and replacing boiler tubes. The units were replaced by new stoker grate units to enable combustion of wood biomass. The units underwent New Source Review permitting which required as BACT the installation of add-on emission controls for NOx including SNCR and OFA. The conversion of the plant from coal to wood biomass provided

significant reduction in SO₂ emissions due to the low sulfur content of wood biomass. These new stoker grate units started the commissioning process on July 28, 2010 and began commercial operation on October 8, 2010. Since commercial operation began after January 1, 2010 the units should receive allowances from the new unit set aside and not be allocated allowances as existing units.

Erroneous Input to IPM Model

The IPM modeling assumes an incorrect amount of NO_x and SO₂ emissions in 2012 and 2014. The “ptipm_2012” tab has 110 NO_x tons per year for both Point IDs B21 and B22. This value should be 280 NO_x tons per year. The “ptipm_2012” tab also has 44 SO₂ tons per year for both Point IDs B21 and B22. This value should be 205 SO₂ tons per year. The “ptipm_2014” tab has 184 NO_x tons per year for both Point IDs B21 and B22. This value should be 280 NO_x tons per year. The “ptipm_2014” tab has 74 SO₂ tons per year for both Point IDs B21 and B22. This value should be 205 SO₂ tons per year. The “ptipm_2014ctrl” tab has 184 NO_x tons per year for both Point IDs B21 and B22. This value should be 280 NO_x tons per year. The “ptipm_2014ctrl” has 74 SO₂ tons per year for both Point IDs B21 and B22. This value should be 205 SO₂ tons per year.

Intent of CSAPR

DTE Stoneman should receive significantly higher allowances than currently provided. The intent of the rule and allowance allocation approach EPA took is not to penalize units for choosing cleaner fuels or installing pollution controls. DTE Stoneman converted the plant to 100% wood biomass, reduced fuel sulfur content and installed SNCR and OFA as BACT for NO_x control. Wood biomass is a cleaner burning fuel than coal, which resulted in significantly reduced SO₂ emission rate. It also installed SNCR and overfire air as add-on emission controls to reduce NO_x emissions. With the fuel conversion, the use of SNCR and overfired air, the current EPA approach in allocating allowances provided DTE Stoneman very little to cover future emissions. DTE Stoneman previously fulfilled the intent of the rule by converting to biomass and now is being asked to buy a significant number of allowances and retrofit with additional pollution controls that are not economical and likely not technically feasible.

Projected Heat Input vs. Historical Heat Input


DTE Stoneman should receive significantly higher allowances than currently provided. The allocation method EPA chose for the final CSAPR consists of the use of historical heat input to allocate allowances instead of projected heat input. Though this approach may make sense for units that have not undergone reconstruction during the look back period, it is not a logical way to appropriately allocate allowances for DTE Stoneman. The plant was unfairly penalized for converting the plant from 100% coal to 100% Biomass and for installing SNCR and OFA. The reconstruction occurred between April 2009 and July 2010, during the baseline period. Prior to the reconstruction, the facility

did not operate often combusting coal (capacity factors in the 3% to 17% range). EPA should allocate based on DTE Stoneman's projected emissions using limited operation data from 2010 and extrapolating for a full year operation and projected capacity factor rather than using the highest 3-yr average between 2006 and 2010 which is not representative of the biomass plant we currently have and future operating conditions.

Due to the extraordinary reasons listed above, DTE Stoneman should receive a significant increase in the allocated allowances to be consistent with the intent of the rule and not cause severe economic hardship to this renewable energy facility. The City of Alexandria, Louisiana (the "City" or "Alexandria") hereby requests that the United States Environmental Protection Agency ("EPA") reconsider and stay the effectiveness of its Final Rule entitled *Federal Implementation Plans to Reduce Interstate Transport of Fine Particulate Matter and Ozone in 27 States; Correction of SIP Approvals for 22 States*, published at 76 Fed. Reg. 48,208 on August 8, 2011 ("Final Rule").

Alexandria is a home rule charter municipality organized under the Constitution and the statutes of the State of Louisiana as a municipal corporation in the Parish of Rapides with a population of approximately 50,000. The City owns and operates a not-for-profit electric utility system, which currently includes 140 MW of generating capacity located at Alexandria's D.G. Hunter Generating Station. The City is also entitled to approximately 55 MW of the output of Rodemacher Unit No. 2 pursuant to terms of an agreement between the City and the Louisiana Electric Power Authority.

The City has not previously filed comments in this proceeding. When the EPA issued its proposed rule in this proceeding, the nitrogen oxide (“NOx”) emissions budget for the State of Louisiana was 21,220 tons for the 2012 ozone season. When the Final Rule was issued, however, the City learned for the first time that the EPA had cut the state’s NOx budget to 13,432 tons – a 37% reduction in the NOx emissions permitted from the state’s electric generating units (“EGUs”) for the 2012 ozone season. As discussed in the Request for Reconsideration and Stay filed by the State of Louisiana Department of Environmental Quality in this proceeding on October 5, 2011, the reduction to the state’s NOx budget contained in the Final Rule has far-reaching implications for the state’s EGUs – including those units owned by the City.

Because the City became aware of the potential impact of the Final Rule only after it was issued, the City has been denied its right to meaningfully participate in this proceeding. The City has never been presented an opportunity to study and comment on the impact of a 13,432 ton budget for the 2012 ozone season on its electric utility operations. Nor has the City or any other interested party been given an opportunity to comment on the reasonable amount of time needed to permit compliance with the EPA’s revised NOx emissions levels for 2012 and beyond.


The Administrative Procedures Act, 5 U.S.C. § 101 *et seq.*, provides that “[a]fter notice...the agency shall give interested persons an opportunity to participate in the rule making through submission of written data, views, or arguments....” 5 U.S.C. § 553. Similarly, section 307(d)(3) of the Clean Air Act requires that the EPA must provide adequate notice of, and the opportunity to comment on the elements of its rulemakings. The City could not comment on the impact of a 13,432 ton NOx emission budget for the State of Louisiana for the 2012 ozone season because it had no reason to believe that the EPA was considering a budget that was a full 37% lower than what it had initially proposed in this proceeding.

The opportunity for the City to submit these comments after the promulgation of the Final Rule is an insufficient remedy under the APA. “Section 553 [of the APA] is designed to ensure that affected parties have an opportunity to participate in and influence agency decision making at an early stage, when the agency is more likely to give real consideration to alternative ideas.” *United States Steel Corp. v. EPA*, 595 F.2d 207, 214 (5th Cir. 1979). Nor could the City have reasonably anticipated that the Final Rule would depart from the proposed rule in such a significant manner. The D.C. Circuit has held that “[g]iven the strictures of the notice-and-comment rulemaking, an agency’s proposed rule and its final rule may differ only insofar as the latter is a ‘logical outgrowth’ of the former.” *Envil. Integrity Project v. EPA*, 425 F.3d 992, 996 (D.C. Cir. 2005). The court explained further that a final rule is a logical outgrowth of a proposed rule “only if interested parties should have anticipated that the change was possible, and thus reasonably should have filed their comments on the subject during the notice-and-comment period.” *Id.* at 998. The City, however, had no reason to believe that the EPA would

change its rule so significantly from the proposal stage when issuing the Final Rule. Nor could the City have submitted meaningful comments on a hypothetical NOx emissions budget and the reasonable amount of time necessary to comply with that emissions budget.

The City of Alexandria therefore respectfully requests that the Administrator convene a proceeding for reconsideration of the Final Rule and afford the City and other interested parties the opportunity to comment on the reasonableness of the proposed NOx baseline for the State of Louisiana. The City requests further that the Administrator stay the effectiveness of the Final Rule during the pendency of the reconsideration for the maximum time allowed by law.

Dear Administrator Jackson,

Our Wisconsin Senate districts comprise approximately the northern half of the state, a largely rural area that is heavily forested and sustains countless jobs that rely on the forest industry. As you know, the forest products industry employs more than 160,000 people statewide. The industry contributes \$5.3 billion in GSP from private forests alone.

Despite 35 years of forest road management practices to the contrary, the U.S. Court of Appeals for the Ninth Circuit ruled in May 2011 that the Environmental Protection Agency lacked authority to designate forest roads and associated storm water runoff systems as "nonpoint" sources. This means that forest roads and their runoff systems will be subject to the Clean Water Act's National Pollutant Elimination Discharge System (NPDES) permit system, and each culvert or drainage ditch on a forest logging road will be consider a "point source," much like a factory or coal-burning power plant. The state of Oregon and other defendants in the case recently appealed the decision to the Supreme Court.

Pending that appeal, the decision by the Court of Appeals has left the EPA in a difficult position. As the Agency decides how to respond to the court's decision, I ask that you carefully consider the impact any action will have on the forest industry and choose the least burdensome solution possible.

Environmental practices in place over the last 30 years have both protected our valued forest resource and allowed the forest products industry to succeed. The forest industry is a critical employer in Wisconsin and thousands of families and businesses in the state are reliant upon the jobs the industry provides. With unemployment well over 9% in Northern Wisconsin we simply cannot afford to see more jobs lost at this time.

As a State Senator in the Michigan Legislature, I am well aware of the industries that drive our state's economy. My district, in the Upper Peninsula, includes a majority of Michigan's forest lands. Timber plays a major role in our state, providing employment and economic growth. With 19 million acres that cover 53 percent of the state, Michigan's forests support 150,000 jobs and contribute more than \$12 billion to Michigan's economy annually. Michigan's timberland acreage is the fifth largest in the nation. I am deeply concerned that a recent court ruling by the U.S. Ninth Circuit Court of Appeals will weaken this vital industry in Michigan by increasing operating costs for business that produce and transport forest products.

Overturning decades of existing EPA practice, the Ninth Circuit earlier this year determined that the Environmental Protection Agency could not define forest roads and their storm water runoff systems as a "nonpoint" sources. Drainage ditches on logging roads will now be categorized as "point" sources, like factories or mining operations. As a result, temporary logging roads will be part of the National Pollutant Elimination Discharge System (NPDES), and those who own and operate these roads must receive special permits. Delays and litigation created by the new permitting process will burden forest owners in Michigan. The state stands to lose countless jobs. The Michigan Department of Environmental Quality (DEQ) and Department of Natural Resources (DNR) set standards for stewardship of our forestlands and are in a better position to

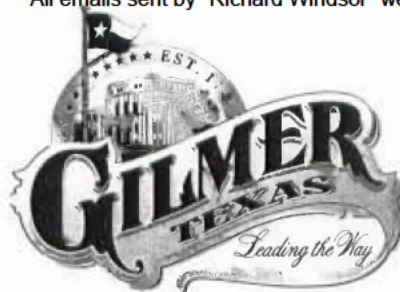

Dear Mr. President:

I am writing to you today regarding the Environmental Protection Agency's soon to be final regulation for utility maximum achievable control technology (MACT) standards for hazardous air pollutants. As the mayor of [Insert City] I strongly urge the Administration to utilize all of the flexibility tools it has available under the Clean Air Act and to provide utilities with greater compliance flexibility.

As you know, EPA is required to finalize the Utility MACT by November 16. I am concerned that the final rule, unless it is modified, could negatively impact [INSERT CITY] and my constituents at a time when we are making every effort possible to create new jobs and restore economic growth. These facilities will be required to be in compliance with the new standards within three years of the rule's effective date, which is impractical, resulting in premature plant closures and unnecessary rate hikes to our citizens.

I believe EPA's proposed three-year implementation schedule is too short and does not adequately take into account the unprecedented number of controls that will need to be installed in our region and across the country, at nearly the same time. EPA can and should extend the compliance deadline for one additional year for all units that are installing new pollution control equipment; that are being replaced or repowered; or whose closure requires expanded transmission capacity for reliability purposes. Such an extension would give utilities more flexibility and would be in line with Executive Order 13563 that states regulations "must promote predictability and reduce uncertainty."

Your Administration has many available tools under the CAA when implementing the Utility MACT and we encourage you to use them all, including, in appropriate circumstances, the

Presidential exemption provisions. I hope that you will agree that additional implementation flexibility will improve the rule and will minimize the compliance costs for customers, reduce regulatory uncertainty, and help to protect electric reliability, while still achieving the desired emissions reductions.

Thank you for your personal attention to this matter.

I appreciate the willingness of senior management at the U.S. Environmental Protection Agency (EPA) to work so closely with their counterparts at the Department of Defense (DoD) regarding the proposed District of Columbia (DC) Municipal Separate Storm Sewer System (MS4) permit. I am pleased that this Clean Water Act permit applies the same performance criteria to federal and non-federal facilities. DoD is committed to maximizing our efforts to reduce storm water pollution throughout the District and to complying fully with federal laws, regulations and directives, including Presidential Executive Orders 13508 and 13514, the Energy Independence and Security Act (EISA), and the Clean Water Act. In addition, as I stated in my January 2010 Policy Memorandum, "DoD Implementation of Storm Water Requirements under Section 438 of [EISA]," DoD will implement EPA's technical guidance on Section 438 of EISA.


DoD supports EPA's proposal to have federal agencies sign a Memorandum of Understanding (MOU) on Storm Water Management in Washington, DC, which would specify concrete actions they are willing to take beyond what the permit requires. Such actions could include:

- Development of metrics and best management practices, including a tracking mechanism for greater transparency;
- Implementation of storm water retention technologies at highly developed properties, where feasible and supported by the latest research;
- Incorporation of "Low Impact Development" or "Green Infrastructure" approaches to reduce the volume and rate of storm water discharges for redevelopment projects;
- Dissemination of information that demonstrates agencies' full compliance with the storm water requirements in the Clean Water Act and Section 438 of the EISA;
- Implementation of storm water actions necessary to meet pollution load reductions contained in the DC Watershed Implementation Plan under the Chesapeake Bay Total Maximum Daily Loads; and
- Exploration of additional innovative opportunities for using preserved open-space on federal properties to improve storm water retention.

DoD would support EPA efforts to expand the number of federal signatories, so as to enhance the exchange of information and lessons learned.

DoD is committed to helping address storm water issues in Washington, DC. I look forward to working with you over the next six months to develop an MOU and to improve in other ways the management of storm water in the Nation's capital.



Dear President Obama:

I am writing on behalf of our 6000 members of UMWA District 22 (Western United States) because we are concerned about the loss of coal mining jobs and all the affected jobs related to coal mining due to proposed EPA regulations for Maximum Achievable Control Technology at electric utility plants. We believe that the recently issued Transport Rule for reducing utility emissions of NOx and SO2 will compound the risk of job losses at a time of high coalfield unemployment and weak growth prospects.

The Transport Rule's deadlines are simply not feasible. Utilities cannot reasonably be expected to retrofit controls by 2012. Many plants will not have time to retrofit scrubbers by the second phase deadline of January 1, 2014. We hope that you will request EPA to grant the petitions for an administrative stay and reconsideration of this rule.

Providing additional time for compliance with EPA's MACT and Transport rules would increase the number of coal-based generating units that are upgraded with retrofit controls, increasing construction jobs and reducing unemployment due to coal market disruptions and plant closures.

The UMWA District 22 knows from experience that cap-and-trade regulations like the Transport Rule can inflict unacceptably large job losses due to fuel-switching. More than 30,000 mining jobs were lost under the 1990 acid rain program, as production shifted from eastern to western mines. We see little opportunity to meet the stringent reductions of the Transport Rule without large-scale fuel-switching. We particularly object to the rule's

emission allocation scheme that severely penalizes many well-controlled plants equipped with SO₂ scrubbers and advanced NO_x emission controls.

Hundreds of smaller and older coal-based generating units may not be able to achieve one or more of the MACT emission limits proposed last March. Job losses would occur in economically-depressed areas already suffering from high unemployment. Worse, the MACT rule would preclude the construction of state-of-the-art new coal plants because of the stringency of its proposed emission limits for mercury and other air toxics.


A UMWA analysis indicates that 54,000 direct jobs and more than 250,000 total jobs related to utility, mining and rail transport may be at risk of near-term closure. Our estimates are confirmed by preliminary studies by the Federal Energy Regulatory Commission. FERC staff estimate that up to 81,000 Megawatts of coal-based capacity could be lost due to pending EPA regulations.

EPA lacks sufficient time to respond to the issues raised by comments on the proposed MACT rule. This is the most expensive utility rule ever proposed by EPA, and the agency should ask the court for additional time to develop a final rule.

Finally, we are asking that you use your authority under the Clean Air Act to provide at least a two-year extension of the three-year compliance deadline for MACT. Providing more time to install controls at more than 1,000 units impacted by this rule is critical given the 4-5 year lead time for retrofitting scrubbers at powerplants.

Dear Administrator Jackson:

In order to ensure compliance with the Environmental Protection Agency's (EPA) Long Term 2 Enhanced Surface Water Treatment Rule, the Massachusetts Water Resources Authority (MWRA) has made significant design decisions based on EPA's UV Guidance Manual and has begun construction of a \$29 million, UV treatment project at our John J. Carroll Water Treatment Plant which serves over 2 million people in the metropolitan Boston area, and are in the final design stage of a smaller UV project at the Quabbin Reservoir. However, MWRA, like other water utilities across the country, has recently learned of developments in the science of ultraviolet disinfection which call into question assumptions made by EPA in the development of said UV Guidance Manual.

It is MWRA's understanding that recent studies raise the possibility that the assumptions in the EPA UV Guidance Manual may overestimate the UV dose delivery with regard to *Cryptosporidium* inactivation for all medium pressure UV reactors. While it appears that there is substantial activity by UV manufacturers, academics, and industry experts to understand the issue, ultimately EPA action will be required to definitively assess and resolve the matter.


MWRA is very concerned that given the fact that MWRA is already in construction on a complicated and tight schedule, that any delay in definitively resolving the issue may result in the need for costly construction delays and/or expensive rework, as well as the potential of violating the compliance deadline.

Frankly, MWRA finds itself in a classic "Catch 22" situation. Whether we plow ahead with construction to meet the compliance deadline and the standard then changes, or we put the project on hold and miss the deadline, MWRA could find itself in non-compliance with federal law.

In closing, I respectfully request that you do all in your power to resolve this situation in an expeditious manner, so that MWRA has clear guidance on how to proceed. MWRA staff stands ready to assist in any possible.

I thank you in advance for your attention to this important matter.



Internal FERC emails show rift with EPA over utility MACT

Internal emails between FERC and the White House show that the EPA may have discounted Energy Department concerns about how its mercury and air

toxics rule for power plants could affect power grid reliability.

FERC officials were also frustrated with EPA's intransigence on the issue during the draft rule phase, according to the emails.

"I don't think there is any value in continuing to engage EPA on the issues," FERC senior economist David Kathan wrote in a March [email](#). "EPA has indicated that these are their assumptions and have made it clear" that they will not change "anything on reliability or gas availability in the proposed rule."

"As it has done in other responses, EPA continues to make a lot of assumptions and does not directly answer anything associated with local reliability," Kathan wrote. "They provide the standard response that there will be enough time and they are confident that regional processes will accommodate any local capacity deficiency problem early in the process, or they do not directly respond to the question."

EPA is expected to issue its utility MACT rule on Friday, per a court agreement.

The requirements of the rule will lead to the closure of many coal-fired power plants, and idling of some coal-fired power generation units. Partisan fervor has risen in recent months over concerns that the pollution-control requirements will have dramatic impacts on electric reliability.

House Oversight and Government Reform Committee leaders cited internal FERC and OMB emails to say that EPA shirked its responsibility to appropriately consider reliability concerns.

Chairman Darrell Issa (R-Calif.) and Regulatory Affairs subpanel Chairman Jim Jordan (R-Ohio) sent a [letter](#) Tuesday to White House Office of Management and Budget regulatory chief Cass Sunstein citing the emails and asking that the rule be returned to EPA to more fully consider the impact on jobs and electric reliability.

Originally, EPA mentioned concerns about reliability in its draft, requesting comment on the issue. But on March 3, while the draft rule was under review, Ellen Brown of FERC sent an email to OIRA expressing concern that EPA was planning to ask commenters to "opine on the scope of our authority to ensure compliance with our regulations," according to the [emails](#).

So EPA removed the request from comment before releasing the rule.

Doing so without requesting input from other FERC offices or commissioners, the committee said in the letter to Sunstein, "does a disservice to the

rulemaking process.”

During the March interagency review of the proposed rule, the Energy asked EPA to change a notation that it “has worked closely” with FERC and DOE on the potential impacts to reliability to say “will continue to work” with the agencies.

“In light of this new information, we are writing to request that the Office of Information and Regulatory Affairs immediately return the utility MACT rule to EPA and require that EPA and the Federal Energy Regulatory Commission complete a proper assessment of the rule that includes an analysis of its impact on grid reliability,” the House letter says.

EPA has repeatedly said that it will allow flexibility to ensure that FERC’s reliability needs are met, and also notes that independent assessments of the outcome of EPA’s air toxics rules tends to overstate the rules’ requirements.

Cortney-- FERC has the following comments thus far on the draft EPA rule. We may have further comments, for example, from the two telephone conferences that you scheduled for today or on the other materials that you sent last night.

1. At pages 394-395 and 418-421, EPA rejects the option of fuel switching based its concerns about natural gas availability and environmental impacts of hydraulic fracturing associated with shale gas production. FERC's seasonal market reports have found adequate natural gas supplies to meet U.S. generation requirements. We suggest that EPA acknowledge our forecasts and clarify their concerns about long-term availability.
2. Page 463: EPA says it will work with DOE, FERC and others to reduce the adverse health impacts of power generation "while continuing to assure electric reliability is *achieved*." Given that we generally use the term "maintain" with respect to reliability, we suggest they do so as well (since we currently "achieve" reliability).
3. Page 476: EPA invites comments on the impact of the proposed rule on reliability and the authority available to EPA and other agencies to ensure compliance with EPA requirements while maintaining grid reliability. Similarly, on page 561, EPA in addressing the impact of the regulations on grid reliability, asks for comments on the scope of various authorities to ensure, and to exercise discretion in relation to, compliance with the regulations. We have some concern with EPA asking commenters to opine on the scope of our authority to ensure compliance with our regulations.
4. Page 506: EPA says that potential uncontrolled SO₂ emissions were calculated using monthly delivered fuel receipts and fuel quality data from EIA forms EIA-923, EIA-423 and FERC-423. While historical data is available from FERC Form No. 423, the Commission discontinued use of the Form in March, 2008, pursuant to Order No. 709.
5. Page 540: EPA asks for comments on the impact of reliance on combined heat and power and whether it is appropriate to recognize the environmental benefit of distributed generation in reducing line losses. Line loss has been a controversial issue in our wholesale markets and it isn't clear whether EPA intends to make recommendations to FERC on wholesale market design based on comments in this rulemaking. We suggest that EPA clarify where it's coming from in asking the question.

Julie and Mason,

I have looked at the most recent documents. While their answers do not fully resolve our issues and questions, I don't think there is any value in continuing to engage EPA on the issues. EPA has indicated that these are their assumptions and have made it clear that are not changed anything on reliability or gas availability in the proposed rule. I suspect that all these issues will be brought up in comments on the rule.

I have cited their responses and my commentary on key responses below.

As it has done in other responses, EPA continues to make a lot of assumptions and does not directly answer anything associated with local reliability. They provide the standard response that there will be enough time and they are confident that regional processes will accommodate any local capacity deficiency problem early in the process, or they do not directly respond to the question.

On flexibility they made the following statement saying that there may be additional flexibility if NERC raises a reliability concern in response to a query:

With the three years (or four years for installation of controls at the discretion of the permitting authority) that power plants have to determine and install their selected method of compliance with the Utility MACT, it is our expectation that most, if not all, of the reliability issues that are related to whether a specific unit will comply through unit retirement will be identified and addressed by the system operator and the source prior to the compliance deadline. We recognize that it is possible that a reliability issue may arise close to the MACT compliance deadline. Again, our expectation is that normal prudent system planning activities will both identify these issues as well as a solution in time to allow for any necessary unit retirement without unacceptable impacts on reliability. Where an operator continues to operate a unit after the MACT deadline without meeting the requirements of the Rule, it is subject to enforcement action. If NERC issues an advisory that taking the plant offline could create a justified reliability concern, EPA would work with NERC (and any other pertinent regulatory bodies) and together look to the statutory criteria set out in the Clean Air Act and other applicable statutes and implementing regulations and evaluate all relevant factors

including any whether the unit is required for reliability and the steps taken by the owner/operator of the unit to come into compliance.

In response to a question on how their modeling addresses transfer of reserves between _____ regions, especially when there are constraints and areas where additional reserves are needed, EPA does not directly answer the question and only states that they model firm capacity exchanges.

In cases where it is economic to transfer reserves from a neighboring region rather than supply reserves from within a region, IPM will transfer reserves, subject to summer and winter limits that are designed to ensure that these reserves can be transferred reliably. If transmission has not been modeled how can this occur? (regarding first bullet above) Some specific IPM regions have known congestion constraints (e.g., NYC, NJ/DE, etc.) so if it is not economical to transfer reserves, what do those dependent regions do to move forward without a reliability event?

For example, the retired coal capacity in TVA (1,084 MW) is replaced by a net increase in transfer of reserves to TVA (1,097 MW). Where is that capacity transferred from? Is it possible to transfer power into the TVA region?

Response: EPA's power sector modeling assumes the ability for firm transfers of capacity between modeling regions subject to interregional firm transfer constraints based on current operation of the grid and known constraints. These assumptions can be found in our modeling documentation at <http://www.epa.gov/airmarkt/progsregs/epa-ipm/BaseCasev410.html#documentation>.

EPA did respond to our questions. For most of the questions, they provide a rationale in their answer or say they will change the language. However, they are sticking to their opinion that hydraulic fracturing should not be relied upon to provide a resource boost. I am not sure whether there will be another revision of the preamble to reflect our comments or not. The previous version did not address these or do the edits that they say will be done.

[Pages 394-395 and 418-421] EPA rejects the option of fuel switching based its concerns about natural gas availability and environmental impacts of hydraulic fracturing associated with shale gas production. FERC's seasonal market reports have found adequate natural gas supplies to meet U.S. generation requirements. **We suggest that EPA acknowledge FERC's forecasts and clarify the concerns about long-term availability.**

Response: EPA could remove this from the justification for the rejecting the beyond-the-floor analysis if FERC believes there is sufficient gas for all coal- and oil-fired electric generation to be replaced by natural gas without the use of hydraulic fracturing.

[Page 463] EPA says it will work with DOE, FERC and others to reduce the adverse health impacts of power generation "while continuing to assure electric reliability is

achieved." Given that FERC generally uses the term "maintain" with respect to reliability, we suggest EPA use this as well (since we currently "achieve" reliability).

Response: We will edit the text.

[Page 476] EPA invites comments on the impact of the proposed rule on reliability and the authority available to EPA and other agencies to ensure compliance with EPA requirements while maintaining grid reliability. Similarly, on page 561, EPA in addressing the impact of the regulations on grid reliability, asks for comments on the scope of various authorities to ensure, and to exercise discretion in relation to, compliance with the regulations. We have some concern with EPA asking commenters to opine on the scope of our authority to ensure compliance with our regulations.

Response: EPA will remove this request for comment.

[Page 506] EPA says that potential uncontrolled SO₂ emissions were calculated using monthly delivered fuel receipts and fuel quality data from EIA forms EIA-923, EIA-423 and FERC-423. While historical data is available from FERC Form No. 423, the Commission discontinued use of the Form in March, 2008, pursuant to Order No. 709. We suggest EPA check their data source and clarify this information if necessary.

Response: We used delivered fuel data from the 423 forms prior to 2008 and used the 923 data for 2008 & 2009.

[Page 540]: EPA asks for comments on the impact of reliance on combined heat and power and whether it is appropriate to recognize the environmental benefit of distributed generation in reducing line losses. Line loss has been a controversial issue in our wholesale markets and it isn't clear whether EPA intends to make recommendations to FERC on wholesale market design based on comments in this rulemaking. We suggest that EPA clarify why it is asking this question.

Response: We do not intend to make any recommendations to FERC. The proposed approach would divide the electrical output of CHP facilities by 0.95 (increasing the electric output used in determining compliance) and make compliance "easier" for owner/operators of CHP facilities.

While it was not our comment – I thought a response to a DOE should be mentioned. In response to a DOE question about EPA's statement that they have been working closely with DOE and FERC, EPA says that it will change how they will refer to this working arrangement:

[Page 557] DOE suggests (and requests) that the sentence be revised to say, "...will continue to work..." instead of "has worked closely". DOE has not evaluated the potential impact of the rule on the grid, but it has generated some proxy scenarios, which were developed before seeing the proposed rule. Referenced Text: *In developing this proposed rule, EPA has worked closely with other agencies, including the Federal Energy Regulatory Commission (FERC) and the Department of Energy (DOE), to evaluate the potential impact of the final regulation on the grid.*

Response: We will make the edit.

Dear Administrator Jackson,

We are writing to inform you about an important manuscript to be published in *Bulletin of Insectology* titled "*In situ replication of honey bee colony collapse disorder*" that links the vast loss of honey bee hives since 2006 to the exposure of imidacloprid, one of the commonly used neonicotinoid insecticides in the U.S. and worldwide.

We found that after three months of exposing honey bee hives to imidacloprid at the sub-lethal levels, 15 out of 16 (94%) exposed hives were lost to CCD six months after the termination of imidacloprid dosing. The loss of honey bee hives proceeded with a dose-response manner in which hives treated with highest imidacloprid dose of 400ppb are found dead first, following by dosages as low as 20ppb. Those levels were comparable to previously reported imidacloprid residue levels seen in the environment.

This *in situ* study was conducted in the natural environment where honey bee hives are normally thriving during the foraging seasons, yet when treated with different levels of imidacloprid, we observed the mortality of honey bee hives throughout their lifecycle resembling the reported CCD.

We conclude that it is likely that the presence of imidacloprid in the environment has placed enormous pressure for survival on honey bees. The design of this *in situ* study in the apiarian setting and the survival of control honey bee hives eliminated the possibility that the loss of honey bee hives is caused by common biological (pathogenic) factors, as reported in the current literature.

As a result of this research, we would like to offer these recommendations:

1. The discovery of sub-lethal doses of imidacloprid leading to honey bee CCD should be considered in the framework of implementing the Food Quality Protection Act for the

neonicotinoid insecticides. Although we used only imidacloprid in this study, we suspect that other neonicotinoid insecticides, such as clothiadin, would share this deadly toxicity.

2. While the delayed mortality of honey bee hives identified in this study requires further validation, it also indicates the insufficiency of current toxicological testing for pesticides. Had we terminated this study at the end of imidacloprid dosing period (September, 2010) due to the survival of all hives (or not finding the dead honeybee colonies), we would have missed those remarkable observations six months later.

3. Considering the unique systematic property of neonicotinoid insecticides and their use in the increasing popularity of seed treatment program, honey bees are facing an enormous pressure for survival. This is in part the reason that we believe that since 2006, the loss of honey bee hives to CCD remains an ongoing challenge among beekeepers worldwide.

Finally, we would like to express our concern over the lack of federal funding to support pesticide research. Our research on CCD and neonicotinoid insecticides would not have been possible without pilot funding from Harvard University. And while U.S. EPA has been very supportive of pesticide research in the past, this commitment has dwindled since the early 2000's. While we were seeking additional funding from other federal agencies to continue this research in early 2012, Peter Alpert, Program Director of Population and Community Ecology Cluster at the National Science Foundation (NSF) said in response to our recent funding request.

"NSF does not support projects whose primary focus is on ecotoxicology and that therefore fall under the auspices of EPA. We felt that, while this project might provide useful information on the effects of toxic substances for purposes of management and regulation, it was not primarily directed at basic scientific questions."

We understand the current challenge of federal budgets and limited resources; however, we urge that you re-examine the priority of the extramural research program within U.S. EPA. The outcomes from this *in situ* study would not only justify EPA's investment in the extramural research and support EPA's regulatory activities, but could help us avoid the crisis of losing this important pollinator.

When we stood in front of the hives last spring, a very strange feeling surfaced. Four of the five hives that are treated with imidacloprid were so dead silent, whereas bees in the other control hive right next to those dead hives were so eager to welcome the arrival of Spring. The evidence of the cause of CCD is therefore so indisputable. The disappearing of the buzzing sound reminds us the "Silent Spring". Similar to the cause of "Silent Spring" as

Re: EPA's Unjust Proposal with Respect to Reid Gardner Pollution

Dear Administrator Jackson,

I speak for the Moapa Band of Paiutes, a federally recognized Tribe within the plume and downwind of NV Energy's Reid Gardner coal-fired power plant and associated facilities.

Let me note, at the outset, that the land and the air and water here were relatively clean before the coal plant. But with NV Energy's arrival in our ancestral lands we have, for nearly six decades, suffered from the unrelenting air, water, and dust pollution generated by this facility, including the blowing coal ash and hydrogen sulfide gas pollution stemming, respectively, from the Reid Gardner coal ash landfill and wastewater ponds.

Yesterday, Region 9 of EPA proposed a Best Available Control Technology (BART) determination for Reid Gardner NOx pollution, pursuant to the Regional Haze Rule under the Clean Air Act, that is inconsistent with the law, inconsistent with EPA's strong decisions elsewhere (such as at the San Juan Generating Station in New Mexico), and contrary to the environmental justice principles to which you have nominally given support. In particular, EPA's proposed NOx limits allow pollution concentration levels several times greater than the limits you have approved elsewhere.

It is clear now that Region 9 will not, on its own, grasp the opportunity to impose stringent, cost-effective controls that will protect visibility in the region and, as a critical ancillary benefit, protect public health.

The Reid Gardner facility – including its coal ash landfill and its collection of wastewater ponds – is adjacent to the Tribe, within a mile of its community center, and within a ½ mile of the closest homes of Tribal Members. The facility generates significant quantities of regional haze pollution in Nevada and it imposes on Tribal members an overwhelming environmental and public health burden. The impacts of the coal plant, coal ash dump, and the wastewater ponds, on our community and on our way of life cannot be fully understood without coming to our community and speaking with Tribal Members. Because of this, in September 2011, we invited you to visit the Reservation and see for yourself. We hereby renew that invitation, in the hope that you will visit well before making a final decision on BART.

We appealed to you late last year out of concern that Region 9 would not do the right thing. Now, in the wake of the Region's submission to the coal plant and its rejection of the minimal demands of public health, we again seek your engagement. As you stated in your letter that commenced your Agency's Environmental Justice Plan 2014, "every American deserves clean air, water and land in the places where they live, work, play and learn."¹ We must ask you, now: Are we, the Moapa, within your scope of concern? If so, then for EPA to "[lead] by... working for environmental justice,"² it is necessary for you to take back this proposed determination.

Your Agency has acknowledged that breathing ozone reduces lung function, inflames the lining of the lungs, and permanently scars lung tissue.³ Accordingly, failure to impose the most stringent cost effective controls will consign my people to unnecessary disease and early death. This failure itself constitutes a renewed environmental injustice, one that compounds the damage of decades of preventable pollution imposed on my people. Alternatively, you can choose to act firmly to meet Congress's visibility goals with the notable co-benefit of protecting public health and honoring your Agency's long-standing environmental justice commitments.

We urge you take strong action, at long last. Please intervene to ensure that your Agency, in crafting your final determination, upholds the law, protects the environment, and protects our people fully.

I am writing to you as President and Chief Executive Officer of Stratus Consulting, an environmental research consulting firm with offices in Boulder, Colorado and Washington, D.C. For more than 20 years, Stratus Consulting has provided expert technical support to our clients -- primarily federal, state, tribal and international governments -- in the areas of environmental science, economics and policy.

It has come to our attention that a group funded by the Competitive Enterprise Institute has initiated an internet-based letter-writing campaign to pressure the U.S. EPA to exclude Stratus Consulting's scientists, including Dr. Ann Maest, from participating in the EPA's Hardrock Mining Conference being held in Denver this week. We have also learned that the Colorado arm of the Washington, DC-based conservative organization Americans for Prosperity is planning to rally outside the conference, targeting Dr. Maest and Stratus Consulting as well as the EPA more generally.

We are concerned that the organizations behind these efforts are unfairly -- and irresponsibly -- taking aim at the integrity and credentials of our scientists in an effort to promote their own political and ideological agenda. The entity promoting the rally, for example, says that it "believes the [EPA's] rogue regulators and biased scientists are destroying jobs, driving-up energy costs, crippling America's competitiveness and contributing to the country's economic crisis."

Dr. Maest is an internationally-renowned geochemist, formerly with the U.S. Geological Survey, who is serving her sixth year as an elected member of the National Academy of Sciences (NAS) Committee on Earth Resources. In addition to serving on other related NAS committees, Dr. Maest has published widely in peer-reviewed scientific literature, and has been an invited speaker on geochemical and earth resource issues at academic institutions, scientific

meetings, government agencies, and numerous other national and international groups, including the United Nations. In short, she is an outstanding scientist with impeccable credentials who has made significant contributions to her field.

More broadly, Stratus Consulting stands by the quality, integrity, and reputation of our professional staff. Our senior staff have held staff positions at the U.S. Environmental Protection Agency, U.S. Fish and Wildlife Service, U.S. Geological Survey, and National Oceanic and Atmospheric Administration; have authored hundreds of peer-reviewed publications and presentations at national and international conferences; hold university appointments; have been appointed to serve on boards convened by the National Academy of Sciences and EPA's Science Advisory Board; have been recognized as part of the international panel that was awarded a Nobel Prize for its work on climate change; and are regularly invited to speak to national and international government agencies because of our technical expertise and reputation.

In advancing their current agenda, the organizations attacking Stratus Consulting and Dr. Maest are repeating unfounded and patently false allegations made by Chevron during its ongoing legal dispute over environmental pollution damage in the Amazon rainforest.

Here are the facts related to that dispute:

Stratus Consulting was hired to provide scientific assistance to attorneys representing a group of rural and indigenous Ecuadorians in their lawsuit in Ecuador against Chevron for large-scale environmental pollution damage in the Amazon rainforest. In the course of our work, we conducted technical analyses of Chevron's oilfield operations in Ecuador, the environmental contamination caused by those operations, and the resulting environmental impacts. Work on the project was similar to the type of environmental assessments Stratus Consulting has routinely performed for its U.S. federal and state government clients over the past two decades.

Released on the eve of the Ecuadorian court's \$18 billion judgment against the company, Chevron asserted a series of unfounded RICO claims against Stratus Consulting and many other parties. The paper that Stratus Consulting is scheduled to present this week has absolutely nothing to do with the work that our scientists conducted on behalf of the Ecuadorian plaintiffs. It is, rather, a highly technical analysis of copper chemistry and bioavailability. I urge you to stand firm in the face of this pressure to ensure that reasoned discussion based on sound scientific inquiry may continue.



SUBJECT: Implementing PortfolioStat

The stove-piped and complex nature of the Federal enterprise has led over the years to a proliferation of duplicative and low priority investments in information technology (IT). At the same time, agencies too often seek to develop homegrown, proprietary solutions first, before assessing existing options for shared services or components. The Federal Government must have the overarching goal of innovating with less as it pertains to technology. In order to do so, we must end the investment in low priority and duplicative investment in IT.

The Federal Government must focus on maximizing the return on American taxpayers' investment in government IT by ensuring it drives efficiency throughout the Federal Government. The Administration's Campaign to Cut Waste directed agencies to seek opportunities to shift to commodity IT, leverage technology, procurement, and best practices across the whole of government, and build on existing investments.¹

In support of this strategy, the Director of the Office of Management and Budget (OMB) issued a memorandum to Agency heads on August 8, 2011, entitled "Chief Information Officer Authorities" (M-11-29), which clarified the role of Chief Information Officers (CIO). M-11-29 required that agencies, "pool their purchasing power across their entire organization to drive down costs and improve service for commodity IT...CIOs must show a preference for using shared services as a provider or consumer instead of standing up separate independent services."²

Then, in October 2011, the Office of Management and Budget (OMB) launched the Shared First initiative aimed at rooting out waste and duplication across the Federal IT portfolio.³ In order to implement these initiatives, executive departments and agencies (agencies) will

review their respective IT investment portfolios to identify opportunities to consolidate the acquisition and management of commodity IT services, and increase the use of shared-service delivery models.

In support of this review process, Agency Chief Operating Officers (COO), on an annual basis, shall be required to lead an agency-wide IT portfolio review within their respective organization (PortfolioStat).⁴ A PortfolioStat session is a face-to-face, evidence-based review (e.g., including data on commodity IT investments, potential duplications, investments that do not appear to be well aligned to agency missions or business functions, etc.) of an agency's IT portfolio.

PortfolioStat will be a new tool that agencies use to assess the current maturity of their IT portfolio management process, make decisions on eliminating duplication, augment current CIO-led capital planning and investment control processes, and move to shared solutions in order to maximize the return on IT investments across the portfolio. While TechStat examines IT performance at the specific project or investment-level, PortfolioStat examines the portfolio as a whole and draws on the agency's enterprise architecture to help identify and eliminate areas of duplication and waste.⁵

PortfolioStat will help implement the Shared First initiative and the requirements set forth in the Executive Order 13589 (Promoting Efficient Spending),⁶ which targets employee IT devices as a primary area for eliminating waste and duplication. This effort should also assist agencies in meeting the targets and requirements under other initiatives, such as Federal Data Center Consolidation Initiative (FDCCI), the Cloud Computing Initiative, and the draft IT Shared Services Strategy.

CIOs, CFOs, and CAOs must support the PortfolioStat process by providing the necessary data and analysis, attending the PortfolioStat meeting, and support all decisions made through the process. This is necessary so that the portfolio-wide review results in concrete actions to maximize the investment in mission and support IT, consolidate the acquisition and management of commodity IT, reduce duplication, and eliminate waste.

To support this process, OMB is requiring that each agency take the following actions:

- **Designate Lead for Initiative.** Each agency's COO shall designate and communicate to OMB within 10 days of issuance of this memorandum an individual with direct reporting authority to the COO to lead the agency's efforts to implement the PortfolioStat process and guidance contained in this memo.
- **Complete a High-Level IT Portfolio Survey.** The data collection at the Departmental level is a high-level survey of agency IT portfolio status, and shall be completed by the designated lead in

the MAX Collect Tool, with support from the CIO, CFO, and CAO, and submitted to OMB by May 31, 2012.

- **Establish a Commodity IT Investment Baseline.** Each bureau, if applicable, must complete an information request identified in the MAX Collect Tool for specific types of commodity IT investments (including enterprise IT systems, IT infrastructure, and business systems) that will be used to baseline the maturity of agency portfolios. Bureau heads, if applicable, shall lead this request, which shall be completed by OMB by June 15, 2012.
- **Submit a Draft Plan to Consolidate Commodity IT.** Based on the analysis used to respond to the information requests above, the COO, in partnership with the CIO, CAO, and CFO, shall draft a proposed action plan to consolidate the commodity IT spend under the CIO, and establish a measurable financial goal to reduce total IT spend based on more consolidated commodity IT buys and intra-agency shared services. This proposed action plan shall be submitted to OMB by June 29, 2012.
- **Hold PortfolioStat Session.** Agencies shall hold their first PortfolioStat session by July 31, 2012. Further guidance on the process is detailed in Attachment A.
- **Submit a Final Plan to Consolidate Commodity IT.** By August 31, 2012, each Federal Agency shall complete and submit to OMB a document outlining its plan to rationalize and consolidate its IT portfolio, including the adoption of intra and inter agency shared IT services. These comprehensive plans will be informed by the PortfolioStat Process, and will cover at least three years of agency activities.
- **Migrate at Least Two Duplicative Commodities IT Services.** Agencies shall complete the transition of two commodity IT areas by December 31, 2012. In addition to the examples provided in M-11-29, commodity IT would also include IT hardware and software as well as the following services for which Federal Strategic Sourcing Initiative (FSSI)⁷ solutions exist or will soon be awarded: print management, telecommunication expense management, and wireless devices and services. Agency use of these FSSI solutions will count toward meeting this migration goal.
- **Document Lessons Learned.** Agencies shall document and catalogue successes, challenges, and lessons learned from this process into a document that must be submitted to OMB by February 1, 2013.

Through the PortfolioStat process, COOs will have a clearer picture of where duplication exists across their respective agencies. This analysis should inform the budget process and help agency COOs eliminate waste and duplication within the IT portfolio. A specific focus must be placed on reducing duplication within commodity IT by shifting to intra- and inter-agency shared services. Duplicative systems or contracts that support common business functions within an

agency should be targeted for consolidation in order to leverage the purchasing power of the agency.

To assist with the data collection and reporting requirements listed under this memorandum OMB has created a MAX Collect Tool that will be the required repository for all of the information requested. Please go to the MAX Community for more information.

The PortfolioStat process is structured around five discrete phases: (1) Baseline Data Gathering; (2) Analysis and Proposed Action Plan; (3) PortfolioStat Session; and (4) Final Action Plan Implementation, (5) Lessons Learned. The following provides further details on each phase with guidance on the schedule and requirements surrounding the PortfolioStat process to ensure that this essential management reform is consistently implemented by agencies. In order to maximize the return on investments in IT, agency leadership must engage in proactive performance management using high-quality, targeted data on the maturity of agency portfolios, as well as architectural and asset inventory information.

Phase 1: Baseline Data Gathering

Agencies shall provide the following information to OMB that will be collected through the MAX Collect Tool:

- By May 31, 2012, a high-level survey of agency IT portfolio status;
- By June 15, 2012, an information request for specific types of commodity IT investments (including enterprise IT systems, IT infrastructure, and business systems) that will be used to baseline the maturity of agency portfolios. Bureau heads, if applicable, shall complete this data request for each of the identified areas.

Phase 2: Analysis and Proposed Action Plan

Using the portfolio data gathered in Phase 1, combined with other data available at the bureau and agency level, COOs shall:

- Identify wasteful or duplicative investments, procurements, and/or commodity IT areas;
- Make frequent use of the agency's enterprise architecture future plans for program, system, and service changes;
- Use the agency valuation model to assess the IT portfolio and measure expected outcomes vs. actual business value delivered for major investments; and
- Review the current state of governance and program management.

Based on this analysis, the agency COO, in partnership with the CIO, CAO, and CFO, shall draft a proposed action plan to:

- Consolidate commodity IT spending under the agency CIO;
- Establish targets for commodity IT spending reductions and deadlines for meeting those targets;
- Move at least two commodity IT areas to shared services (e.g. E-mail, collaboration tools, web infrastructure, etc.)
- Target duplicative systems or contracts that support common business functions within an agency for consolidation in order to streamline processes and leverage the purchasing power of the agency;
- Illustrate how investments within the IT portfolio align with the agency's mission and business functions;
- Establish criteria for identifying wasteful, "low-value," or duplicative investments

- Establish a process to identify these potential investments and a schedule for eliminating them from the portfolio;
- Improve governance and program management utilizing best practices and, where possible, benchmarks.

The draft action plan shall be submitted to OMB by June 29, 2012.

Phase 3: PortfolioStat Session

A PortfolioStat session is a face-to-face, evidence-based review (e.g., including data on commodity IT investments, potential duplications, investments that do not appear to be well-aligned to agency missions or business functions, etc.) of an agency's IT portfolio. In the session, the Federal CIO along with the agency CIO, CAO, CFO, and COO, meet for one focused hour to review the agency's portfolio data and proposed action plan. Participants agree on concrete next steps to rationalize the agency's IT portfolio, resulting in a final plan that articulates corrective actions, anticipated results, and which establishes specific timeframes for the actions to be taken.

Agencies shall hold their first PortfolioStat session by July 31, 2012.

Phase 4: Final Action Plan Implementation

The anticipated cost savings and portfolio improvements realized through the PortfolioStat session must be memorialized in a communication from the COO to the agency. Additionally, in the FY 2014 budget process, agencies must document the cost savings and avoidance realized in FY 2013 and into subsequent out years. Effective implementation of the PortfolioStat process will require agencies to incorporate the following activities into their approach:

- Agencies shall complete and submit to OMB a document outlining its plan to rationalize and consolidate its IT portfolio, including the adoption of intra and inter agency shared IT services.

The final action plan to consolidate commodity IT spending shall be shared with OMB by August 31, 2012.

Phase 5: Lessons Learned

The process established in this memo will be an annual requirement for all agencies to continually assess the maturity of IT portfolio management and ensure that any inertia, which would relegate the Federal Government to the status quo, be rooted out on a recurring basis. In order to do so with maximum impact, agencies must document successes, challenges and lessons learned through the PortfolioStat process.

Additionally, OMB will gather its own successes, challenges, and lessons learned through the process and update this memo and data collection parameters accordingly each year. As this process evolves, we will ask agencies to look deeper into their portfolios at more mission oriented and high-value investments. The intention is that this process will inform governance and budget decisions each fiscal year.

- Agencies shall document and catalogue successes, challenges, and lessons learned throughout the process and must submit a consolidated document to OMB. This document shall be submitted to OMB by February 1, 2013.

By undertaking the portfolio review described above, COOs will get a better picture of where potential duplication exists across their respective agencies. In addition, the reviews will enable agencies to use the asset inventory and architectural information to help refine their IT investment portfolios in the future.

Dear Administrator Jackson:

I am writing to express the enthusiastic support of the Apartment and Office Building Association of Metropolitan Washington (AOBA) for an alternative green infrastructure approach to the District's Long Term Control Plan (LTCP) as proposed to your agency by DC Water. AOBA is a non-profit trade association representing owners and managers of commercial office building and multifamily residential properties, as well as companies that provide products and services to the real estate industry. Currently, the combined portfolio of AOBA's membership is more than 156 million square feet of office space and 208,700 residential units in the District of Columbia, Maryland, and Virginia. Here in the District of Columbia, AOBA members own or manage more than 40,000 apartment units and over 70 million square feet of office space.

As you are aware, DC Water is constructing a massive, \$1.3 billion tunnel system to eliminate 98 percent of sewer overflows into the Anacostia River, per the terms of the 2005 consent decree it entered into with the United States Environmental Protection Agency (EPA) and the Department of Justice (DOJ). AOBA members are among the District's largest landowners and currently represent approximately forty-four (44%) percent of the customer base being assessed the impervious surface area charge by DC Water to finance the construction of the tunnel system.

However, DC Water is currently proposing a transformative pilot project that could reduce the burden placed on ratepayers, including AOBA members, for funding the large tunnels. Specifically, DC Water is seeking EPA's approval of a full-scale demonstration of green infrastructure that could offset the need for some of the Potomac and Rock Creek tunnel project capacity, through installation of a wide range of projects across the city for different types of properties and land areas. Project ideas include installation of permeable pavement, tree filters, green roof treatment and vegetated filter strips. The large scale of the proposed pilot project will yield a diversity of ecological, social, and economic benefits, in addition to, hopefully, reducing the needed storage tunnel capacity. The projects envisioned by DC Water




will transform local neighborhoods and improve the quality of life for District residents by creating more green jobs and enhanced green spaces.

For this demonstration project to move forward and prove itself, the consent decree must be amended to grant sufficient time to evaluate the effectiveness of the green infrastructure pilot. Since the negotiation of the 2005 consent decree, EPA has supported and approved green infrastructure approaches to address combined sewer overflows (CSOs) in jurisdictions similar to the District, such as Cleveland and Indianapolis. Further, more recent EPA consent decrees have provided jurisdictions with 25 years to address CSOs, instead of the 20 years allowed under the District's agreement. With that in mind, it is reasonable to provide DC Water with additional time to conduct a rigorous pilot of green infrastructure approaches to CSOs at its own expense.

Thank you for the opportunity to express AOBA's support for the DC Water pilot project and we urge you to approve the necessary modification of the 2005 consent decree.

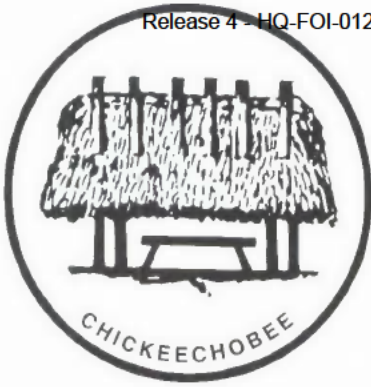

On behalf of the Miccosukee Tribe of Indians of Florida (Tribe), I thank you and the other officials at the U.S. Environmental Protection Agency (EPA) for meeting with us on February 14th as well as for accommodating our schedule so late in the day. We appreciated the opportunity to discuss with you ways to advance Everglades restoration and the impacts that water resource decisions are having on our homelands. We were encouraged to hear of EPA's resolve to make progress in ensuring that water quality in the Everglades meets tribal and state standards.

The Tribe remains fully committed to restoration of the Everglades. The Tribe supported the original Comprehensive Everglades Restoration Plan and continues to support its overall goals. In addition to the need to improve water quality on tribal lands and other parts of the Everglades, we seek to ensure that the federal government does not engage in further skyway bridging of the Tamiami Trail because it will not achieve its intended environmental purpose and will destroy areas of significant cultural, historical, and archeological value. Instead, the culvert and swale approach is far more cost-effective and less disruptive. Further, it can be implemented immediately to improve the hydrology on tribal lands. We would greatly appreciate EPA's assistance on this matter as well.

I look forward to continuing our work together so the Miccosukee people can continue our traditional ways of life in the Everglades and the American public can enjoy its beauty for many generations to come.



MEMORANDUM FOR THE HEADS OF EXECUTIVE DEPARTMENTS AND AGENCIES

SUBJECT: Establishing a Working Group on the Intersection of HIV/AIDS, Violence Against Women and Girls, and Gender-related Health Disparities

Throughout our country, the spread of HIV/AIDS has had a devastating impact on many communities. In the United States, there are approximately 1.2 million people living with HIV/AIDS, including more than 290,000 women. Women and girls now account for 24 percent of all diagnoses of HIV infection among United States adults and adolescents. The domestic epidemic disproportionately affects women of color, with African Americans and Latinas constituting over 70 percent of new HIV cases in women. The spread of HIV/AIDS is, in and of itself, a primary concern to my Administration. However, gender-based violence and gender-related health disparities cannot be ignored when addressing the domestic public health threat of HIV/AIDS. HIV/AIDS programs often ignore the biological differences and the social, economic, and cultural inequities that make women and girls more vulnerable to HIV/AIDS. In our country, women and girls are all too frequently victimized by domestic violence and sexual assault, which can lead to greater risk for acquiring this disease. Teenage girls and young women ages 16-24 face the highest rates of dating violence and sexual assault. In addition, challenges in accessing proper health care can present obstacles to addressing HIV/AIDS. Gender-based violence continues to be an underreported, common problem that, if ignored, increases risks for HIV and may prevent women and girls from seeking prevention, treatment, and health services.

My Administration is committed to improving efforts to understand and address the intersection of HIV/AIDS, violence against women and girls, and gender-related health disparities. To do so, executive departments and agencies (agencies) must build on

their current work addressing the intersection of these issues by improving data collection, research, intervention strategies, and training. In order to develop a comprehensive Government-wide approach to these issues that is data-driven, uses effective prevention and care interventions, engages families and communities, supports research and data collection, and mobilizes both public and private sector resources, I direct the following:

Section 1. Working Group on the Intersection of HIV/AIDS, Violence Against Women and Girls, and Gender-related Health Disparities. There is established within the Executive Office of the President a Working Group on the Intersection of HIV/AIDS, Violence Against Women and Girls, and Gender-related Health Disparities (Working Group), to be co-chaired by the White House Advisor on Violence Against Women and the Director of the Office of National AIDS Policy (Co-Chairs). Within 60 days of the date of this memorandum, the Co-Chairs shall convene the first meeting of the Working Group.

(a) In addition to the Co-Chairs, the Working Group shall consist of representatives from:

- (i) the Department of Justice;
- (ii) the Department of the Interior;
- (iii) the Department of Health and Human Services;
- (iv) the Department of Education;
- (v) the Department of Homeland Security;
- (vi) the Department of Veterans Affairs;
- (vii) the Department of Housing and Urban Development; and
- (viii) the Office of Management and Budget.

(b) The Working Group shall consult with the Presidential Advisory Council on HIV/AIDS, as appropriate.

(c) The Department of State, the United States Agency for International Development, and the President's Emergency Plan for AIDS Relief Gender Technical Working Group shall act in an

advisory capacity to the Working Group, providing information on lessons learned and evidence-based best practices based on their global experience addressing issues involving the intersection between HIV/AIDS and violence against women.

Sec. 2. Mission and Functions of the Working Group. (a) The Working Group shall coordinate agency efforts to address issues involving the intersection of HIV/AIDS, violence against women and girls, and gender-related health disparities. Such efforts shall include, but not be limited to:

- (i) increasing government and public awareness of the need to address the intersection of HIV/AIDS, violence against women and girls, and gender-related health disparities, including sexual and reproductive health and access to health care;
- (ii) sharing best practices, including demonstration projects and international work by agencies, as well as successful gender-specific strategies aimed at addressing risks that influence women's and girls' vulnerability to HIV infection and violence;
- (iii) integrating sexual and reproductive health services, gender-based violence services, and HIV/AIDS services, where research demonstrates that doing so will result in improved and sustained health outcomes;
- (iv) emphasizing evidence-based prevention activities that engage men and boys and highlight their role in the prevention of violence against women and HIV/AIDS infection;
- (v) facilitating opportunities for partnerships among diverse organizations from the violence against women and girls, HIV/AIDS, and women's health communities to address the intersection of these issues;
- (vi) ensuring that the needs of vulnerable and underserved groups are considered in any efforts to address issues involving the intersection of HIV/AIDS, violence against women and girls, and gender-related health disparities;

(vii) promoting research to better understand the intersection of the biological, behavioral, and social sciences bases for the relationship between increased HIV/AIDS risk, domestic violence, and gender-related health disparities; and

(viii) prioritizing, as appropriate, the efforts described in paragraphs (a)(i)-(vii) of this section with respect to women and girls of color, who represent the majority of females living with and at risk for HIV infection in the United States.

(b) The Working Group shall annually provide the President recommendations for updating the National HIV/AIDS Strategy. In addition, the Working Group shall provide information on:

(i) coordinated actions taken by the Working Group to meet its objectives and identify areas where the Federal Government has achieved integration and coordination in addressing the intersection of HIV/AIDS, violence against women and girls, and gender-related health disparities;

(ii) alternative means of making available gender-sensitive health care for women and girls through the integration of HIV/AIDS prevention and care services with intimate partner violence prevention and counseling as well as mental health and trauma services;

(iii) specific, evidence-based goals for addressing HIV among women, including HIV-related disparities among women of color, to inform the National HIV/AIDS Strategy Implementation Plan (for its biannual review);

(iv) research and data collection needs regarding HIV/AIDS, violence against women and girls, and gender-related health disparities to help develop more comprehensive data and targeted research (disaggregated by sex, gender, and gender identity, where practicable); and

(v) existing partnerships and potential areas of collaboration with other public or nongovernmental actors, taking into consideration the types of

implementation or research objectives that other public or nongovernmental actors may be particularly well-situated to accomplish.

Sec. 3. Outreach. Consistent with the objectives of this memorandum and applicable law, the Working Group, in addition to regular meetings, shall conduct outreach with representatives of private and nonprofit organizations, State, tribal, and local government agencies, elected officials, and other interested persons to assist the Working Group in developing a detailed set of recommendations.

Sec. 4. General Provisions. (a) The heads of agencies shall assist and provide information to the Working Group, consistent with applicable law, as may be necessary to carry out the functions of the Working Group. Each agency and office shall bear its own expense for carrying out activities related to the Working Group.

(b) Nothing in this memorandum shall be construed to impair or otherwise affect:


(i) the authority granted by law to an executive department, agency, or the head thereof; or

(ii) the functions of the Director of the Office of Management and Budget relating to budgetary, administrative, or legislative proposals.

(c) This memorandum shall be implemented consistent with applicable law and subject to the availability of appropriations.

(d) This memorandum is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the United States, its departments, agencies, or entities, its officers, employees, or agents, or any other person.

(e) The Secretary of Health and Human Services is authorized and directed to publish this memorandum in the *Federal Register*.

Re: Clean Air Council Petition to the Administrator to Make a Finding that Pennsylvania is Failing to Implement Requirements in its State Implementation Plan; and to Apply Sanctions Relating to these Alleged Failures.

Dear Administrator Jackson:

This letter is in response to the Clean Air Council (CAC) Petition in the above captioned matter, which was submitted to the U.S. Environmental Protection Agency (EPA) on February 16, 2012.

Introduction

The Pennsylvania Department of Environmental Protection (Department or DEP) is very concerned about the CAC's continued abuse of the Clean Air Act, (CAA), 42 U.S.C. § 7401 *et seq.*, and Administrative Procedure Act (APA), 5 U.S.C. § 553(e) petition processes. As you well know, this is the third petition that CAC has filed against Pennsylvania in yet another transparent attempt to use the petition process as a means to get what they may not otherwise achieve through the judicial, regulatory and policymaking processes. CAC's latest petition seeks to attack how the Department is implementing the Pennsylvania State Implementation Plan (SIP) – even though the Department is implementing and acting in accordance with its regulations concerning the permitting and construction of air contaminant sources. Put simply, there is no credible evidence that the Department is failing to implement its SIP or the Title V program. To the contrary, the Department continues to implement its SIP and Title V program in accordance with the law and will continue to do so.

CAC's petition alleges that the Department is failing to implement the Pennsylvania SIP based on our handling of single source determinations under the CAA and the Pennsylvania SIP, 40 CFR Part 52.2020. The CAC alleges the following to support their petition – permit review memos that discuss "aggregation" are vague, incomplete, and conflict with the CAA; the Department's October 12, 2011 interim final guidance on single source determinations is contrary to the CAA; EPA's comments on the Department's interim final guidance raise concerns with that guidance; and pending litigation on aggregation issues before the Pennsylvania Environmental Hearing Board (EHB) and the U.S. District Court for the Middle District of Pennsylvania.

The CAC petition further alleges that the Commonwealth is failing to adequately administer and enforce its Title V permitting program. The petitioners allege that the Department is "failing to make accurate source determinations for the purpose of assessing applicability" of the Title V program.

The evidence that CAC uses to support its petition does not relate to the Department's "failure" to implement the Pennsylvania SIP, but rather takes issue with "how" the Department implements the SIP. Moreover, the petition also fails to demonstrate that DEP is not adequately administering and enforcing its Title V program. As explained more fully below, the Department is implementing and acting in compliance with federal and state regulations related to the construction and operation of air contamination sources. Accordingly, the Department believes that this petition is meritless and should be summarily rejected.

Background

The Pennsylvania Environmental Quality Board, an independent entity responsible for the adoption of DEP regulations, finalized a series of regulatory amendments to ensure that Pennsylvania's air quality permitting program is consistent with both the Pennsylvania Air Pollution Control, 35 P.S. § 4001 *et seq.*, and the CAA. These amendments relate to the construction and operation of sources under 25 Pa. Code Chapter 127 and, in pertinent part, were modified in 1983¹ and 1994.² These amendments were subsequently approved by EPA as revisions to the Pennsylvania SIP.³

Since 1996 the Department issued over 800 Title V permits and over 2,500 state-only operating permits. More specifically, as it relates to permitting operations for natural gas operations within the Marcellus Shale, the Department issued over 400 authorizations to use general permits for natural gas production and/or processing facilities. In addition, the Department issued approximately 20 individual plan approvals for these facilities. Each plan approval, operating permit, or general permit application is reviewed individually to ensure compliance with the applicable regulatory requirements. While some of these DEP permits are subsequently challenged, it is reflective of the implementation decisions that the Department made on these applications.

In no instance has the Department refused to implement any SIP-approved regulation. *See Citizens for Pennsylvania's Future v. Mallory, et al*, No. 02-798 2002 U.S. Dist. LEXIS 24406 (E.D. Pa. December 18, 2002) (Liability found for failure to implement a SIP-approved inspection and maintenance program). *See also Coalition for Clean Air, Inc., v. South Coast Air Quality Management District*, 1999 U.S. Dist. LEXIS 16106 (C.D. Ca. August 27, 1999) (Liability found for failure to implement control measures in the SIP). This petition is not about

a failure to implement the current SIP, but rather a dispute about how the Department is implementing its SIP. As a result, the allegations set forth in the petition do not support a failure to implement finding as it relates to the Pennsylvania SIP.

Furthermore under 25 Pa. Code §§ 127.13b and 127.422(3) (relating to plan approval changes for cause and operating permit changes for cause), the Department is obligated to deny a plan approval or operating permit if EPA notifies the DEP, in writing, that the plan approval or operating permit is not in compliance with the CAA or its regulations.⁴ To date, EPA has not notified the Department in writing that any plan approval issued for the natural gas industry is contrary to any applicable law and regulation. The fact that EPA has not provided any written notifications shows that both the SIP and the Title V program are being implemented consistent with federal and state law.

Additionally, CAC has an adequate regulatory remedy related to Title V permits. *See* 25 Pa. Code § 127.523 (relating to public petitioners to the administrator of the EPA). Under these provisions, anytime that EPA does not object to a Title V permit issued by the Department, CAC may petition EPA to make an objection. If EPA objects, the Department will suspend the permit until the objection is resolved.

Since it is much easier for EPA to assert its oversight responsibilities under these Pennsylvania regulatory provisions on a case-by-case basis as opposed to making a broader failure to implement finding or failure to adequately administer or enforce the Title V permitting program, CAC's petition should also be rejected because of these adequate regulatory remedies under the *Pennsylvania Code*.

CAC's Allegations Concerning a Failure to Implement the SIP and Failure to Adequately Administer and Enforce the Title V Permitting Program

Pending Litigation

The CAC petition references litigation before the EHB and the U.S. District Court for the Middle District of Pennsylvania as evidence that the Pennsylvania SIP is not being implemented. These litigation matters – *Group Against Smog and Pollution v. DEP*, (2011 EHB 065) *Clean Air Council v. DEP*, (2011 EHB 072), and *PennFuture v. Ultra Resources* (M.D. Pa.11-cv-01360) – involve single-source determination decisions by the Department in implementing the SIP, not in failing to implement the SIP. Obviously, this is specious. As CAC should know and I know EPA knows, lawsuits in and of themselves are not evidence of anything in the American system of law. There have been no findings of fact of any nature in these lawsuits. There have not even been any preliminary decisions of procedural issues. In the federal lawsuit, the defendants have

moved to dismiss the case on the ground that the federal court ought to abstain from hearing the matter since it is primarily a state law issue. The federal court has not even yet determined that threshold issue and regardless of which way the court rules on that issue, its opinion on that topic will not decide any factual issues in the suit at all. The state court case is not even finished with the discovery process yet.

As demonstrated by the caption in one of these matters, CAC is an appellant before the EHB. This petition is an obvious case where the CAC is hedging its bets in two different forums. If EPA entertains such a tactic, it would open the flood gates to forum-shopping where CAC, and others, could use the petition process in an improper manner to have its grievances heard where they believe they could receive a more favorable judgment. Such a result would inject a huge amount of inconsistency and uncertainty in the air quality permitting process, because the Department, and not EPA, is the permitting authority in Pennsylvania. Consequently, EPA should reject CAC's invitation to air its grievances within a petition process that is ill-suited to review individual DEP permitting decisions.

In fact the appropriate forum for CAC's challenge is before the EHB, the specialized administrative tribunal established for the purpose of hearing challenges to DEP's permitting decisions. This forum is best suited to review the Department's case-by-case single source determinations within the legal framework established by the EHB's practices and procedures. *See* 25 Pa. Code Chapter 1021. Additionally, this process avails itself to subsequent appeals to the Commonwealth Court of Pennsylvania, and the Pennsylvania Supreme Court. *See* 42 P.S. §§ 763(a) and 723(a), respectively. Therefore, it is these legal processes, that CAC initially chose, that should decide the issues surrounding these case-by-case determinations.

The Department is confident that it made the correct implementation decisions in each of the cases cited in the CAC petition. However, these matters are likely to be protracted without decisions on the merits for the foreseeable future. Therefore citing these pending cases as support for their petition does not advance CAC's cause at all. Citing these cases merely shows that the appellants disagree with the Department's decisions, and not that these decisions are contrary to the law.

In addition, each of the permits in these litigation matters were subject to the public notice and comment provisions under 25 Pa. Code § 124.44 (relating to public notice). At no time did the Department receive comments from EPA objecting to the issuance of these permits. If EPA notified the DEP, in writing, that a plan approval or operating permit is not in compliance with the CAA, the Department is obligated to deny that plan approval or operating permit. *See* 25 Pa. Code §§ 127.13b and 127.422(3).⁵ The fact that EPA did not provide any written notifications is evidence that both the SIP and the Title V program are being implemented consistent with the law.

DEP interim guidance and EPA's comments on that guidance

The CAC petition references the DEP interim guidance on single source determinations and EPA's comments on that guidance as evidence that the Pennsylvania SIP is not being implemented. That point is specious because, at the end of the day, the state process is exactly like the federal process on this: a case-by-case determination of the aggregation question. The DEP interim guidance outlines a case-by-case determination process just like the McCarthy Memorandum does. We do it the same way, on a case-by-case basis "represent[ing] highly fact-specific decisions, and...no single determination can serve as an adequate justification for how to treat any other source determination for pollutant-emitting activities with different fact-specific circumstances." McCarthy Memorandum, September 22, 2009, p. 2.

Also, like the litigation matters, the interim guidance is an unresolved matter that was noticed and made available for public comment. *See* 41 Pa. Bull. 5719, October 22, 2011. Over 300 comment letters were submitted on this guidance, which are currently being reviewed by DEP. In fact, as the CAC indicated in their petition, they submitted comments on the interim guidance through the Columbia University Environmental Law Clinic. Depending on the outcome of DEP's review, the guidance may be revised. Just like the unsettled litigation matters, citing a draft interim guidance document, which may be revised, does not advance CAC's cause.

Similar to the litigation matters, CAC is hedging its bets in two different forums. If EPA granted CAC's petition, it would short circuit the Department's long established policies related to public participation in the development of technical guidance. *See* "Public Participation in the Development of Regulations and Technical Guidance." (Document No. 012-1920-001).⁶ *See* also "Policy for Development and Publication of Technical Guidance." (Document No. 012-0900-001).⁷ It is through these documents, which were developed through the public comment process, that the Department establishes the standards and procedures for the drafting of other technical guidance documents, and creates a uniform process for developing, approving, and distributing these documents.

Similar to the litigation matters, the appropriate forum to establish a technical guidance document, which will assist DEP staff and permit applicants in making single source determinations, is through the Department and the public comment process. This forum is best suited to evaluate and respond to the comments submitted on the interim guidance. No one person or group speaks for the public. The Department must reach out to broaden public participation to understand what the public thinks, to better inform the Department, and to ensure that the public understands what the Department is doing, and why it is doing it. Accordingly, CAC's crude attempt at forum shopping must be rejected by EPA.

The Department, in this response, will not take the time to respond to all of the comments submitted by the CAC through the Columbia University Environmental Law Clinic; however it

is clear that those comments confuse the fundamental difference between a regulation that is binding and a technical guidance document that allows for discretion. The guidance is not a regulation because the Department is able to deviate from it, if circumstances warrant. The guidance merely interprets the regulations the air quality permitting staff uses in making single source determinations.

The assertions in the CAC petition that the interim guidance requires air quality staff not to aggregate air contamination sources located on properties outside of a quarter mile, and that the “[g]uidance exempts natural gas operations from aggregation” are absurd.. The guidance document is clear – sources on properties within a quarter mile will be aggregated, and sources on properties located outside of a quarter mile may be aggregated on a case-by-case basis.

While EPA expressed concerns with certain portions of this guidance, EPA does agree with the central premise of the guidance, which is all single source determinations must be conducted on a case-by-case basis in accordance with the applicable law. Moreover, EPA may avail itself to the procedures under 25 Pa. Code §§ 127.13b and 127.422(3) to object to specific permits decisions based on the guidance document. Consequently, the assertions in the petition related to the interim guidance and EPA’s comments on that guidance do not rise to the level of a failure to implement the SIP or failure to adequately administer or enforce the Title V permitting program.

Permit review memos

The CAC petition references certain “vague” and “incomplete” permit review memos on single source determinations as evidence that the Pennsylvania SIP is not being implemented. This particular allegation is puzzling on a number of levels. First, all of the Department actions associated plan approval or general permit applications were noticed for public comment under 25 Pa. Code § 127.44. EPA never notified the Department that any of its single source determinations were contrary to law as it can under 25 Pa. Code §§ 127.13a and 127.461.⁸ As a result, the only conclusion one can reach is that both the SIP and the Title V program are being implemented consistent with the law.

Second, the petition compares and contrasts statements in the Mark West review memos with answers supplied by the Department to CAC’s interrogatories as part of its litigation before the EHB. So it appears that CAC is trying to litigate its case before EPA rather than before the EHB. This, of course, just buttresses the Department’s point that these arguments are better left to a litigation tribunal that can render a case specific judgment on these case-by-case determinations.

Third, the Mark West permit review memos described in the petition were completed prior to the issuance of the DEP guidance on October 12, 2011. So, while the permit review was based on the single source regulatory criteria, it was not based on the DEP interim guidance.

Lastly, the Department also reviewed a number of permit review memos on single source determinations and, not surprisingly, takes the opposite view on the quality of the analyses of the single source determinations. The review memos that the Department examined provide a detailed discussion of all regulatory requirements, including those related to the aggregation of sources. Where a single source determination is not discussed in a review memo it is because only one source is being permitted. Therefore, the assertions in the petition related to the permit review memos do not rise to the level of a failure to implement the SIP or failure to adequately administer or enforce the Title V permitting program.

Title V Administration and Enforcement

As previously noted, the CAC petition further alleges that the Commonwealth is failing to adequately administer and enforce its Title V permitting program. The petitioners allege that the Department is "failing to make accurate source determinations for the purpose of assessing applicability" of the Title V program.

The Department issued over 400 general permit authorizations for natural gas production and/or processing facilities. In addition, the Department issued approximately 20 individual plan approvals for these facilities. Each plan approval, operating permit, or general permit application is reviewed individually to ensure compliance with the applicable regulatory requirements.

Like the SIP allegations, the Title V allegations are without merit. EPA has the ability under under 25 Pa. Code §§ 127.13b and 127.422(3) to notify the Department in writing that a plan approval or operating permit is not in compliance with the CAA or its regulations.⁹ Upon that occurrence, the Department is obligated to deny that plan approval or operating permit. At this time EPA has not notified the Department in writing that any plan approval issued for the oil and gas industries is contrary to the applicable law and regulations. The fact that EPA has not made any written notifications shows that the SIP, generally, and the Title V program, in particular, is being implemented consistent with the law.

In addition, the CAC petition fails to note that it has an adequate regulatory remedy related to Title V permits. *See* 25 Pa. Code § 127.523 (relating to public petitioners to the administrator of the EPA). Under these provisions, anytime that EPA does not object to a Title V permit issued by the Department, CAC may petition EPA to make an objection. For that reason, as well, CAC's petition should be rejected.

Conclusion

The evidence that the CAC offers in its petition is insufficient to carry its burden that DEP is failing to implement the SIP or failing to adequately administer the Title V program. CAC's



allegations merely relate to "how" the Department implements its programs. EPA has not provided any written notifications to DEP that its programs are not being implemented consistent with the law.

The Department is implementing and acting in compliance with its current regulations related to air quality permitting matters on the construction and operation of air contamination sources. Clearly CAC failed to meet its burden. As such, the petition should be rejected.



U.S. EPA Administrator Lisa Jackson today vowed to give electric utilities and their state overseers regulatory certainty with a host of forthcoming environmental rules.

Speaking at a conference of state utility regulators today, Jackson outlined a series of pending regulations that will significantly affect utilities, including rules aimed at curbing soot, smog and

mercury.

"I believe that we can do it smartly, that we will do it in partnership and that we will do it in a way that gives a clear road map for investors and for regulators and for ratepayers," Jackson said.

EPA will propose a replacement for the Clean Air Interstate Rule in April, Jackson said, to address pollution that crosses state lines.

President George W. Bush's cap-and-trade program was designed to cut sulfur dioxide and nitrogen oxide in the eastern United States. But CAIR was thrown out by a federal appeals court in 2008. The court temporarily reinstated the rule in December 2008 to give EPA time to craft a replacement. Members of the Senate, meanwhile, are pushing a legislative fix for the CAIR rule ([E&ENews PM](#) , Feb. 4).

"Later this year, we'll propose a new utility MACT standard," Jackson added. EPA is facing a court deadline to require plant-specific maximum achievable control technology for mercury and other hazardous air pollutants at power plants by November 2011 ([Greenwire](#) , Oct. 23, 2009).

"Working together, we'll set a strong foundation for achieving the reductions that a new MACT and new CAIR rules will require," Jackson said.

Jackson said that although challenges and disagreements will arise during the development of new standards, "the benefits of us getting this right are absolutely unprecedented."

EPA to Regulate Greenhouse Gases

WASHINGTON - The [Environmental Protection Agency](#) is expected for the first time to regulate carbon dioxide and other greenhouse gases that scientists blame for the warming of the planet, according to top Obama administration officials.

The decision, which likely would play out in stages over a period of months, would have a profound impact on transportation, building standards, manufacturing costs and how utilities generate power. It could accelerate the progress of energy and [climate change](#) legislation in Congress and form a basis for the United States' negotiating position at [United Nations](#) climate talks set for December in Copenhagen.

The E.P.A. is under order from the [Supreme Court](#) to make a determination whether carbon dioxide is a pollutant that endangers public health and safety, an order that the Bush administration essentially ignored despite a near-unanimous belief among E.P.A. experts that the research points inexorably to such a finding.

[Lisa P. Jackson](#), the new E.P.A. administrator, said in an interview that she has asked her staff to review the latest scientific evidence and prepare the documentation for a so-called endangerment finding, although she said she had not made a final decision to issue one. But she pointedly noted that the second anniversary of the Supreme Court decision, in Massachusetts v. E.P.A., is April 2. "We here know how momentous that decision could be," she said. "We have to lay out a road map."

She took a first step on Tuesday when she said the agency would reconsider a Bush administration decision not to regulate carbon dioxide emissions from new coal-burning power plants. In announcing the reversal, Ms. Jackson said that the action would not be "the final

word” from the E.P.A. on the regulation of carbon dioxide emissions.

The White House has signaled that it fully supports Ms. Jackson’s approach, deferring to her to discuss the administration’s response to the Supreme Court case. Benjamin LaBolt, a White House spokesman, also pointed to statements on the subject during the presidential campaign by Heather Zichal, a top adviser on environmental and energy issues.

Ms. Zichal, who is now deputy to [Carol Browner](#), the White House coordinator for climate and energy policy, said last fall that the Bush White House had prevented the E.P.A. from making the endangerment finding “consistent with its obligations under the recent Supreme Court decision.” She said that while Mr. Obama supported Congressional action on climate change, he was also committed to using the regulatory authority of the executive branch to reduce global warming emissions.

If the E.P.A. determines that carbon dioxide is a dangerous pollutant to be regulated under the [Clean Air Act](#), it would set off one of the most extensive regulatory rule-makings in history. Ms. Jackson knows that she would be stepping into a minefield of Congressional and industry opposition and she said that she is trying to craft a program that would allay these worries.

“We are poised to be specific on what we regulate and on what schedule,” she said. “We don’t want people to spin that into a doomsday scenario.”

Even some who favor an aggressive approach to climate change are wary of the E.P.A. asserting exclusive authority over carbon emissions. They say that the Clean Air Act, now more than 40 years old, was not intended to regulate ubiquitous substances like carbon dioxide. They also believe that a broader approach that addresses all aspects of the economy and is fully debated in Congress would be better than a regulatory action that could easily drag through the courts for years.

The finding and the proposed regulations would be issued in sequence, with ample opportunity for public comment and not in a sudden burst of regulatory muscle-flexing, Ms. Jackson said. The regulations would work in concert with any legislation and not supplant it, she added.

“What we are likely to see is an interplay of authorities, some new, some existing,” she said.

That is not likely to assuage critics, including many Democrats from states dependent on coal-generated electricity and manufacturing jobs, where such regulation could significantly increase costs. Representative [John D. Dingell](#) Jr., the Michigan Democrat who has long championed the interests of the American auto industry, said that regulation of carbon dioxide emissions by the E.P.A. would set off a “glorious mess” that would resonate throughout the economy.

Senator John Barrasso, Republican of Wyoming, warned Ms. Jackson during her January confirmation hearing that she should not undercut Congress’s authority by using the E.P.A.’s regulatory power to address global warming. He called the use of the Clean Air Act to regulate carbon “a disaster waiting to happen.”

Many environmental advocates said the E.P.A.'s action is long overdue. But they see the measure, they said, as a stopgap until Congress passes comprehensive climate change legislation.

"It's politically necessary, scientifically necessary and legally necessary," said David Bookbinder, chief climate counsel at the [Sierra Club](#), one of the plaintiffs in the Supreme Court case. But he said that Congressional action is preferable to E.P.A. acting on its own. "We are loudly advocating for tailor-made legislation as the best means of addressing carbon emissions. Trying to address climate change via a series of rulemakings from E.P.A. is a distant second best."

We recognize that we need to act quickly and that industry needs regulatory certainty to make the important investment decisions that are called for to bring the new generation of vehicles to the marketplace. Therefore we each expect to issue proposed rules addressing passenger cars, light trucks and medium duty passenger vehicles by August 2009, with final rules issued by April 2010.

We are confident that the federal programs that result will put the nation on the right path to addressing the very important problems we face on climate change and energy security. We will dedicate our leadership and resources to ensuring that these goals are met. We intend to stay personally involved and monitor the progress of this effort.

Obama Delaying 'Hard Choices' On Many Of Environmentalists' Priorities

President Obama is unlikely to swiftly make "hard choices" on key energy and environmental issues favored by environmentalists, despite many groups strongly pushing the new administration to show early and strong support for their priorities.

In recent weeks, activists have pushed the new administration to embrace their positions on a wide range of topics, including reforming toxics law, aggressive climate change controls, bills to clarify the scope of the Clean Water Act, abolishing cost-benefit analysis and opposing Canadian tar sands oil development. But the administration is in a "hard core examination mode" and "moving pretty cautiously," one environmentalist says.

An industry source says "we've learned a lot" from the first five weeks of the new administration -- including signals that the Obama EPA will reverse the Bush administration's opposition to climate change regulations -- but that the "hard decisions" regarding which environmental efforts to prioritize are yet to come.

Environmentalists and industry sources agree that while the Obama administration appears to be saying "all the right things" to activist groups on some of their top priorities, the extent of Obama's willingness to swiftly develop policies on those issues remains to be seen. Complicating matters is the state of the economy, as well as a number of other non-environmental administration priorities, primarily health care reform.

An EPA spokesman says the "remarkable" amount the agency has done in only a few weeks with a "skeletal political staff" is a testament to EPA Administrator Lisa Jackson's "sense of urgency." The spokesman also

says transparency, science and the rule of law will guide Jackson's decisions and that it's important not to "prejudge" decisions to ensure a fair and impartial process. The spokesman adds that environmentalists have praised recent actions by the agency.

And other activists point to recent developments as evidence of the new administration's clear direction on environmental issues, including the stimulus law that provides more than \$7 billion for EPA programs and even more for renewable energy projects, and the agency's recent announcements that it will review Bush administration decisions on national air standards, and a policy blocking carbon dioxide (CO₂) limits in air permits.

Still, on a wide-ranging set of issues, environmentalists have pressed the Obama administration for further action, but to date have had little feedback from the administration on a number of key issues. Efforts include trying to win EPA support for a bill to clarify the scope of the Clean Water Act.

However, Jackson recently told reporters, "I don't have a position" on the merits of the bill, the Clean Water Restoration Act, and in written responses to questions from Senate environment committee members following her Jan. 14 confirmation hearing said the issue was "complicated."

Environmentalists are also urging Jackson to embrace pending legislation from Sen. Frank Lautenberg (D-NJ) to reform the Toxic Substances Control Act. Jackson stopped short of endorsing the legislation during her Jan. 14 confirmation hearing. In written questions, Lautenberg asked if Jackson supports requiring chemicals to be tested for safety before coming to market -- a key component of his bill. Jackson said she would work with Congress, EPA and the White House "to determine the best approach."

In recent weeks, activists have also pushed Obama to take a strong position opposing the development of oil from Canadian tar sands and are urging EPA to use its Clean Air Act permitting authority to place new limits on oil refineries' ability to process heavy crude. EPA has said little on the issue, though Obama does appear open to finding ways to make oil from tar sands "clean" given the long-running concerns about the oil development's adverse environmental impacts, according to recent statements he made.

Meanwhile, a group of legal scholars that favor strict regulation is urging

the Obama administration to drop the use of cost-benefit methods when reviewing EPA and other agencies' regulations. The likelihood that Obama will nominate Cass Sunstein -- a strong proponent of cost-benefit analysis -- already drew a "collective groan" from activists opposed to such regulatory reviews.

The scholars want the Obama administration to adopt an alternative review method known as pragmatic regulatory impact analysis that assesses rules based on their adherence to statutory risk priorities rather than economic factors, though the White House is yet to respond to their call.

"What's interesting," the first environmentalist says, "is that the Obama administration has laid out a set of markers but acted on precious few of them," adding, "that's not a criticism, it's reality." Both the environmentalist and the industry source compare the current situation to the early Clinton administration, in which the then-president signaled strongly on environmental issues but was forced to prioritize.

However, another environmentalist says, "I think anybody that is criticizing [the administration] right now is pretty silly." Indeed, major environmental groups including the Sierra Club have welcomed a number of recent announcements from the Obama EPA on climate change.

For example, Jackson has announced a review of the Bush administration's denial of California's Clean Air Act waiver that would have allowed the state to set first-time CO₂ limits for automobiles. She also granted environmentalists' petition to review a policy from former Bush EPA Administrator Stephen Johnson that blocks the consideration of CO₂ limits in air permits for power plants.

Obama Delaying 'Hard Choices' On Many Of Environmentalists' Priorities

President Obama is unlikely to swiftly make “hard choices” on key energy and environmental issues favored by environmentalists, despite many groups strongly pushing the new administration to show early and strong support for their priorities.

In recent weeks, activists have pushed the new administration to embrace their positions on a wide range of topics, including reforming toxics law, aggressive climate change controls, bills to clarify the scope of the Clean Water Act, abolishing cost-benefit analysis and opposing Canadian tar sands oil development. But the administration is in a “hard core examination mode” and “moving pretty cautiously,” one environmentalist says.

An industry source says “we’ve learned a lot” from the first five weeks of the new administration -- including signals that the Obama EPA will reverse the Bush administration’s opposition to climate change regulations -- but that the “hard decisions” regarding which environmental efforts to prioritize are yet to come.

Environmentalists and industry sources agree that while the Obama administration appears to be saying “all the right things” to activist groups on some of their top priorities, the extent of Obama’s willingness to swiftly develop policies on those issues remains to be seen. Complicating matters is the state of the economy, as well as a number of other non-environmental administration priorities, primarily health care reform.

An EPA spokesman says the “remarkable” amount the agency has done in only a few weeks with a “skeletal political staff” is a testament to EPA

Administrator Lisa Jackson's "sense of urgency." The spokesman also says transparency, science and the rule of law will guide Jackson's decisions and that it's important not to "prejudge" decisions to ensure a fair and impartial process. The spokesman adds that environmentalists have praised recent actions by the agency.

And other activists point to recent developments as evidence of the new administration's clear direction on environmental issues, including the stimulus law that provides more than \$7 billion for EPA programs and even more for renewable energy projects, and the agency's recent announcements that it will review Bush administration decisions on national air standards, and a policy blocking carbon dioxide (CO₂) limits in air permits.

Still, on a wide-ranging set of issues, environmentalists have pressed the Obama administration for further action, but to date have had little feedback from the administration on a number of key issues. Efforts include trying to win EPA support for a bill to clarify the scope of the Clean Water Act.

However, Jackson recently told reporters, "I don't have a position" on the merits of the bill, the Clean Water Restoration Act, and in written responses to questions from Senate environment committee members following her Jan. 14 confirmation hearing said the issue was "complicated."

Environmentalists are also urging Jackson to embrace pending legislation from Sen. Frank Lautenberg (D-NJ) to reform the Toxic Substances Control Act. Jackson stopped short of endorsing the legislation during her Jan. 14 confirmation hearing. In written questions, Lautenberg asked if Jackson supports requiring chemicals to be tested for safety before coming to market -- a key component of his bill. Jackson said she would work with Congress, EPA and the White House "to determine the best approach."

In recent weeks, activists have also pushed Obama to take a strong position opposing the development of oil from Canadian tar sands and are urging EPA to use its Clean Air Act permitting authority to place new limits on oil refineries' ability to process heavy crude. EPA has said little on the issue, though Obama does appear open to finding ways to make oil from tar sands "clean" given the long-running concerns about the oil development's adverse environmental impacts, according to recent statements he made.

Meanwhile, a group of legal scholars that favor strict regulation is urging the Obama administration to drop the use of cost-benefit methods when reviewing EPA and other agencies' regulations. The likelihood that Obama will nominate Cass Sunstein -- a strong proponent of cost-benefit analysis -- already drew a "collective groan" from activists opposed to such regulatory reviews.

The scholars want the Obama administration to adopt an alternative review method known as pragmatic regulatory impact analysis that assesses rules based on their adherence to statutory risk priorities rather than economic factors, though the White House is yet to respond to their call.

"What's interesting," the first environmentalist says, "is that the Obama administration has laid out a set of markers but acted on precious few of them," adding, "that's not a criticism, it's reality." Both the environmentalist and the industry source compare the current situation to the early Clinton administration, in which the then-president signaled strongly on environmental issues but was forced to prioritize.

However, another environmentalist says, "I think anybody that is criticizing [the administration] right now is pretty silly." Indeed, major environmental groups including the Sierra Club have welcomed a number of recent announcements from the Obama EPA on climate change.

For example, Jackson has announced a review of the Bush administration's denial of California's Clean Air Act waiver that would have allowed the state to set first-time CO₂ limits for automobiles. She also granted environmentalists' petition to review a policy from former Bush EPA Administrator Stephen Johnson that blocks the consideration of CO₂ limits in air permits for power plants.

The Obama administration is also asking to enter settlement talks with environmentalists and states that sued the Bush EPA over a rule changing Toxic Release Inventory reporting requirements. At the time the rule was issued, critics said the changes weakened requirements for companies to report their toxic emissions.

Jackson has also said she is open to reviewing the Bush EPA's changes to the agency's national ambient air quality standards for ozone and fine particulate matter (PM_{2.5}). EPA must conduct a new review of the PM_{2.5} standard after an appellate court recently remanded it to the agency.

Environmentalists also point to recent developments in Congress as a clear signal of the Obama administration's position on energy and environmental issues that the activists say is similar to their agenda.

For example, Obama in his Feb. 24 speech to Congress asked lawmakers "to send me legislation that places a market-based cap on carbon pollution and drives the production of more renewable energy in America" and reiterated his commitment to spend \$150 billion over ten years on clean energy research.

Environmentalists also welcome the economic stimulus law Obama signed Feb. 17 which provides \$7.22 billion for EPA programs and many more billions for renewable energy projects.

Another activist opposed to Canadian tar sands oil development also praises remarks Obama made following his recent visit to Canada. On the trip Obama did not address tar sands directly, but did say, "increasingly we have to take into account the issue of climate change and greenhouse gases."

Canadian Prime Minister Stephen Harper has since indicated a willingness to consider environmental and labor protections in the North American Free Trade Agreement (NAFTA) if he and Obama can avoid "opening the whole NAFTA and unraveling what is a very complex agreement."

The industry source says Obama is "saying all the right things" on "80 percent of what environmentalists want, but the other 20 percent they're pressing him on, they are so out of their minds on those even Obama won't do it." The source cites in particular environmentalists' efforts to abolish cost-benefit analysis from the regulatory process, which the source says is the "stupidest approach" to the issue.

Environmentalists and the Obama administration "can't get everything they want because the lights would literally go out -- we wouldn't have enough power," the source says, reiterating long-running claims by some industry officials that aggressive environmental regulation could harm the economy.

EPA: Global Warming Threatens Public Health, Welfare

The Environmental Protection Agency sent a proposal to the White House that global warming is endangering the public's health and welfare, according to several sources. The move has far-reaching implications for the nation's economy and environment.

The proposal -- which comes in response to a 2007 Supreme Court decision on whether carbon dioxide and other greenhouse gases should be regulated under the Clean Air Act -- could lay the groundwork for nationwide measures to limit such emissions. It follows the administration's landmark environmental decisions: In July 2008 then-EPA Administrator Stephen Johnson rejected his scientific and technical staff's recommendation and announced a six-month seek months of further public comment on the threat posed by global warming.

"This is historic news," said Frank O'Donnell, who heads the public watchdog group Climate Reality. "It will set the stage for the first-ever national limits on global warming pollutants and help light a fire under Congress to get moving."

But business groups decried the move as an economic disaster.

Future Grows More Hazy For Mountaintop Mining

EPA's Fluctuating Messages Concern W.Va. Residents

ETHEL, W.Va. -- In one of the deepest, steepest corners of Appalachia, where the most important industry is shearing mountains down to flat-top stumps, everybody wants the same answer.

What did Washington just do?

About two weeks ago, the Environmental Protection Agency seemed poised to crack down on the "mountaintop" coal mines that are common in this region, which industry officials say would threaten thousands of jobs. The EPA said it had "significant concerns" about the mines -- in which peaks are legally blasted off to get at coal seams inside -- because neighboring streams are buried under displaced rock.

But later that day, the EPA suddenly seemed to play down its own worries, saying it thought the bulk of the projects would "not raise environmental concerns."

The episode has been seen as an early unsteady attempt by a White House with environmental ambitions to confront one of its most vexing problems: polluting, carbon-heavy, economically vital coal.

This week, EPA Administrator Lisa P. Jackson -- making her first public comments about the letters -- said her agency did not intend to send a mixed message. She said that the EPA was not trying to stop all mountaintop removal but that it "is going to do its job" in checking 150 to 200 projects for environmental impact.

"This was not about making any kind of value judgment on a practice of mining," Jackson said in

an interview. "This is about science. And what the law tells us to do is review these permits." But here in southern West Virginia, the EPA's moves have left a powerful sense of uncertainty about the future of mountaintop mining. People also see this issue as a microcosm of the nation's ambivalence about coal.

"We don't have a clue" what the federal government is planning, said Roger Horton, a truck driver at a West Virginia mine who heads the group Citizens for Coal. "We want clarity. To do this, to me, is inhumane."

As Washington has become more focused on climate change, coal has become something like the new tobacco: publicly reviled, at least by some, but still deeply embedded in the economy. Coal produces dirty water when it is mined and greenhouse gases when it is burned, but it also accounts for about half of U.S. electric power, and coal mining provides about 82,000 jobs. What happens here, in the heart of mountaintop-mining country, might be considered coal's unfiltered version.

"You know 'Almost heaven, West Virginia'? Well, now it's 'Almost level, West Virginia,' " said Teresa Perdue, 50, a resident of Ashford, W.Va., who has spoken out against mountaintop removal. Perdue was looking down at a vista that once included a rounded mountain and a valley, Bull Creek Hollow.

But the peak was blasted and scooped away by heavy machinery to get at thin seams of coal near the surface. Excess rock was dumped into the valley. The resulting landscape was flatter and browner, with plenty of bare rock.

"Who said it's okay to bury streams, it's okay to cut the tops off mountains to get coal?" Perdue said. She still takes senior photos for local high-schoolers there, but now she has to crop the photos tighter: The background has an unnatural amount of sky, at least for West Virginia. Some environmentalists think the science is overwhelming that mountaintop mining is harmful. Pro-coal people think the economy trumps everything: "There's nothing to replace [coal] right now," said Jim Taylor, a 73-year-old with long, white George Jones sideburns who manages a hydraulic and machine repair shop in Logan, W.Va.

Sitting in front of a former service station in Blair, W.Va., Carlos Gore, 57, a mountaintop mining opponent, said previous experience shows that mining companies usually win: "They take the rules, and they bend it and twist it like a pig's tail."

Mountaintop mining is also called "mountaintop removal," although in most cases, rock is piled up to re-create the mountain's contours and replanted with grass and trees. The practice is centered in eastern Kentucky and southern West Virginia, although there are some mines in Tennessee, southeast Ohio and southwest Virginia. At the EPA's last count, in 2001, the mines' "valley fills" had buried 724 miles of stream valleys, about 1.2 percent of the region's total.

The industry says the mines produce about 10 percent of the country's coal. Last year, a Washington Post analysis found that the area's coal-burning power plants purchased 32 percent of their fuel from surface mines in this region, which often involve mountaintop mining.

Lately, mountaintop mining's opponents had been on a losing streak. In December, the Bush administration approved a rule that environmentalists said would make it easier to dump waste rock near streams. And in February, a U.S. appeals court rejected environmental groups' challenges to certain mining permits.

Then, on March 24, EPA officials released two letters that had been sent to the U.S. Army Corps of Engineers, which handles permits for valley fills. The letters said that two mines -- one here near Ethel and the other in Pike County, Ky. -- could harm aquatic life in the buried valleys and downstream. It sent three more letters this week, expressing concerns about valley fills at a mine

in southwest Virginia and two in West Virginia.

To the coal-industry, it looked like a torpedo, aimed at mountaintop mining.

"EPA: End Production in America," said Chris Hamilton, a vice president at the West Virginia Coal Association. He said it is wrong that in a worldwide economic crisis, "here we're almost trying to find a way to force these, you know, mining jobs to go elsewhere."

In her interview with The Post, Jackson said that the EPA had just begun to review these permit applications and that although "the sense right now is that the vast majority of them are not significant" concerns, she could not predict the final outcome. She said that the White House Council on Environmental Quality has convened officials from the EPA, the Army Corps of Engineers and other federal agencies to talk about the future of mountaintop mining more generally.

In Logan County, W.Va., County Commission President Art Kirkendoll said he was worried that the EPA will eventually turn against coal mining in general, which would remove his area's economic bedrock. Future Grows More Hazy For Mountaintop Mining

EPA's Fluctuating Messages Concern W.Va. Residents

ETHEL, W.Va. -- In one of the deepest, steepest corners of Appalachia, where the most important industry is shearing mountains down to flat-top stumps, everybody wants the same answer.

What did Washington just do?

About two weeks ago, the Environmental Protection Agency seemed poised to crack down on the "mountaintop" coal mines that are common in this region, which industry officials say would threaten thousands of jobs. The EPA said it had "significant concerns" about the mines -- in which peaks are legally blasted off to get at coal seams inside -- because neighboring streams are buried under displaced rock.

But later that day, the EPA suddenly seemed to play down its own worries, saying it thought the bulk of the projects would "not raise environmental concerns."

The episode has been seen as an early unsteady attempt by a White House with environmental

ambitions to confront one of its most vexing problems: polluting, carbon-heavy, economically vital coal.

This week, EPA Administrator Lisa P. Jackson -- making her first public comments about the letters -- said her agency did not intend to send a mixed message. She said that the EPA was not trying to stop all mountaintop removal but that it "is going to do its job" in checking 150 to 200 projects for environmental impact.

"This was not about making any kind of value judgment on a practice of mining," Jackson said in an interview. "This is about science. And what the law tells us to do is review these permits." But here in southern West Virginia, the EPA's moves have left a powerful sense of uncertainty about the future of mountaintop mining. People also see this issue as a microcosm of the nation's ambivalence about coal.

"We don't have a clue" what the federal government is planning, said Roger Horton, a truck driver at a West Virginia mine who heads the group Citizens for Coal. "We want clarity. To do this, to me, is inhumane."

As Washington has become more focused on climate change, coal has become something like the new tobacco: publicly reviled, at least by some, but still deeply embedded in the economy. Coal produces dirty water when it is mined and greenhouse gases when it is burned, but it also accounts for about half of U.S. electric power, and coal mining provides about 82,000 jobs. What happens here, in the heart of mountaintop-mining country, might be considered coal's unfiltered version.

"You know 'Almost heaven, West Virginia'? Well, now it's 'Almost level, West Virginia,'" said Teresa Perdue, 50, a resident of Ashford, W.Va., who has spoken out against mountaintop removal. Perdue was looking down at a vista that once included a rounded mountain and a valley, Bull Creek Hollow.

But the peak was blasted and scooped away by heavy machinery to get at thin seams of coal near the surface. Excess rock was dumped into the valley. The resulting landscape was flatter and browner, with plenty of bare rock.

"Who said it's okay to bury streams, it's okay to cut the tops off mountains to get coal?" Perdue said. She still takes senior photos for local high-schoolers there, but now she has to crop the photos tighter: The background has an unnatural amount of sky, at least for West Virginia. Some environmentalists think the science is overwhelming that mountaintop mining is harmful. Pro-coal people think the economy trumps everything: "There's nothing to replace [coal] right now," said Jim Taylor, a 73-year-old with long, white George Jones sideburns who manages a hydraulic and machine repair shop in Logan, W.Va.

Sitting in front of a former service station in Blair, W.Va., Carlos Gore, 57, a mountaintop mining opponent, said previous experience shows that mining companies usually win: "They take the rules, and they bend it and twist it like a pig's tail."

Mountaintop mining is also called "mountaintop removal," although in most cases, rock is piled up to re-create the mountain's contours and replanted with grass and trees. The practice is centered in eastern Kentucky and southern West Virginia, although there are some mines in Tennessee, southeast Ohio and southwest Virginia. At the EPA's last count, in 2001, the mines' "valley fills" had buried 724 miles of stream valleys, about 1.2 percent of the region's total.

The industry says the mines produce about 10 percent of the country's coal. Last year, a Washington Post analysis found that the area's coal-burning power plants purchased 32 percent of their fuel from surface mines in this region, which often involve mountaintop mining.

Lately, mountaintop mining's opponents had been on a losing streak. In December, the Bush

administration approved a rule that environmentalists said would make it easier to dump waste rock near streams. And in February, a U.S. appeals court rejected environmental groups' challenges to certain mining permits.

Then, on March 24, EPA officials released two letters that had been sent to the U.S. Army Corps of Engineers, which handles permits for valley fills. The letters said that two mines -- one here near Ethel and the other in Pike County, Ky. -- could harm aquatic life in the buried valleys and downstream. It sent three more letters this week, expressing concerns about valley fills at a mine in southwest Virginia and two in West Virginia.

To the coal-industry, it looked like a torpedo, aimed at mountaintop mining.

"EPA: End Production in America," said Chris Hamilton, a vice president at the West Virginia Coal Association. He said it is wrong that in a worldwide economic crisis, "here we're almost trying to find a way to force these, you know, mining jobs to go elsewhere."

In her interview with The Post, Jackson said that the EPA had just begun to review these permit applications and that although "the sense right now is that the vast majority of them are not significant" concerns, she could not predict the final outcome. She said that the White House Council on Environmental Quality has convened officials from the EPA, the Army Corps of Engineers and other federal agencies to talk about the future of mountaintop mining more generally.

In Logan County, W.Va., County Commission President Art Kirkendoll said he was worried that the EPA will eventually turn against coal mining in general, which would remove his area's economic bedrock. ENERGY POLICY: U.S. has much to learn from N.J. programs -- Corzine

New Jersey's energy programs offer a template for federal action on climate, energy efficiency and renewable power, the state's governor told a regional energy summit today.

"I think we are doing a lot to move forward on alternative energy," Gov.

Jon Corzine (D) said. "It is happening broadly across our state." New Jersey's success in helping launch the nation's only

government-regulated, cap-and-trade program for greenhouse gases

"without a huge hue and cry" shows strong public support for fighting climate change, Corzine told the Council on Competitiveness gathering at Rutgers University.

The meeting is part of a series of regional gatherings designed to influence debate on new energy and climate legislation. While not perfect, the move by Northeastern states to the Regional Greenhouse Gas Initiative, or RGGI, provides lessons for Congress and the Obama administration, Corzine said. RGGI "is off to a terrific start," he said.

As part of its energy master plan, New Jersey is committed to ambitious goals, including generating 30 percent of its electricity from renewable sources, cutting overall energy consumption by 20 percent and reducing emissions of carbon dioxide and other heat-trapping gases by 25 percent within the next 11 years, Corzine said.

Among initiatives to help the state meet its goals, Corzine cited the state's market for trading renewable energy credits (RECs) from solar power. The state's RECs trade at some of the highest prices in the solar market, helping make New Jersey second to California in the volume of installed solar capacity. New small-scale solar projects continue to sprout in New Jersey despite the economic downturn.

Rutgers is nearing completion of what is billed as the largest U.S. solar plant on a college campus.

Immediately after his speech, Corzine visited a new solar project being built on the East Rutherford campus by the pharmaceutical giant Merck & Co.

The state Board of Public Utilities is also working with PSEG, New Jersey's largest energy provider, to develop an offshore wind farm near Atlantic City. Developers are racing in Massachusetts, Delaware and Rhode Island to build the nation's first offshore wind plant; the New

Jersey project is expected to generate 1,000 megawatts by 2013 and 3,000 MW by 2020.

The state is also pursuing policies designed to encourage geothermal power generation.

But Corzine warned that efforts to launch various clean energy initiatives have pitfalls.

"It is very challenging," he said, "to be able to make certain that we get the price and execution of energy efficiency programs, in particular, rolled out.

"New Jersey is struggling to get homeowners and businesses to enhance their energy efficiency. And state regulators are experimenting with "decoupling" electricity-rate rules designed to eliminate the paradox of electricity providers losing revenue as they encourage customers to reduce electricity consumption. Designing a system to encourage energy efficiency in households is thus far proving the greatest challenge, Corzine said.

Regulators and utility executives are trying to learn how to nudge households toward making often-expensive retrofits without raising electricity rates substantially, since New Jersey residents already pay some of the highest power prices in the country.

"I think it's safe to say that we have some work to do," Corzine said.

"We're looking for that right mix so that we can actually unfold a broad-based, scaled program."






OMB Memo: Serious Economic Impact Likely From EPA CO2 Rules

WASHINGTON (Dow Jones)--U.S. regulation of greenhouse gases such as carbon dioxide "is likely to have serious economic consequences" for businesses small and large across the economy, a White House memo warned the Environmental Protection Agency earlier this year.

The nine-page document also undermines the EPA's reasoning for a proposed finding that greenhouse gases are a danger to public health and welfare, a trigger for new rules.

The memo, an amalgamation of government agencies' comments sent from the Office of Management and Budget to the EPA, is in stark contrast to the official position presented by President Barack Obama and his Cabinet officials. It is likely to give critics of greenhouse-gas regulation ammunition in their political salvos against the administration.

Cabinet officials, including the president's climate-change czar, Carol Browner, have said the administration would prefer Congress create greenhouse-gas regulations through legislation, and not through the EPA's Clean Air Act.

But the White House has given the EPA the green light to move ahead with regulation under the Clean Air Act, a move deemed by some analysts as political leverage to push Congress to act because of the bluntness of the tool.

According to government records, the document was submitted by the OMB as comment on the EPA's April 15 proposed finding that greenhouse gases are a danger to public health and welfare, a key trigger for regulation of greenhouse gases emitted from cars, power plants, and potentially any number of other sources, including lawn mowers, snowmobiles and hospitals.

While business groups have warned about the potential for a cascade of regulation and litigation, the EPA has said that greenhouse-gas rules would only be for large emitters.

The memo - marked as "Deliberative-Attorney Client Privilege" - doesn't have a date or a named author. But an OMB spokesman confirmed it was prepared by Obama administration staff as part of the inter-agency review process of the proposed endangerment finding.

"It's a conglomeration of counsel we've received from various agencies...and it's not indicative of an OMB or administration-wide position," an OMB official said.

OMB spokesman Tom Gavin said, "It's up to the EPA now to consider the various suggestions that were part of the interagency review and make some decisions on which direction they want to move."

The position outlined in the memo is at odds with other White House documents on the proposed endangerment rule, which appear to affirm the EPA's decision to move ahead with the endangerment finding.

"Making the decision to regulate CO2 under the [Clean Air Act] for the first time is likely to have serious economic consequences for regulated entities throughout the U.S. economy, including small businesses and small communities," the OMB document reads.

"The finding should also acknowledge the EPA has not undertaken a systemic risk analysis or cost-benefit analysis," it reads.

The head of the U.S. Chamber of Commerce's environment and regulatory affairs, William Kovacs, said the memo "confirms almost everything we've been saying on the spillover effects of regulating greenhouse gases." He said the OMB legal brief exposes the administration and the EPA to litigation if it finalizes the endangerment finding and begins to regulate greenhouse gases under the Clean Air Act, particularly because it was drafted during the deliberation process.

Although an official within the EPA's Climate Change Division said the agency "considers everything we receive," an EPA spokeswoman couldn't immediately comment on the extent to which memo influenced the drafting of the proposed rule.

Earlier this year, EPA chief Lisa Jackson dismissed concerns raised by groups such as the Chamber and the National Association of Manufacturers, saying, "It is a myth...[that] EPA will regulate cows, Dunkin' Donuts, McDonald's, Huts, your lawn mower and baby bottles."

The White House legal brief starts by questioning the link between the EPA's scientific technical endangerment proposal and the EPA's political summary. Jackson said in the endangerment summary that "scientific findings totality point to compelling evidence of human-induced climate change, and that serious risks and potential impacts to public health and welfare have been clearly identified..."

"The finding rests heavily on the precautionary principle, but the amount of acknowledged lack of understanding about the basic facts surrounding [greenhouse gases] seem to stretch the precautionary principle to providing regulation in the face of unprecedented uncertainty," the memo reads.

For example, the memo notes, the EPA endangerment technical document points out there are several areas with essential behaviors of greenhouse gases are "not well determined" and "not well understood."

The OMB memo questions with concern the adequacy of the EPA finding that the gases are a harm to the public when there is "no demonstrated direct health effects," and the scientific data on which the agency relies are "almost exclusively from non-EPA sources."

Based on the "dramatically expanded precautionary principle," the EPA would be petitioned to find endangerment and regulate many other alleged "pollutants," including electro-magnetic fields, noise, and salts called perchlorates.

The memo also warns that the endangerment finding, if finalized by the administration, could make agencies vulnerable to litigation alleging inadequate environmental permitting reviews, adding that the proposal could unintentionally trigger a cascade of regulations.

The administration last week avoided requiring permitting reviews that would need to consider the impact of greenhouse gases when it decided not to revoke a Bush administration rule on polar bears. Although the Interior Secretary said greenhouse gases were the primary cause of the bear's loss of sea-ice habitat, the animal's listing as a threatened species couldn't be used to prevent oil refineries and coal-power plants from being built.

DELIBERATIVE—ATTORNEY CLIENT PRIVILEGE**Discussion of scientific support and analysis.**

The NPRM fails to articulate the process by which the Administrator came to the conclusion on p. 30, line 41-46:

“The Administrator believes that the scientific findings in totality point to compelling evidence of human-induced climate change, and that serious risks and potential impacts to public health and welfare have been clearly identified, even if they cannot always be quantified with confidence. The Administrator’s proposed endangerment finding is based on weighing the scientific evidence, considering the uncertainties, and balancing any benefits to human health, society the environment that may also occur.”

The finding document remains very separate from the TSD, with only occasional references to the IPCC or particular CCSP report findings, and it is up to the reader’s interpretation of the TSD to determine how the evidence has been weighed to arrive at the conclusions above. The finding rests heavily on the precautionary principle, but the amount of acknowledged lack of understanding about basic facts surrounding GHGs seem to stretch the precautionary principle to providing for regulation in the face of unprecedented uncertainty. (The TSD notes several areas where essential behaviors of GHGs are "not well determined" and "not well understood" (e.g., why have U.S. methane levels decreased recently?).) This could be remedied by expanding the discussion on pp. 25-31 to articulate more clearly how the Administrator weighed the scientific evidence related to each impact or how/whether she gave more or less weight to particular impacts for either the public health or the welfare finding and how she weighed uncertainty in her deliberations.

For example, the NPRM and TSD outline the following 5 human health effects from climate change: temperature effects, air quality changes, extreme events, climate-sensitive diseases and aeroallergens. It is unclear whether temperature effects will result in net mortality increases or decreases and the scientific literature does not provide definitive data or conclusions about aeroallergen impacts. Further, the impact of climate-sensitive diseases may be minimal in a rich country like the US.

Hence, it seems that the Administrator’s public health endangerment conclusion is based on the other two impacts, with the most significant health risks being posed by air quality changes. If so, the discussion here should state this explicitly. Further, the argument for why the increases in ozone from climate change pose a health impact could be fleshed out more thoroughly (p. 27, line 34-39). Since tropospheric ozone is already regulated under the Clean Air Act, EPA should explain why those regulations are inadequate to protect public health from the ozone impacts of climate change.

In addition, the finding could be strengthened by including additional information on benefits, costs, and risks (where this information exists); meeting appropriate standards for peer review; and accepted research protocols. Some issues to cover that would address costs, benefits, and risks include the following:

DELIBERATIVE—ATTORNEY CLIENT PRIVILEGE

- Methodology or methodologies used for weighing risks and various outcomes and the risks associated with each;
- Confidence intervals related to model results at the regional and local scales;
- Underlying assumptions of findings, publications on which the findings are based, and “business-as-usual” scenarios;
- Quality and homogeneity of temperature data from surface networks that may affect estimates of past temperature trends, and calibration and verification of models;
- Impacts of climate change on the value of net economic benefits.

The Finding should also acknowledge that EPA has not undertaken a systematic risk analysis or cost-benefit analysis.

In the absence of a strong statement of the standards being applied in this decision, there is a concern that EPA is making a finding based on (1) "harm" from substances that have no demonstrated direct health effects, such as respiratory or toxic effects, (2) available scientific data that purports to conclusively establish the nature and extent of the adverse public health and welfare impacts are almost exclusively from non-EPA sources, and (3) applying a dramatically expanded precautionary principle. If EPA goes forward with a finding of endangerment for all 6 GHGs, it could be establishing a relaxed and expansive new standard for endangerment. Subsequently, EPA would be petitioned to find endangerment and regulate many other “pollutants” for the sake of the precautionary principle (e.g., electromagnetic fields, perchlorates, endocrine disruptors, and noise).

Endangerment without consideration of regulatory consequences.

EPA should explain whether it considered a finding that methane and the other four non-CO₂ GHGs do in fact contribute to climate change, based on their higher warming potential, but that overriding policy concerns make such a finding infeasible concerning CO₂. Because methane and the other four non-CO₂ GHGs are either already regulated under the CAA or are functionally equivalent to pollutants typically regulated under the CAA, an endangerment finding for these GHGs would be relatively routine. Because GHGs are understood to be long-lived, well-mixed in the atmosphere, and generated by many nations around the globe, the most analogous regulatory approach for controlling GHGs would seem to be Title VI of the CAA. EPA's relevant experience with controlling ozone-depleting substances should inform its decisions on an approach to regulating GHGs.

In contrast, an endangerment finding under section 202 may not be the most appropriate approach for regulating GHGs. Making the decision to regulate CO₂ under the CAA for the first time is likely to have serious economic consequences for regulated entities throughout the U.S. economy, including small businesses and small communities. Should EPA later extend this finding to stationary sources, small businesses and institutions would be subject to costly regulatory programs such as New Source Review.

DELIBERATIVE—ATTORNEY CLIENT PRIVILEGE**The role of mitigation, adaptation, and/or benefits of climate change**

To the extent that climate change alters our environment, it will create incentives for innovation and adaptation that mitigate the damages from climate change. The document should note this possibility and how it affects the likely impacts of climate change.

For example, climate change is likely to unfold slowly and people may migrate from hot regions (e.g., Arizona) to more temperate regions (e.g., Minnesota) and this would mitigate the adverse impacts on health (although people would incur migration costs). Further, climate change is likely to lead to innovation that mitigates the ozone related health impacts; it seems reasonable to assume that in the absence of regulation of GHS, new medicines that lessen the health impacts of ozone will be developed. Moreover, advances in technology and the development of public health programs (e.g., cooling centers) are likely to lessen the negative welfare impacts of heat waves.

Similarly, the document would appear more balanced if it also highlighted whether particular regions of the US would benefit, and to what extent these positive impacts would mitigate negative impacts elsewhere in the United States. For example, it might be reasonable to conclude that Alaska will benefit from warmer winters for both health and economic reasons. Deschenes and Moretti (2007 *Review of Economics and Statistics*) demonstrate that extremely cold days are more dangerous to human health than extremely hot days. Please add this paper to the literature review in Section 7(a) of the TSD.

Further, there should be a consideration of the fertilizing effect of CO₂, which may overwhelm the negative impact of additional hot days on agricultural yields in some regions of the US. In others regions, the net effect is likely to be negative.

Agency compliance with other environmental mandates

There is some concern that an endangerment finding, and some of the language used to support the finding, will make it more difficult to comply with NEPA and other environmental planning statutes.

- This finding and the associated emission standards for these six greenhouse gases may make it much more expensive and difficult to develop other air quality standards (NAAQS in particular). For example, EPA has recently asked BLM to use models that sometimes exceed current budgets in developing resource management plans and environmental impact statements. Also, there are currently no models available that forecast the potential impacts of greenhouse gases on climate change at the regional or local level, which are the levels at which our decisions are made. This rule also could make findings that would leave agencies vulnerable to litigation alleging “inadequate NEPA” due to new information (i.e., the endangerment finding) that was not considered when the EIS was developed. Without a model available, an agency would be left with little ability to respond because (i) there are no standards to serve as thresholds, (ii) there are no tools to analyze impacts, and (iii) the cost of analyzing impacts could be exorbitant.

DELIBERATIVE—ATTORNEY CLIENT PRIVILEGE

- Unnecessarily broad or expansive language with respect to the effects of GHGs or the certainty with which effects will occur could create a basis for finding all GHG emissions significant for purposes of NEPA analysis, thus requiring an EIS for all direct and indirect effects that change GHG emissions in any amount. Similarly, EPA should be very careful to state which effects are significant and their scale to avoid unintentionally trigger NEPA for Federal actions not otherwise considered to have environmental impacts.

Four chemicals v. six chemicals

EPA proposes to make an endangerment finding on six directly emitted and long-lived GHGs—carbon dioxide, methane, nitrous oxide, hydrofluorocarbons, perfluorocarbons and sulfur hexafluoride, treated as a group as an air pollutant. The proposal, however, defines the terms “air pollution” and “air pollutant” for purposes of section 202(a) as the six GHGs, two of which are not addressed in the underlying petition and which EPA recognizes are not emitted by new motor vehicles or motor vehicle engines, and on page two, this action is characterized as a “response” to the Supreme Court’s decision in Massachusetts v. EPA, 549 U.S. 497 (2007), which arose from a petition with respect to the four GHGs. Although the latter two GHGs have similar characteristics and are addressed in UN documents, it is not clear why they are included in the endangerment and “cause or contribute” findings. While it appears that section 202(a) provides sufficiently broad authority for EPA to do so and the draft explains this decision as based on the uniform, global nature of GHG ambient concentrations, a seemingly simpler regulatory action might be to base the definition of “air pollution” or “air pollutant” on the four GHGs emitted by new motor vehicles or motor vehicle engines.

- This raises the question of the extent to which EPA intends or does not intend this finding to extend beyond section 202 to the same terms used in other key parts of the CAA, e.g., section 101(a) (general findings and purpose), section 108 (National Ambient Air Quality Standards), and section 111(b) (New Source Performance Standards). EPA would benefit from making its position explicit in this proposal. Commenters are sure to take this important issue on in some fashion so EPA may as well do what it can to shape the debate and the comments being invited. For example, it could note that the same terms are important parts of other key CAA provisions, but then state that EPA at this time is only addressing and seeking comment on issues directly associated with section 202. Alternatively, it could state that it views these findings as to GHGs to be broadly applicable to the Act as a whole, but nonetheless make clear that EPA is not in this rulemaking attempting to consider or address any of the other regulatory findings that would be necessary to trigger GHG regulation under other CAA programs. A third option would be to invite comment on whether interested parties believed there was any basis for distinguishing the understanding of the terms in the section 202 context from the understanding of the terms in other parts of the Act.

DELIBERATIVE—ATTORNEY CLIENT PRIVILEGE

- EPA fails to make a case of why the six GHGs should be treated as a single pollutant and why all six should be treated as a group. Treating the gases as a group yields the indefensible result that emissions of PFCs, SF₆ and HFCs other than HFC-134a from motor vehicles are asserted to “cause or contribute: to air pollution, when there are no such emissions from motor vehicles. Further, EPA states that: “Depending on the circumstances... it may be appropriate to set standards for individual gases [of the 6], or some combination of group and individual standards.” EPA asserts that these regulatory flexibilities would exist whether or not greenhouse gases are treated as multiple pollutants or as individual pollutants. [See discussion on page 32-33.]
- These greenhouse gases differ significantly in terms of physical properties, formation mechanisms, and possible mitigation techniques.
 - Mobile source CO₂ is formed by burning fossil fuels. Virtually all of the carbon in the fuel is converted to CO₂. The more efficient the combustion process, the more complete the conversion to CO₂. Unlike for traditional criteria pollutants (*e.g.*, NMHC, CO, NO_x), which can be converted to other substances through emissions aftertreatment (*i.e.*, catalytic converters), no mobile aftertreatment device can convert CO₂ to something that does not contribute to global warming.¹ Therefore, mobile source CO₂ emissions can only be reduced by burning less fossil fuel, either by improving fuel economy or converting to less carbon-intensive fuels.
 - Mobile source CH₄ and N₂O emissions are by-products of fossil fuel combustion. However, burning less fossil fuel does not necessarily mean reducing CH₄ and N₂O emissions. For example, using methane (CH₄) rather than petroleum could increase CH₄ emissions
 - Mobile source HFC emissions arise from releases of HFC refrigerants from mobile air conditioners. Therefore, mobile source HFC emissions can only be reduced by using different refrigerants and/or “hardening” mobile air conditioners to reduce the potential for refrigerant leaks.
 - Mobile source CO₂, CH₄, N₂O, and HFC emissions not only have different global warming potentials, they remain in the atmosphere for different amounts of time and are removed from the atmosphere by different mechanisms.
- In contrast to EPA’s citation of Class I and Class II substances under Title VI, under Title II, EPA’s treats mobile source NMHC and NO_x as separate pollutants, even though both are precursors to the formation of tropospheric ozone (*i.e.*, urban smog), and both are mitigated through a combination of fuel improvements,

¹ In fact, current catalytic converters operate by convert HC, CO, and NO_x into CH₄, N₂O, and CO₂ (and water).

combustion process changes, and emissions aftertreatment. Considering that mobile source CO₂, CH₄, N₂O, and HFC emissions are even more distinct from one another than are mobile source NMHC and NO_x emissions, and that EPA classifies NMHC and NO_x as separate pollutants, EPA should classify these as separate pollutants or, alternatively, classify CO₂ as one pollutant, classify CH₄ and N₂O as another pollutant (class), and classify HFCs as a third pollutant (class).

Accounting for the Global Nature of Greenhouse Gas Pollution in the Findings

In this draft proposal, EPA finds under Clean Air Act (CAA) section 202(a) that (1) “air pollution” in the form of the global mix of six greenhouse gases (or the GHGs) may be reasonably anticipated to endanger public health and welfare (the endangerment finding); and (2) emissions of an “air pollutant” in the form of the global mix of the GHGs from new motor vehicles or motor vehicle engines cause or contribute to that air pollution (the contribution finding). The agency characterizes the “global” nature of the GHG emissions and concentrations (page 16), notes the effects of GHG emissions globally in making the endangerment finding (page 29), and assesses the contribution of the GHGs emitted by section 202(a) sources as a percentage of global emissions (page 36). The proposal appears to assume, but does not explicitly discuss why (or solicit comment on whether) these are relevant legal inquiries under section 202(a) the Clean Air Act. This is virtually certain to be a subject of public comment; and we recommend that EPA directly address this matter in the proposal.

EPA also factors international considerations into the endangerment and contribution findings differently. On page 29, the agency states: “The Administrator judges that impacts to public health and welfare occurring within the U.S. alone warrant her proposed endangerment finding.” On page 36, however, EPA bases its finding on the “significance” of the GHG emissions from section 202(a) sources for purposes of the contribution finding in part on their global contribution:

It is the Administrator’s judgment that the collective GHG emissions from section 202(a) source categories are significant, whether the comparison is global (over 4 percent of total GHG emissions) or domestic (24 percent of total GHG emissions). The Administrator believes that consideration of the global context is important for the cause or contribute test but that the analysis should not solely consider the global context.

It is unclear from the proposal why a difference in treatment of the two findings is necessary or appropriate. Because the Administrator regards the domestic contribution comparison in itself to be significant, it may be simpler (and less open to challenge) to base the contribution finding solely on domestic considerations. (This would not foreclose a discussion of global contribution, provided, as requested above, it is made clear how relevant this is under section 202(a)).

Group Versus Individual Approach to “Air Pollutant”

On page 32, EPA proposes to designate the six GHGs, collectively, as the "air pollutant" for which the endangerment finding is being made. The proposal, however, then goes on at pages 33-40 to analyze the contribution issue both as to the six GHGs collectively, and as to each individually. Although EPA hints that it believes either a collective or individual approach could be valid and would reach similar results, see page 34, the agency never really says expressly whether or not it is soliciting comment on these issues and whether it would be open to considering a pollutant-by-pollutant-based approach for the final rule. We recommend that this be made explicit.

Comment Solicitation

EPA limits solicitation of comment on the proposal to the simple statements on page six to the effect that it seeks comment on all aspects of this action (data, methodology, and major legal and policy considerations). While this is efficient and legally sufficient, the agency may want to highlight a few key areas in which comment would be most useful. The first two issues that we've identified above might be worthy of an express request for comment. EPA may also need to clarify the relationship between comment on this proposal and the July 30, 2008 Advance Notice of Proposed Rulemaking on Greenhouse Gas Emissions (ANPR). In footnote 11, EPA indicates that it is responding to a few key comments from the ANPRM in this proposal related to the endangerment and contribution findings and asks commenters to "submit to the docket for today's action any comments they want EPA to consider as it makes a decision on this proposed determination." We recommend that EPA move the footnote 11 discussion up to the main body of the proposal at page 6 and explicitly state that commenters may not rely on prior submission of comments to the ANPR and that if parties wish EPA to consider comments made in response to the ANPR or other rulemakings, they should re-submit those comments here with an appropriate explanation as to how the commenter believes those comments relate to issues raised in this proposal. We can imagine a party trying to make out a challenge to this endangerment finding based on arguments that were raised entirely or primarily in comments submitted in response to the ANPR, not this proposal (a prospect that is somewhat more likely due to the fact that EPA in various places discusses comments made in response to the ANPR).

Agricultural Production

The proposed Finding erroneously suggests that Intergovernmental Panel on Climate Change (IPCC) predicts an increase in both crop and forest production in the U.S. (e.g., pg. 28 lines 21 and 34 of the Proposed Finding, pg 80 line 26, page 87 line 9). The IPCC findings refer to North America, not the U.S.

The Synthesis and Assessment Product 4.3 (SAP 4.3) "The Effects of Climate Change on Agriculture, Land Resources, Water Resources, and Biodiversity in the United States" (U.S. Climate Change Science Program/Backlund et al. 2008), which includes more recent and more geographically-specific publications, tempered IPCC's findings substantially, citing water limitations, northward progression of production zones, diminished grain set period, pest infestations, nutrient limitations, air pollution, and wildfire, among other dampening factors to production in agriculture and forestry in the

U.S. Significant increases in production may be possible within North America as a whole, but are unlikely within the U.S. itself.

The Findings document should be corrected to reflect that IPCC is referring to North America rather than the U.S. More importantly, the Findings document should be revised to accurately reflect the discussion in the Technical Support Document (TSD).

In addition, the placement of the IPCC prediction near the beginning of each section in the absence of any summarization gives the impression that large production increases are conclusive. This overrides the very salient and far more equivocal discussion which follows, leaving readers with the mistaken impression that climate change is a boon to U.S. agriculture and forestry. A summary statement which more accurately reflects the content of the technical discussions should be composed to lead each section.

Emissions from the combustion of different fuels vs. emissions from different mobile source categories.

Mobile source CO₂ is formed by burning fossil fuels. Virtually all of the carbon in the fuel is converted to CO₂. Therefore, and considering that CO₂ remains in the atmosphere for a long time, national aggregate consumption of different types of fuels provides the most accurate basis for estimating CO₂ emissions.

IPCC guidelines for national reporting of GHG emissions account for this fact, and EIA and EPA both use fuel consumption—not vehicle sales and fuel economy—as a basis for estimating and reporting CO₂ emissions. According to the IPCC (emphasis added), “Emissions of CO₂ are best calculated on the basis of the amount and type of fuel combusted (**taken to be equal to the fuel sold**, see section 3.2.1.3) and its carbon content.”²

Such reporting addresses petroleum consumption in the aggregate and for different petroleum-based fuels, such as shown below from EIA (<http://www.eia.doe.gov/oiaf/1605/ggrpt/carbon.html>):

General Editorial issues

“New Motor Vehicle or Motor Engine” Reference. The draft sometimes simply refers to emissions from “motor vehicles” rather than emissions from “new motor vehicles or motor vehicle engines.” (The draft could indicate initially that the term “motor vehicle” is intended to refer to both of these.)

Statements regarding consideration of current and near-term emissions [page 35], and cumulative emissions [page 17] appear to be inconsistent, and should be clarified.

EPA clearly intends that the definition of the “air pollutant” emitted by new motor vehicle or motor engine sources to be the six GHGs. In several places, however, the proposal appears to describe the four GHGs emitted by new motor vehicles or motor vehicle engines as the “air pollutant.” See, e.g., pages 1 (lines 36-37), 2 (lines 24-27), and 36 (lines 34-37).






Dear Mr. Stanislaus:

This letter is in regard to our discussions on the potential release of information collected by the Environmental Protection Agency (EPA) on surface impoundments which receive liquid-borne materials for the storage and disposal of coal combusted residuals generated at electric power generation facilities (Coal Ash Ponds). You advised us that the EPA collected this information under authority granted to it by the Comprehensive Environmental Response Compensation, and Liability Act (CERCLA). This effort followed the failure of a Coal Ash Pond at the Tennessee Valley Authority's Kingston facility, and your concern about similar incidents.

While you addressed your letter to me in my capacity as Acting Deputy Assistant Administrator for Mitigation, Federal Emergency Management Agency (FEMA), and in my position as Acting Chair, National Dam Safety Review Board (Board), this letter responds only on behalf of FEMA. The Board's role is to advise the FEMA Administrator on specific aspects of the program. *See*, 33 U.S.C. 467f (f) (5).

The EPA's release of the necessary information for risk communication purposes related to coal ash pond structures complements the responsibilities of the National Dam Safety Program and FEMA's responsibility to prepare, protect, respond, recover, and mitigate, in order to reduce the loss of life and property. In fact, notification of this information to local responders and the communities where these dams are located can be useful in informing the local public of any potential risk. FEMA encourages and supports the release of information on potential dam risks, including those with Coal Ash Pond residuals. However, the EPA will have to make its own determination regarding its obligations under CERCLA, or any other law, that may affect the EPA's release of this information.

The National Dam Safety Act outlines the functions of the National Dam Safety Program. The Program provides technical assistance. "The technical assistance activity shall consist of the transfer of knowledge and technical information among the Federal and non-Federal elements described in Paragraph 2, Section C, Public Awareness. The public awareness activity shall provide for the education of the public, including State and local officials, in the hazards of dam failure, methods of reducing the adverse consequences of dam failure, and related matters." *See*, 33 U.S.C. 467f (d) (3).

The hazard potential classification system employed by the National Dam Safety Program is meant to represent the potential consequences associated with the failure of a dam or water-retaining


structure. Dams associated with a high hazard potential classification are those where failure or mis-operation would probably cause loss of human life, but is not a reflection on the stability of the dam or the characteristics of the impounded materials.

FEMA supports risk communication efforts that provide the public, communities, local/state governments, and federal agencies with necessary information regarding potential dam safety hazards. Further, FEMA consulted with the Department of Homeland Security's Office of Infrastructure Protection, Dams Sector Specific Agency on this issue. In this particular instance involving coal ash structures, the Department of Homeland Security has no objections to the release of the specific data – either collectively or individually – collected under your CERCLA 104(e) letter.

The current protocol for release of information within the National Inventory of Dams is to provide maximum public accessibility for non-sensitive data via a web-based portal. The Board remains concerned about the release of aggregated sensitive dam safety data fields in an uncontrolled or unrestricted manner, such as hazard potential classification, the nearest downstream town, and distance to the nearest downstream town. In light of the issues you have highlighted, and the National Dam Safety Program's practice to reexamine the protocols for both communicating and safeguarding dam data as new security threat information is made available, I intend to ask the Board to review its advice regarding these data elements for our future use in responding to similar requests.








