

ORDINANCE NO. 57-2001

**AN ORDINANCE AUTHORIZING THE GRANT TO THE WATER WORKS
AND SANITARY SEWER BOARD OF THE CITY OF MONTGOMERY OF
A FRANCHISE FOR THE OPERATION OF A WATER SYSTEM AND THE
EXECUTION OF AN AGREEMENT MEMORIALIZING SUCH GRANT**

WHEREAS, the City Council (the "Council") of the City of Montgomery, Alabama (the "City") has by Ordinance No. 30-96 (the "Prior Ordinance") heretofore granted to The Water Works and Sanitary Sewer Board of the City of Montgomery (the "Board") a franchise to maintain and operate a water system (as defined in Section 11-50-310 of the Code of Alabama of 1975, as amended, the "Water System"); and

WHEREAS, the Council desires to grant a new franchise for operation and maintenance of the Water System and to authorize the execution of a franchise agreement with respect to the Water System.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MONTGOMERY, ALABAMA:

1. The Mayor is authorized and directed to execute, acknowledge, and deliver the Water System Franchise Agreement presented at this meeting and attached hereto as Exhibit A, and any other documents necessary or convenient to effect the intent thereof. The City Clerk is hereby authorized to attest the Agreement and any other document where attestation is required.

2. This Ordinance shall be published in full once a week for three consecutive weeks in the Montgomery Advertiser, a newspaper published in the City. This Ordinance and the Water System Franchise Agreement shall take effect thirty days after the final enactment and publication of the Ordinance and at such time the franchise presently held by the Board is terminated.

3. At such time as the Water System Franchise Agreement becomes effective, the Prior Ordinance is hereby repealed in its entirety.

WATER SYSTEM FRANCHISE AGREEMENT

THIS AGREEMENT, [the "Agreement"] between the City of Montgomery ["City"], a municipal corporation of the State of Alabama, and The Water Works and Sanitary Sewer Board of the City of Montgomery ["Board"], a public corporation of the State of Alabama;

W I T N E S S E T H:

WHEREAS, the City has heretofore granted to the Board a franchise to maintain and operate a water system (as defined in Section 11-50-310 of the Code of Alabama of 1975, as amended, the "Water System") which franchise expires in 2026; and,

WHEREAS, the Board desires to issue bonds, some of which will mature after the present water franchise expires and therefore desires a new franchise for a period of thirty years from the present time and will surrender its existing franchise upon the granting of a new franchise.

NOW, THEREFORE, in consideration of the premises and of the mutual agreements hereinafter expressed, the City and the Board do hereby agree with each other as follows:

Section 1: The City hereby grants to the Board the right, privilege, authority and franchise to acquire, construct, reconstruct, enlarge, extend, repair, maintain and operate a Water System within the City suitable to provide a supply of water to the City and its inhabitants for a period of thirty years from the effective date of this Agreement as hereinafter provided.

Section 2: The City hereby grants to the Board the right, privilege, authority and

franchise to maintain and operate during such period in any of the streets, public highways, thoroughfares or public property of the City and during such period, to enlarge, extend, reconstruct and repair any water mains, valves, meters, fire hydrants, manholes, equipment, apparatus, and other facilities necessary or appropriate for the maintenance and operation of such Water System. The City hereby grants its consent to the use of such streets, public highways, thoroughfares or public places for such purposes.

Section 3: The Board, in the maintenance, repair or extension of the Water System agrees that it shall not unnecessarily interrupt or obstruct the use of any street, public highway, thoroughfare or public property and, if practicable, before commencing any maintenance or repair or construction work of any kind, shall first notify and obtain the permission of the City and shall obtain such permit or permits as required by the ordinances of the City. If circumstances require immediate or emergency maintenance or repair such that prior notice is impracticable, then the Board may proceed with the maintenance or repair and shall notify the City as soon thereafter as it reasonably can do so. No permit from the City shall require the payment of any fee without express agreement between the City and the Board. When any street, public highway, thoroughfare, or public property is entered upon, or facilities removed therefrom, the Board agrees that it shall restore the same to its original condition to the satisfaction of the City and shall clear all such places of dirt, obstructions or anything that might constitute a nuisance or might prevent such street, public highway, thoroughfare or public property from being used for its normal purposes and in its normal condition. Such restoration to original condition shall be made by the Board under

the supervision and control of the proper agency of the City, which shall determine what part, if any, of such work shall be done by the City and charged to the Board.

Section 4: No franchise granted by this Agreement shall ever be leased, assigned, or otherwise alienated without the express consent of the City.

Section 5: As compensation to the City for the grant of any right, privilege, authority or franchise made by this Agreement, the Board shall pay to the City as compensation therefor, a fixed charge of \$12,000.00 per year and such fixed charge shall be payable in monthly installments of \$1000.00 each on the first day of each calendar month, which shall be an obligation of the Board, but failure to make this payment shall not result in forfeiture of the franchise. In addition to the fixed charge, the Board agrees to pay on a monthly basis to the City an amount equal to five percent (5%) of the gross water revenues derived by the Board from operation of its Water System within the municipal limits (at such time as such revenues are received) of the City, but failure to make this payment shall not result in forfeiture of the franchise.

Section 6: This Agreement shall become effective 30 days after the final enactment and publication of the Ordinance adopted to authorize execution of this Agreement by the City.

**AN ORDINANCE AUTHORIZING THE GRANT TO THE WATER WORKS

EXECUTION OF AN AGREEMENT MEMORIALIZING SUCH GRANT**

WHEREAS, the City Council (the "Council") of the City of Montgomery, Alabama (the "City") has by Ordinance No. 31-96 (the "Prior Ordinance") heretofore granted to The Water Works and Sanitary Sewer Board of the City of Montgomery (the "Board") a franchise to maintain and operate a sewer system (as defined in Section 11-50-310 of the Code of Alabama of 1975, as amended, the "Sewer System"); and

WHEREAS, the Council desires to grant a new franchise for operation and maintenance of the Sewer System and to authorize the execution of a franchise agreement with respect to the Sewer System.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MONTGOMERY, ALABAMA:

1. The Mayor is authorized and directed to execute, acknowledge, and deliver the System Franchise Agreement presented at this meeting and attached hereto as Exhibit A, and any other documents necessary or convenient to effect the intent thereof. The City Clerk is hereby authorized to attest the Agreement and any other document where attestation is required.



SEWER SYSTEM FRANCHISE AGREEMENT

THIS AGREEMENT [the "Agreement"] between the City of Montgomery ["City"], a municipal corporation of the State of Alabama, and The Water Works and Sanitary Sewer Board of the City of Montgomery ["Board"], a public corporation of the State of Alabama;

W I T N E S S E T H:

WHEREAS, the City has heretofore granted to the Board a franchise to maintain and operate a sewer system (as defined in Section 11-50-310 of the Code of Alabama, as amended, the "Sewer System") which franchise expires in 2026; and

WHEREAS, the Board desires to issue bonds, some of which will mature after the present sewer franchise expires and therefore desires a new franchise for a period of thirty years from the present time and will surrender its existing franchise upon the granting of a new franchise.

NOW, THEREFORE, in consideration of the premises and of the mutual agreements hereinafter expressed, the City and the Board do hereby agree with each other as follows:

Section 1: The City hereby grants to the Board the right, privilege, authority and franchise to acquire, construct, reconstruct, enlarge, extend, repair, maintain and operate a Sewer System suitable to collect and dispose of sewage in the City for a period of thirty years from the effective date of this Agreement as hereinafter provided.

Section 2: The City hereby grants to the Board the right, privilege, authority and franchise to maintain and operate during such period in any of the street, public highways,

thoroughfares or public property of the City and during such period, to enlarge, extend, reconstruct and repair any sewer mains, laterals sewers, manholes, equipment, apparatus and other facilities necessary or appropriate for the maintenance and operation of such Sewer System. The City hereby grants its consent to the use of such streets, public highways, thoroughfares or public places for such purposes.

Section 3: The Board, in the maintenance, repair or extension of the Sewer System agrees that it shall not unnecessarily interrupt or obstruct the use of any street, public highway, thoroughfare or public property and, if practicable, before commencing any maintenance or repair or construction work of any kind, shall first notify and obtain permission of the City and shall obtain such permit or permits as required by the ordinances of the City. If circumstances require immediate or emergency maintenance or repair such that prior notice is impracticable, then the Board may proceed with the maintenance or repair and shall notify the City as soon thereafter as it reasonably can do so. No permit from the City shall require the payment of any fee without express agreement between the City and the Board. When any street, public highway, thoroughfare, or public property is entered upon, or facilities removed therefrom, the Board agrees that it shall restore the same to its original condition to the satisfaction of the City and shall clear all such places of dirt, obstructions or anything that might constitute a nuisance or might prevent such street, public highway, thoroughfare or public property from being used for its normal purposes and in its normal condition. Such restoration to original condition shall be made by the Board under

the supervision and control of the proper agency of the City, which shall determine what part, if any, of such work shall be done by the City and charged to the Board.

Section 4: No franchise granted by this Agreement shall ever be leased, assigned, or otherwise alienated without the express consent of the City.


Section 5: As compensation to the City for the grant of any right, privilege, authority or franchise made by this Agreement, the Board shall pay to the City as compensation therefor, a fixed charge of \$1,200.00 per year and such fixed charge shall be payable in monthly installments of \$100.00 each on the first day of each calendar month, which shall be an obligation of the Board, but failure to make this payment shall not result in forfeiture of the franchise.

Section 6: This Agreement shall become effective 30 days after the final enactment and publication of the Ordinance adopted to authorize execution of this Agreement by the City.







The undersigned, N. J. Bell, 3rd, John S. Hodgeson, and Rush Stallings, each of whom is over the age of twenty-one years and each of whom is a qualified elector of and property owner in the City of Montgomery in said County, desiring to organize a body corporate under the laws of Alabama and particularly under Title 37, Sections 394 to 402, inclusive, of the Code of Alabama of 1940, as amended, and being all of the incorporators of the corporation hereby organized, do make, sign and file this certificate of incorporation as follows:

(1) The name of the corporation is and shall be
THE WATER WORKS BOARD OF THE CITY OF MONTGOMERY.

(2) The location of the principal office of the corporation shall be in the City of Montgomery in the State of Alabama, and the post office address of the corporation shall be Montgomery, Alabama.

(3) The period for the duration of the corporation shall be perpetual, unless sooner dissolved by operation of the aforesaid sections of said code.

(4) The corporate powers shall be exercised by a board of directors, which shall consist of three members, which shall be the maximum and minimum number thereof. The members of the board of directors shall be elected by the governing body of the City of Montgomery, Alabama. None of the members of the said board of directors shall be an officer of said City. The members of the

board of directors shall be elected in the manner and hold office for the terms as provided by law.

(5) The objects for which the corporation is formed are to acquire, construct, operate, maintain, improve and extend a water works plant or plants and system or systems and any part or parts thereof in the City of Montgomery, Alabama, and in the territory surrounding said City. In furtherance of the said objects, the corporation shall have all powers conferred on corporations of like nature by the aforesaid sections of said code under which the corporation is organized and any amendments thereof, and all other powers conferred upon corporations generally by the laws of Alabama.

The Water Works Board of the City of Montgomery, a
body corporate organized and existing pursuant to Sections 394
to 402, inclusive, of Title 37 of the Code of Alabama of 1940,
as amended, by and through the Chairman of its Board of
Directors and by its Secretary DO HEREBY CERTIFY as follows:

(1) On July 14th, 1952, the Board of Directors of the
Water Works Board of the City of Montgomery duly adopted the
following resolution:

"WHEREAS The Water Works Board of the City of
Montgomery is a corporation which was organized pursuant
to Sections 394 to 402, inclusive, of Title 37 of the
Code of Alabama of 1940, as amended, and the Board of
Directors of the Water Works Board of the City of
Montgomery desire to amend the Certificate of Incorporation
of such corporation, pursuant to and in accordance with
Act No. 175 of the Acts of 1951 of Alabama, approved
June 29, 1951, so as to provide for the operation of a
sewer system in addition to the water works system for
the operation of which the corporation was originally
organized, and, at the same time, change the name of the
corporation as hereinafter provided; NOW, THEREFORE,

BE IT RESOLVED by the Board of Directors of The
Water Works Board of the City of Montgomery as follows:

(1) Paragraphs (1) and (5) of the Certificate
of Incorporation of The Water Works Board of the City of
Montgomery are hereby amended to read as follows:

"(1) The name of the corporation is and shall
be THE WATER WORKS AND SANITARY SEWER BOARD OF THE CITY OF
MONTGOMERY."

"(5) The objects for which the corporation
is formed are (a) to acquire, construct, operate, maintain,
improve and extend a water works plant or plants and system

or systems and any part or parts thereof in the City of Montgomery, Alabama, and in the territory surrounding said City, and (b) to acquire, construct, operate and maintain, improve and extend a sanitary sewer system, including mains, laterals, sewage disposal plants or sewage treatment plants, and all appurtenances to such system and all property used or useful in connection therewith, including franchises, either within or without or partly within or partly without the limits of the City of Montgomery. In furtherance of the said objects, the corporation shall have all powers conferred on corporations of like nature by the aforesaid sections of said Code under which the corporation is organized and any amendments thereof, and all other powers conferred upon corporations generally by the laws of Alabama."

(2) The Board of Commissioners of the City of Montgomery is hereby requested to consent to such proposed amendments.

(3) In the event that the Board of Commissioners of the City of Montgomery shall consent to such amendments, the Chairman and Secretary of the Board of Directors of such corporation are hereby directed to file in the office of the Judge of Probate of the County of Montgomery a certificate in the name of and on behalf of the corporation, under its seal, reciting the adoption of the respective resolutions by the Board of Directors of said corporation and by the Board of Commissioners of the City of Montgomery, and setting forth said proposed amendments.

(4) The Secretary is hereby directed to present to the Board of Commissioners of the City of Montgomery a certified copy of this resolution."

(2) On July 15th, 1952, the Board of Commissioners of the City of Montgomery duly adopted the following resolution:

"WHEREAS, The Board of Directors of The Water Works Board of the City of Montgomery desires to amend paragraphs (1) and (5) of its Certificate of Incorporation so that they shall read as follows:

"(1) The name of the corporation is and shall be THE WATER WORKS AND SANITARY SEWER BOARD OF THE CITY OF MONTGOMERY."

"(5) The objects for which the corporation is formed are (a) to acquire, construct, operate, maintain, improve and extend a water works plant or plants and system or systems and any part or parts thereof in the City of Montgomery, Alabama, and in the territory surrounding said City, and (b) to acquire, construct, operate and maintain, improve, and extend a sanitary sewer system, including mains,

laterals, sewage disposal plants or sewage treatment plants, and all appurtenances to such system and all property used or useful in connection therewith, including franchises, either within or without or partly within or partly without the limits of the City of Montgomery. In furtherance of the said objects, the corporation shall have all powers conferred on corporations of like nature by the aforesaid sections of said Code under which the corporation is organized and any amendments thereof, and all other powers conferred upon corporations generally by the laws of Alabama."

WHEREAS, said Board of Directors has requested the Board of Commissioners of the City of Montgomery to consent to such proposed amendments pursuant to and as provided in Act No. 175 of the Acts of 1951 of Alabama, approved June 29, 1951, and the Board of Commissioners desires to give such consent; NOW, THEREFORE,

BE IT RESOLVED by the Board of Commissioners of the City of Montgomery that such board do and it hereby does consent to such proposed amendments to the Certificate of Incorporation of The Water Works Board of the City of Montgomery."

(3) By reason of the adoption of said resolutions the Certificate of Incorporation of The Water Works Board of the City of Montgomery which was filed in the office of the Judge of Probate in and for Montgomery County on October 4, 1949 and is recorded in Book No. 20 of Corporations at page 383, has been amended so that paragraphs (1) and (5) of such Certificate of Incorporation read as follows:

"(1) The name of the corporation is and shall be THE WATER WORKS AND SANITARY SEWER BOARD OF THE CITY OF MONTGOMERY."

"(5) The objects for which the corporation is formed are (a) to acquire, construct, operate, maintain, improve and extend a water works plant or plants and system or systems and any part or parts thereof in the City of Montgomery, Alabama, and in the territory surrounding said City, and (b) to acquire, construct, operate and maintain, improve and extend a sanitary sewer system, including mains, laterals, sewage disposal plants or sewage treatment plants, and all appurtenances to such system and all property used

or useful in connection therewith, including franchises, either within or without or partly within or partly without the limits of the City of Montgomery. In furtherance of the said objects, the corporation shall have all powers conferred on corporations of like nature by the aforesaid sections of said Code under which the corporation is organized and any amendments thereof, and all other powers conferred upon corporations generally by the laws of Alabama.
