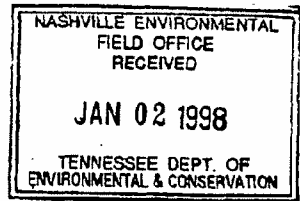

## Dickson County Landfill Dye Trace - Work Plan

In March 1997, trichloroethylene (TCE) was detected in water from a production well (Dk-21) operated by the City of Dickson. Although the source of the contamination has not been documented, well Dk-21 is located near the Dickson County landfill. Results of previous investigations conducted during summer and fall conditions when well Dk-21 was not in use indicate that the well is upgradient from the landfill, and migration of contaminants from the landfill to the well is unlikely. However, when well Dk-21 is used as a water supply (December to April), there may be as much as 40 feet of drawdown in the well, possibly causing a change in the direction of the gradient between the landfill and the well. A dye trace study conducted during the winter and spring months while well Dk-21 is pumping might help evaluate if the landfill is a possible source of the contaminants.

The dye trace study will be conducted in two phases: a background phase and a dye-detection phase. During the background phase (beginning 12/02/97), cotton and charcoal dye detectors will be placed at specific sites in the Dickson County landfill area (table 1 and fig. 1). The dye detectors will be collected and replaced weekly. Collected dye detectors will be analyzed for dyes which may already be present in the ground-water and surface-water systems in the area of the landfill. This part of the study will aid the USGS in choosing specific dyes to inject at the beginning of the dye-detection phase. At the beginning of the dye-detection phase (planned for 1/06/98), a different dye will be injected at each of three points at the Dickson County landfill (table 1 and fig. 1). Unless background analyses dictate otherwise, fluorescein, rhodamine-wt, and optical brightener will be used. Dye detectors will be collected frequently and analyzed for the injected dyes.

Retrieval and replacement of dye detectors will continue for a span of approximately three to four months after the injections. During the first month, the detectors will tentatively be collected and replaced 1, 3, 6, 10, 14, 20, and 30 days after the dye injections. During the next two to three months, detectors will be collected and replaced weekly to bi-weekly.

Near the end of proposed retrieval period, the USGS would like to meet with the City Water Committee, Dickson County Solid Waste Authority, and the Tennessee Division of Solid Waste to present data, discuss the results, and enable a decision to be made as to whether further pumping of well Dk-21 and retrieval time is necessary. In the event that no dye is detected at well Dk-21, it may be possible to estimate the time needed for an extension based upon the occurrence of dye at other locations. In the event that one or more dyes have been detected at several places, it may be advisable to extend the time of pumping and retrieval. Following the completion of the dye trace, a final report will be prepared describing the results of the investigation.
