The purpose of this letter is to notify Honeywell International, Inc. that the U.S. Environmental Protection Agency is approving its February 11, 2013 revision of Remedial Investigation Report for the Uplands, Operable Unit Three (OU 3), for the LCP Chemicals Superfund Site. In addition, the EPA directs Honeywell International, Inc. to proceed with development of a draft of Task 6 (Development and Screening of Remedial Action Alternatives) of the Feasibility Study (FS), in a manner that is generally consistent with the description detailed in the Scope of Work (SOW), Attached to the Administrative Order by Consent for Remedial Investigation/Feasibility Study, EPA Docket No. 95-17-C (AOC). Please submit the draft of the Task 6 Technical Memorandum of the FS within forty five (45) days of receipt of this letter. Task 7 (Detailed Analysis of Remedial Action Alternatives) will be undertaken after Task 6 of the FS is approved by the EPA.
