Syngenta Crop Protection, Inc. is submitting a new petition for use of difenoconazole, (Inspire) on strawberry, carrot, chickpeas, soybean and stone fruit, group 12. Difenoconazole is registered for foliar uses for several crops, Inspire Fungicide (EPA reg. No. 100-1262).

In addition to adding these new uses to Inspire Fungicide (difenoconazole solo), Syngenta is requesting that several of these new uses to be added to the label of other mixture products containing difenoconazole. These products are as follow:

- Inspire XT (EPA Reg. No. 100-1312), mixture of difenoconazole and propiconaozle. The requested new uses are registered for propiconaozle and are on the Tilt label (EPA Reg. No. 100-617)
- 2) Quadris Top (EPA Reg. No. 100-1313), mixture of difenoconazole and azoxystrobin. The requested new uses are registered for azoxystrobin and are on the Abound Flowable label (EPA Reg. No. 100-1098).
- Inspire Super (EPA Reg. No. 100-1317), mixture of difenoconazole and cyprodinil. The requested new uses are registered for cyprodinil and are on the Vangard WG label (EPA Reg. No. 100-828).

## Minor Use Exclusive Use Qualification

"Under FIFRA § 3 (c)(1)(F)(vi), Syngenta respectfully requests EPA to allow exclusive use protection of the data submitted in support of the minor use registrations contained in this application for the period of 10 years from the date of submission. The exclusive use period for the pesticide difenoconazole has expired and the data pertaining to the minor use registration is eligible under FIFRA § 3 (c)(I)(F)(vi). Specifically, Syngenta considers the following minor use crops to qualify under this Section: Apricot, Cherries, sweet; Cherries, tart; Nectarine, Peach, Plum, Plumcot, Prune, Strawberry, Chickpea and Carrot.

Under the provisions of this paragraph, Syngenta certifies, to the best of our knowledge that the exclusive use period for difenoconazole has expired. The original registration of difenoconazole was August 4, 1994, which is more than 10 years ago.

The following representative crop data pertaining solely to the above minor uses are eligible for the provisions of this paragraph:

- Magnitude of the Residue in or on Cherry (sweet and tart), Plum and Peach; Fruit, Stone, Group 12 (Study No. T002402-07)
- Magnitude of the Residue in or on Carrot (Study No. T002431-07)
- Magnitude of Residue in or on Chickpeas (Study No. T004254-07)
- Magnitude of Residue on Strawberry (Study No. T0002401-07)
- Magnitude of Residue on Soybeans (Study No. T002400-07)

Syngenta has taken the following extra measures to facilitate the review and registration of these new uses for difenoconazole:

 The accompanying data is being submitted using the current EPA guidance for full electronic data submission.

## Fees for Services:

In compliance with the Pesticide Registration Improvement Act (PRIA), Syngenta will pay the required pesticide registration fee for this action. Syngenta believes that this submission fits the following registration fee category: R170/21 (Additional food use), \$57,120 for each of the (5) crops.
