

Urban Waters Partnership Meeting Minutes June 5, 2013 1:30 - 4:00 p.m. The Daniels Fund Building, 101 Monroe St. Denver, CO

Mission: The South Platte River Urban Waters Partnership collaborates across jurisdictions and disciplines to engage communities, and to protect and restore the South Platte River and Watershed.

Welcome and Introductions:

There were many new attendees, including Englewood, Jefferson County, Commerce City, Douglas County, Lakewood, Tri-County Health, and Zeppelin Development. Welcome to all of our new partners!

Acknowledging the large number of new participants in the room, Devon Buckels gave an overview of the Partnership, including mission and goals. (PowerPoint slides posted on Urban Waters Google Docs site)

Whole Group Exercise:

Each partner introduced themselves by name and organization, and answered the questions "Why are you here? What is the catalyst for regional collaboration?" Responses to this exercise are attached at the end of this meeting summary.

Devon and Chris spoke about the unique opportunity through the CDC Foundation for the Urban Waters Partnership to obtain funding for collaborative, public health-related projects. We are most interested in developing projects that are cross-jurisdictional with multiple partners. The CDC Foundation grants represent an unusual opportunity since the CDC is one of the federal partners supporting the Urban Waters initiative, and because the nature of the funding is flexible. We would like to forward several projects for consideration.

<u>Work Session -- Brainstorming a potential cross-jurisdictional project(s) for CDC Foundation</u> <u>funding:</u> (Stephanie Vuong with EPA's facilitation network co-facilitator)

The group brainstormed ideas for projects that could be funded through the CDC Foundation, identifying general concept and potential partners. Ideas were posted and grouped into potential packages. Several Partners signed up for further conversations on some of the project ideas.

All ideas generated in today's meeting will be posted on a shared site, a Google Docs or Drop Box, so Partners can access the list to add more detail to these ideas and/or add new ideas, and we'll let you

know when that site is available. After allowing a couple of weeks for edits to the list, we'll create workgroups around the project ideas. Workgroups can meet with Devon and Chris P. to create project concepts to be submitted to the CDC Foundation for initial feedback and subsequent submittal for funding.

Work Group Updates:

Funding. (Marge Price) This group met May 9th. The group agreed environmental protection and water quality as key elements for the Partnership, but we need to include economic development and public/private partnerships as well. It was suggested that we invite new partners to be involved in the workgroup including those who know transit so we can draw on their expertise regarding development along transit corridors.

Geomapping. (Stacey Eriksen) The group has met once. Mapping is going well and a draft tool will be available to look over in the next month. Partners will be asked to give feedback on the tool including missing/incorrect information, and to add new project information. We are planning to schedule two webinars for the Partners in late July for a demo. Partners will be asked to sign commitments to update their information on the geomapping tool approximately quarterly. The tool includes geographic data, project data, organization and event/news information.

Systems Mapping. (Kaitlin Fischer) The group met once and is exploring the possibility of funding for a contractor. CDPHE may have funding of \$25,000 for this effort. If this happens it will be a fast-track project and partners will need to help out by responding to the contractor's requests quickly.

Water Quality and Data Gaps. (Don Moore) Jon Novick put together a survey document which was sent out to all of the UWPartners to complete (Partners were encouraged to complete the survey by Tuesday June 18th) The purpose of the survey is to find out what data is out there and what data we are missing. Once the responses are compiled we can look for data gaps.

Headwaters-Urban Connection. (Boyd Byelich) The group met once and felt that the systems mapping is important to identify partnership synergies and gaps. The group would like to share events and opportunities, and post this information somewhere. The group will coordinate with the Children's Forest Corridor project which is already established. This workgroup raised the idea of combining with the Education and Outreach Workgroup. It seems the Education and Outreach Workgroup came to the same conclusion separately and that this might work.

Education and Outreach Workgroup. (Donny Roush) This group may want to change its name to "Education and Engagement Workgroup." They met once to discuss activities. They would like to merge with the Headwaters-Urban Connection workgroup.

Devon asked the Workgroup leads to set another meeting before the next quarterly meeting of the South Platte Pilot in September 2013. Devon will set the next Funding group meeting. We will need a new lead for the Systems Mapping group in September (We will miss you Kaitlin!)

The day will start at the Deckers Conference Center, and then we'll visit some CUSP projects while we learn about forest health, source water protection, and other headwaters area issues.
