Funding Opportunities

U.S. Forest Service Community Forestry Program Grants

Due: January 15, 2014

The Community Forest Program is a grant program that authorizes the U.S. Forest Service to provide financial assistance to local governments, Tribal governments, and qualified nonprofit entities to establish community forests that provide continuing and accessible community benefits. Requests up to \$400,000 can be made; the match rate is 50% (1:1).

Five Star & Urban Waters Restoration Program 2014

Due: February 5, 2014

The grant program seeks to develop community capacity to sustain local natural resources for future generations. It provides \$5,000-\$20,000 to diverse local partnerships for wetland, forest, riparian and coastal habitat restoration, stormwater management, outreach and stewardship with a particular focus on water quality, watersheds and the habitats they support. Also in this RFP, the U.S. EPA makes funding available through its Five Star Program for on-the-ground restoration projects including wetland, riparian, in stream and/or coastal habitat restoration.

Sustain Our Great Lakes

Pre-proposals Due: February 18, 2014

In 2014, grant funding for work in the Great Lakes basin will be awarded in two categories:

-Habitat Restoration -Delisting of Habitat-Related Beneficial Use Impairments

Eligible applicants include nonprofit organizations, educational institutions, and state, tribal and local governments. Details on this funding opportunity will likely be

announced on January 6th, 2014.
