





You can't see, smell, or taste radon, but it could be present at a dangerous level in your home. Radon is the leading cause of lung cancer deaths among nonsmokers in America. Radon claims the lives of about 20,000 Americans each year, but exposure to radon is a preventable [health risk](#). If a high radon level is detected in your home, you can take steps to fix the problem to protect yourself and your family. Test your home and protect your health during National Radon Action Month.

Roy Russell, vice president of strategic planning and marketing for Centex's Florida division, adds that developing a multifamily site that might have only 1.5 acres, with per-acre densities of 30 to 35 units, ranges from 40 to 50 feet wide, requires "talented architects and a keen understanding of consumer preferences for optimizing the smaller space."

Two factors determine density, say

builders: market demand and municipal regulation. Each presents challenges, although the first is proving to be a lot easier for builders to deal with than the second. For example, Kaufman-Bunney has five different multifamily building schemes, including a "town," stacked-town product for buyers looking for an affordable alternative. Puffer says his company's plans are flexible enough that it

can alter its product mix depending on

market and local circumstances.

Kaufman-Bunney favors densities of seven to nine homes per acre, says Feldman. Other builders in more populous areas opt for more. "We try to get as high a density as we can," says Stock of Suresite, whose recent projects have between 15 and 20 units to the acre. Bunter thinks the broader acceptance of the traditional neighborhood development concept has softened some municipalities' resistance to attached housing. By city planners, in many markets will view "attached" sales in times of more traffic congestion and children. "We build attached in five markets, and two of them are Illinois, you know," he says. And a "town" is, now, on their radar screen, says Asaro of Corby McMinn. Ekerman of AllBrook design says that municipalities also regularly demand "upside" designs with lots of passive amenities, such as parks. "The key is to match the look, feel, and density of the project [with] surrounding zoning."

While municipalities' reticence negates perceptions about attached homes might be changing in builders' favor, it's still not a slam dunk. One of its most recent projects, the Villas at Glenview in Oak Brook, Ill., it took Epoca 21 months to get land it wanted, and second time around to attached residential, and now, then it ended up with a density of only 2.5 homes to the acre. But by October, when construction of the units and clubhouse was to percent complete, "people [were] saying that maybe it's not as bad as all that," says Heister. ■

REWORKING IT SIMPLIFIED: Epoca Command in Irvine is an attached-home project on a four-acre site for two to four units. It's a three-story, white and gray exterior that pairs modern, clean, and its Cathedral series, with styles called "The Abbey" and "The Cathedral" that include terraces, vaulted ceilings, and more modern interior design. The Villas at Glenview houses range from 1,500 to 2,100 square feet and from \$185,000 to \$300,000.





Radon in *Alabama* overview

- Extension has been a State Indoor Radon Grant sub-grantee since October 1997
- 22 Radon team members
- 15 Zone 1 counties with an average radon risk of 24%
- Our focus is to educate citizens about the radon health risk, encourage them to test their homes and mitigate if needed, and build new homes RRNC.
- Alabama is a non-regulatory state
 - 6 cities adopted the radon appendix in their building code
- We started working on National Radon Action Month outreach in 2003

Alabama's 2007 National Radon Action Month Results

- Outcomes attributable directly or indirectly to NRAM efforts
 - 11 local newspaper articles (180,505 potential readers)
 - 4 TV programs (396,000 potential viewers)
 - 5 radio programs (70,000 potential listeners)
 - 9 proclamations were obtained
- Results that are attributable directly or indirectly to NRAM efforts
 - **528 test kits were sold in January and February**
 - ✓ 381 test kits were used (72% usage rate of sales)
 - includes 64 prior-purchased kits were used
 - 97 (25%) tests were above the EPA action level
 - **24 homes were tested by certified testers**
 - ✓ 14 homes (58%) were above the EPA action level
 - **42 homes were mitigated in the January-March quarter**
 - **46 homes were reported built with radon-resistant new construction**

 - ✓ *Citizens Guide*
 - If possible, be at the proclamation signing
 - ✓ Schedule time on the agenda to make a presentation
 - Provide special “bag” to each government official
 - ✓ *Free test kit*
 - ✓ *Radon brochure*
 - ✓ *GIS radon zip code map of results*
 - ✓ *EPA Citizen's Guide to Radon*
 - ✓ *Marketing materials*

More tips for National Radon Action Month Success

- News media
 - Start early – target the January 1st edition
 - Personally meet with the reporter or editor
 - Provide them with a free test kit
 - Provide them with an EPA sample press release
 - ✓ Include where to get test kits
 - ✓ Include local contact numbers
 - ✓ Include radon risk figures for that area
 - ✓ Provide them with your radon web site
 - Provide them with the GIS zip code map for the area
- Plan for January programs now
 - Seek opportunities throughout the year
- Make test kits available at program presentations
 - Record serial number, date, name, address, location/event
- Code or date the coupons you distribute during this time

Alabama's Plan for the 2008 National Radon Action Month

- Proclamations
 - Try to obtain at least 2 per county (30 total, which is 3x last year's #)
 - Ask for time on the agenda to make a presentation
 - Provide “bags” with radon materials for government officials
- Programs
 - Radon Advisory Leadership Councils for two counties
 - Lunch and Learn seminars at local hospitals
 - Civic organizations
 - Partner with Libraries
 - Partner with schools and youth organizations
- Newspaper articles
- TV programs
- Radio programs and PSAs
- Partner with utility companies with radon message on billing statements


Radon in Colorado

Colorado's 2007 National Radon Action Month Results

- Distribute 30,000 pieces of literature/year
- Governor's NRAM Proclamation issued in January w/statewide press release
- Radon Hotline-1,600 phone calls/year
- 10,000 website hits/year
- 60+ articles about radon were published in the local media
- Estimating 95,000 people reached through outreach activities
- CDPHE distributed 1,500 free test kits to public (big learning experience!)
- 3,000 test kits distributed by locals
- 56% return rate
- 46% above 4 PCi/L
- 7,833 homes mitigated
- Working on builders survey to determine RRNC

- Focus public attention on radon issues
- Key activities
 - Press releases
 - Proclamation
 - Website postings
 - Attendance at public events (i.e., health fairs, community events, etc.)
- Resources
 - Public Relations staff
 - State Indoor Radon Grant Funds pre-allocated for NRAM
 - Get to know your mailroom staff! Suckup!
 - Work with other IAQ folks in your department (Asthma, Lead, etc.)
- Partnerships
 - Local Health Departments, Extension Offices, Measurement/Mitigation providers, Realtors, Environmental Health Assn's, Cancer Coalitions, etc.



Colorado's 2007 National Radon Action Month Results Tracking

- Learn to love EXCEL!
 - Track publications distributed, phone calls, etc., as you go, not after the fact
- Work with test kit companies, measurement/mitigation contractors to get results
 - Call them, get on a first name basis, they want to help you also (good PR for them!)
- Track results all year long, not just during NRAM, we need the info for EPA anyways....
- Come up with new methods for tracking difficult numbers (CBA, school inspectors, teachers, etc.)
- Pounding the media with information does make a difference, be persistent! (no cost to do press releases)
- Results are better than expected!

Colorado's Tips for National Radon Action Month Success

- Free test kits-our experience
 - Be careful how “well” you advertise
 - Be prepared for influx of phone calls
 - Have only one method for ordering
 - Work with test kit company to handle distribution and results
 - Have a press release announcing unavailability ready
 - Stress **LIMITED SUPPLY, ONE PER HOUSEHOLD**
- Use your PR folks in your department to their fullest ability
- Don't recreate the wheel (coupons, press releases, etc.)
- Preplan your time and funding needed for NRAM

Colorado's Preview for the 2008 National Radon Action Month

- 3,000 free test kits
- Governor's proclamation with more media attention
- Create NRAM brochure for distribution to local health departments, extension offices, libraries, birth certificate registry, etc. for state/local outreach
- Pounding the press releases
- Targeting local neighborhood publications (usually free!)

2007 National Radon Action Month Results

- **Since Jan. 2006 over 25,000 test kits - During Jan. 2007 2,256 test kits were distributed through our office, State Indoor Radon Grant grantees and other partners. Approximately 33% of the test kits released have been used since the inception of the free test kit program.**
- Results? Survey to test kit recipients-mitigation, post mitigation testing numbers. Difficult numbers to provide in outputs.
- Examples of activities generating test kit requests:
 - 400 at USEPA presentation about radon and testing at USEPA's Region V Chicago offices. A presentation along with an exhibit booth worked well. This would work well at any employee group such as hospitals, factories etc.
 - Release of the Illinois Status Report through our Public Information Officer created ensuing publication of radon in Illinois in the media.

Documents provided during January 2007

- Six thousand radon documents were distributed during January and the Radon Program received 825 calls.
 - Prompted by Illinois Status report release which was released in November when we gave out 6,697 documents and fielded 1,325 calls.
 - Requests resulted from an approved continuing education class to real estate agents, construction workshops offered by Department of Commerce and Economic Opportunity and Radon Networking Day where county health, non-profit and other groups come together to learn about radon and how to start their own programs.
 - Articles like those on the Illinois Association of Realtors Website & in the Women Council of Realtors newsletter.

2007 National Radon Action Month Activities & Tracking

- Being a regulatory state our mitigation and testing numbers are required. Access (which is a simple Microsoft Office program) tracks documents and kits. We tag kits per activity from our test kit coupons.
- Using November which is Lung Cancer Awareness month and December activities as a forerunner some will boil over as the Radon Month Activities. We use these months to launch new ideas. For example:
 - November- Women's Health Conference-launched brochure about women, radon and lung cancer opens doors to other presentations and health care providers.
 - December- This year at the Illinois Department on Aging we will present "radon-resistant homes for the elderly".
 - Some activities are not measured in numbers, but in connections such as the one listed above that came from an Alzheimer's conference where the true success was with the other vendors rather than the attendees.

Illinois Tips

- Double dip, write one article that can be used as a template for several.
- Use one presentation that can be adapted for several.
- Partner, meet your partner's need, let them share the message with the audience they know.
- Offer to present, do a poster session, or offer a continuing education class to the audience you are trying to reach.
- We are willing to share handouts, presentations, or anything that can assist other states.
- Work with laboratories providing test kits for tracking.

2008 National Radon Action Month for Illinois

The Illinois plan for 2008 is underway. We participated in calls planning with partners.

Activities-Test kits at USEPA, possibly mitigate a low income home, articles in trade and health industry publications, work with the real estate industry sharing information about our new Radon Awareness Act, offer presentations, teach courses, and honor the Illinois poster contest winners.

- We plan to double the number of real estate agents requesting information about radon and how it will affect their transactions in the next year.
