Mr. King,

From my perspective, there are two problems with the M6 propellant being shipped from Minden.

Propellant

stability and packaging configuration.

The first, propellant stability, needs to be checked for each container (?? or via a statistical sampling plan for each packaging configuration) of M6 prior to shipment of the M6 from Minden. With mixed lots and

loss of lot identify, lot integrity is basically lost. The propellant sampling plan recently sent to Minden could be used as the starting point for material being shipped out of Minden.

The second, packaging configuration, will have to be addressed since there are approximately 6 packaging

configurations of M6 at Minden. Those include: 100 lb. barrels, 120 lb. barrels, 121 lb. barrels, 140 lb. barrels, 60 lb. boxes, and 880 lb. bulk boxes. In order to ship these items, each will need a separate DOT

reference number letter (Competent Authority Authorization) requested by the State of Louisiana and/or their

contractor for transportation purposes. DOT has authorized DOD to issue Interim Hazardous Classifications

(IHCs) for shipment of DOD explosive assets. For an IHC to be issued from DOD to the State of Louisiana or

their commercial contractor, someone within DOD would need to authorize issue of such IHC by the DOD

community.
