- Broke out into small groups to discuss key recommendations to be included in the Interim Report and range of options to implement the recommendations
- Discussed and agreed on process to finalize the Interim Report and transmit to the Clean Air Act Advisory Committee

## **Process for Generating the Interim Report**

Goal: beginning with a draft outline of report in May, produce a finalized, 10-page report for transmittal in June

### May 8th meeting

- Work Group members commented and agreed to draft outline of report
- Full WG discussed two sections: observations and background
- Broke out into small groups to discuss other sections: key recommendations to and range of options to implement the recommendations
- Small groups selected a lead drafter, who would coordinate to produce a consensus one-pager on assigned topic
- One-pagers sent to Ben TY and Anna on May 16, first complete draft distributed to WG on May 18
