While the rule is not perfect from our perspective, the final rule is an improvement over the proposed rule. The final rule puts bright-line limits on jurisdiction over neighboring waters, offering farmers increased regulatory certainty and mitigating the risk of enforcement or litigation. The final rule also provides more clarity on which ditches fall under the Clean Water Act jurisdiction, removing a gray area that has caused farmers and ranchers an incredible amount of concern. We appreciate EPA's work on the regional water features, but remain concerned about waters that cannot impact the quality of jurisdictional waters will fall under jurisdiction, or that farmers will not have the regulatory certainty they need to address these waters appropriately.
