**Region 9's New Program Officer**. The Tribal Section welcomed a new project officer in June. Shannon Kissinger comes from the Department of Veterans Affairs in San Francisco, where he was a social worker for homeless veterans. The U.S. Navy veteran is a native San Franciscan and has both bachelor's and master's degrees from Humboldt State University. He will be working tribes in Sonoma and Mendocino counties, including Round Valley, Cahto (Laytonville), Sherwood Valley, Potter Valley, Redwood Valley, Coyote Valley, Guidiville and Pinoleville.



**Diesel Engine Upgrade Grants** (\$1 million): EPA is funding tribal clean-diesel projects that reduce air pollutants from diesel exhaust, such as nitrogen oxides and particulate matter. Up to five tribal assistance agreements will awarded, between \$30,000 and \$800,000 each. Projects can involve school buses, transit buses, heavy-duty diesel trucks, marine engines, locomotives, energy production generators and other diesel engines. This competition is part of the Diesel Emission Reduction (DERA) Program, which funds projects to retrofit or replace older diesel engines. Emergency Community Water Assistance Grants: The U.S. Department of Agriculture program helps eligible rural communities recover from or prepare for emergencies adversely affecting the supply of drinking water. Up to \$150,000 is available to repair breaks or leaks in water distribution lines, and to pay for related maintenance. Up to \$500,000 is available to construct a new water source, intake, and/or treatment facility or waterline extensions. A federal disaster declaration is not required.
