The safety of the public is our most important consideration. The U.S. Environmental Protection Agency (EPA) strongly believes that public engagement

better informs decisions — both for the EPA and for the community. The EPA remains committed to finding ways to increase the involvement of local officials and the community in the remedy as we move forward in addressing the cleanup actions at Camp Minden.

#### **Current Actions**

On August 13, 2015, The Louisiana Military Department (LMD) led an Environmental Workshop presenting details on the future Work Plan and Quality Assurance Sampling plan for the site. The LMD contractor, Explosive Service Intl., and its subcontractor El Dorado Engineering, gave a detailed description of the steps and timeline needed to complete the cleanup. Representatives from the EPA and Louisiana Department of Environmental Quality were available to discuss and answer questions from the community on the workplan and sampling plan. Citizens were advised that the destruction of the M6 and CBI will happen in 3 phases:

Phase 1- Mobilization and Site Preparation, will involve the startup tasks such as design and fabrication of equipment, training, facility construction, access roads preparation, and magazine assessment. This phase will end when the CBS system has been constructed and is ready for testing. Phase 1 will be complete by December 2015.

Phase 2: The first step of this phase is ramping up and testing of the system in January 2016. A major milestone is conducting the Comprehensive Performance Test (CPT) to document that the CBS unit will meet ARARs. That is a 30-day long test that is planned for February 2016. Removal and Destruction Operations will then be conducted. M6 and CBI will be removed from the magazines and destroyed in the Contained Burn System. Recyclable and reusable material will be properly profiled and disposed of or recycled accordingly. Phase 2 will be complete by November 2016. Phase 3: Site Restoration and Demobilization, will begin after all the M6 and CBI has been destroyed. ESI will remove all equipment and material mobilized, installed and utilized in the project. They will restore the operational areas in accordance with the requirements of the Military Department and, submit a Closeout Project Report. Phase 3 will be complete by January 2017.
