Dear Mr. Prasad:

Pursuant to conditions specified in a permit (see attached) issued by the City of Chicago, radiation monitoring was required to be performed at the above referenced site. AECOM Technical Services, Inc. (AECOM) was onsite between the days of July 18-19, 2012 for an investigation to fix a gas service line for the property located at 201 E. Ontario St. and 609 N. St. Clair St.

During the investigation, workers performed a variety of non-earth intrusive tests to determine the source of the gas leak. During this time, it was still unclear whether excavation work would need to be performed. Eventually, an air sample was collected within a vault where gas detection sensors originally indicated a potential leak. The sample was taken to a laboratory for analysis and on the following day (July 19, 2012), it was determined that the source of the gas was not from a leaking pipeline.

AECOM was informed that there are a variety of reasons a gas sensor within a vault could be triggered that are unrelated to a natural gas distribution network. For example, there is potential for methane gas to leak from a nearby sewer line as well as the potential for degrading organic debris to produce methane within a vault.

Since it was determined that the cause of the sensor being triggered was not from a leaking gas service line, it was not necessary to perform trench excavations around or in the vicinity of the vault. As a result, no radiation monitoring was required to be performed at this location. In any case, as part of the permit condition this letter has been forwarded to:
