Dear Mr. Prasad:

Pursuant to conditions specified in a permit (see attached) issued by the City of Chicago, radiation monitoring was required to be performed at the above referenced site. AECOM Technical Services, Inc. (AECOM) provided the required radiation surveillance completed on the day of July 16, 2012 for an excavation to install an anode on existing gas service piping.

Surveying was performed for the soil removed from a 2-foot by 3-foot excavation along the roadway of East Ohio Street (see sketch) to a depth of 3.5-feet below ground surface required for installation of an anode on existing gas service piping. The monitoring revealed no indication of soils above the specified clean-up value established by the U. S. Environmental Protection Agency (USEPA) for the Streeterville area of Chicago. The USEPA clean-up value for Chicago's Streeterville area is 7.1 picocuries per gram (pCi/g total radium (Ra-226 + Ra-228).

Gamma radiation count measurements for the project were made using Ludlum Model 2221 survey meter and an unshielded 2 x 2 inch Nal probe (Model 44-10). For the instrument used, the gamma count threshold equivalent to the 7.1 pCi/g clean-up value was 20,356 counts per minute (cpm) unshielded (7,567 cpm shielded). The field gamma background for the area was measured at approximately 6,600 cpm unshielded. The field gamma measurements within the excavation and of the spoil materials generated during the excavation process did not exceed the respective field instrument threshold values previously stated and ranged from a minimum of 7,100 cpm to a maximum of 8,100 cpm unshielded. Thus, there was no indication of the presence of radiologically-contaminated material and/or an exceedance of the USEPA cleanup value of 7.1 pCi/g total radium.

- All directional boring must be pre-approved by the Office of Underground Coordination. 3.
- Contractor must secure plating over all openings in the roadway and secure all 4. sidewalk/parkway openings during non-working hours until such time when the road surface is restored.
- Contractor must notify DIGGER at 312-744-7000 no less then 48 hours (exclusive of Saturdays, 5. Sundays and Holidays) but no more then 14 calendar days in advance of the start of the excavation or demolition, unless the excavation date was provided with the application and remains unchanged. Prior to 26 calendar days the Contractor must notify DIGGER to renewal the dig date!
- It is the Excavator's responsibility to request refreshing of marks when needed, but no longer 6. than 28 calendar days after the last requested date.
- When applicable, all excavation areas are to be clearly marked in safety white paint prior to 7. calling DIGGER. White paint is not required for joint meets or emergency work.
- Excavators requesting dig tickets are responsible for the protection of utility markings at the job 8. site. Any markings of underground utilities utilizing utility colors, must be done by facility owners or authorized agents only.
- Permittee must provide a sign which identifies the telephone number and company or person 9. performing the work. Signage may be affixed to barricades.
- 10. Permanent base pavement restoration to follow within 5 days after the completion of underground work.
- 11. All pavements and pavement markings are to be restored in accordance with CDOT Construction Standards.
- 12. Work to be performed as per plans and specifications.
- 13. Use of pneumatic equipment must not begin before 8:00 A.M. or continue after 8:00 P.M.
- 14. Maintain pedestrian traffic at all times.
- 15. Pavement opening to be backfilled to grade/or plated during off work hours.
- 16. Parkway excavation by hand, cut and replace sod wherever possible.
- 17. Permittee to provide all barricades, signs and/or flagmen as necessary.
- 18. Sidewalk pavement broken by hand or with pneumatic hammer only.
