# **WCIT Registration**

You will need a WCIT account to participate in the Training. Please follow the directions below to obtain an account.

## ALREADY HAVE A WCIT ACCOUNT

If you already have a WCIT account, log in before the meeting to make sure your password is up-to-date. If you forget your username, call the Central Data Exchange (CDX) Help Desk for help at 888-890-1995 or 970-494-5500 (from Puerto Rico and Guam).

### ALREADY HAVE A CDX ACCOUNT BUT NOT A WCIT ACCOUNT

If you already have an account on CDX, but don't have access to WCIT, log into your CDX account at <u>https://cdx.epa.gov</u>. From the MyCDX tab select the green button "Add Program Service." Choose WCIT from the alphabetical list. Select a role and press "Select Role Access." For details, read below.

### NEED TO REGISTER FOR BOTH CDX AND A WCIT ACCOUNT

If you do not already have a User Name and Password for EPA's Central Data Exchange, open a web browser and type the following into the address bar: <u>https://cdx.epa.gov/</u>.

On the right side of the page, you will see this box. Click on the green button that says "Register with CDX."

After reading the Terms and Conditions, select the radio next to "I Accept," and click on the green "Proceed" button.

Your cursor is already in the **Active Program Services List** search box. Type WCIT into the search bar. WCIT: Water Contaminant Information Tool will appear below the search bar. Click "WCIT" and you will be automatically taken to the Core CDX Registration Page.

Select the Role from the drop down list that best fits your organization: Association, Federal Employee, State Lab, State Primacy Agency, or Utility. Don't select Data Entry or Expert Review unless you have been previously told to do so.

Answer the three general contact questions that appear. WCIT is a secure database, your information will need to be verified before you are granted access. Answering these questions will expedite your approval. Click the green button, "Request Role Access."

#### Part 1: User Information

Enter a User ID. Your User ID must meet the requirements listed below.

#### Part 2: Organization Information

Enter the name of your organization in the box and click "Search." If your organization is on the list, click on its Organization ID to proceed to the next page. If your organization is not on the list, select "Use advanced search" or "Request that we add your organization." Either complete the advanced search form and click "Search" or complete the organization information and click "Submit Request for Access."

You will soon receive an email confirmation message at the email address you provided. Follow the link in the message to complete your registration. The link will take you to your "My CDX" page where you will see an hour glass symbol next to WCIT. This symbol means that your account is awaiting final approval. You will receive a follow up email notifying you of your approval.

The next screen asks you about your Organization Type, Utility Size, and job title. Fill in this information and click the blue "Save" button. This will take you to the Welcome page for WCIT.
