First the developer tests the release until satisfied it meets the requirements and specifications. Then it is tested by our independent contractor testers. Once they are satisfied, the software is placed in the RCRAInfo Pre-Production environment and a News Letter (e-mail via Listsery) is sent to all RCRAInfo Users announcing an open testing period for the issues in the upcoming release. The user community is given anywhere from 2 to 6 weeks, or more, to conduct their testing in Pre-Production.
