During this reporting period, EPA received 136 Individual standard permit public notices, performed a detailed review of 89%, and subsequently provided comment letters on 10% of them. EPA is not the only commenter on Corps public notices. Other federal and state agencies and the public routinely provide comments to the Corps. Of the new public notices in Section I, the Corps has issued 14 permits, 0 permit were denied, 8 applications were withdrawn, 108 are still being processed, and 1 was verified as General Permit.
