

## FY 2013 STATE CLEAN DIESEL GRANT PROGRAM FACT SHEET FOR EPA REGIONS AND PARTICIPATING STATES AND TERRITORIES

## **FY 2013 -SPECIFIC FUNDING HIGHLIGHTS**

DERA January 2011 Reauthorization changes to the FY 2012 DERA State Program:

- States\* and territories\*\* may use their funding to run a rebate program.
- o All projects must use verified technologies or certified engine configurations.
- States and territories must use the same statutory priorities as the DERA National Program when selecting projects.
- States and territories must make a public notification listing project information on their state websites within 60 days of making a grant, rebate, or loan. Website postings must include the total number and dollar amount of rebates, grants, or loans provided, as well as a breakdown of the technologies funded.
- Please note that states and territories should stay on schedule as detailed in their work plans. Any potential FY 2014 DERA State Clean Diesel Program funds are currently planned to be disbursed as new award funds. This means that the states with FY 2012-2013 or FY 2013 State Program awards will need to complete all work before they can open any potential FY 2014 State Program new award.
- Please note that the normal attrition time for engine/vehicle replacement projects funded with FY 2013 State Program funds is September 2016, meaning that vehicles or engines in the projects must not be scheduled to be replaced before September 2016.
- States that did not open a new award in FY 2012: State Program funding for FY 2013 will be disbursed to these states as new awards. States with an open FY 2008-2011 DERA State grant must complete all grant activities and incur all costs for their current State Program grant by September 30, 2013, in order to receive FY 2013 State Program funds. States must submit a new application and an approvable work plan for a new FY 2013 award.
- States that opened a new award in FY 2012: State Program funding for FY 2013 will be disbursed to participating states a supplemental amendment. States must submit a new application and an approvable work plan for a new FY 2013 award.
- <u>Territories with current State Clean Diesel grants:</u> FY 2013 State Program funds will be
  dispersed as supplemental amendments to the participating territories' current State
  Program awards. Territories should note that the FY 2013 funding will be awarded
  under terms and conditions meeting the requirements of the Diesel Emissions
  Reduction Act January 2011 Reauthorization.

<sup>\*\*&</sup>quot;Territories" includes the Commonwealth of Puerto Rico, the Commonwealth of the Northern Mariana Islands, Guam, American Samoa, and the United States Virgin Islands.

- If all 50 States, the District of Columbia, and the five qualifying territories participate in the FY 2013 State Program, then:
  - Each State, the District of Columbia, and the Commonwealth of Puerto Rico will receive a base allocation of 1.887% of 2/3 of the total FY 2013 State Program allocation.
  - Guam, the United States Virgin Islands, American Samoa, and the Commonwealth of the Northern Mariana Islands will each receive a base allocation of 0.472% of 2/3 of the total FY 2013 State Program allocation.
- If fewer than all 50 States, the District of Columbia, and the five qualifying territories participate in the FY 2013 State Program, then the available base allocations to the participating states and territories will be modified in accordance with the methodology outlined at 42 U.S.C.§ 16133(c)(2)(B).
- States and territories cannot fund federally mandated projects.
