Section I. of the following table lists the Corps of Engineers Individual Standard Permit public notices received by EPA in July 2014 and all comment letters on individual standard permit public notices issued by EPA in July 2014. Section II. of the following table lists all comment letters on Corps of Engineers Individual Standard Permit public notices issued by EPA between October 1, 2013 and June 30, 2014. Where the Corps has made a final permit decision, it is documented below and will not appear in subsequent reports. During this reporting period EPA received 153 Individual standard permit public notices, performed a detailed review of 90%, and subsequently provided comment letters on 10% of them. EPA is not the only commenter on Corps public notices. Other federal and state agencies and the public routinely provide comments to the Corps. Of the new public notices in Section I, the Corps has issued 23 permits, 6 applications where withdrawn, and 124 are still being processed.
