Where the Corps has made a final permit decision, it is documented below and will not appear in subsequent reports. During this reporting period EPA received 170 Individual standard permit public notices, performed a detailed review of 83%, and subsequently provided comment letters on 8% of them. EPA is not the only commenter on Corps public notices. Other federal and state agencies and the public routinely provide comments to the Corps. Of the new public notices in Section I, the Corps has issued 25 permits, 6 applications where withdrawn, and 139 are still being processed.
