PROGRESS REPORT (OCTOBER 1, 2014 THROUGH DECEMBER 31, 2014)

Interim Measures

- The Interim Measures Implementation Report was submitted to EPA on August 27, 2014.
- Hydraulic Control System was running during this reporting period. The volume of water recovered from October 1, 2014 through December 31, 2014 is 286,247 gallons.
- Groundwater level measurements and groundwater samples were collected from the monitoring wells in November 2014. The groundwater monitoring will be reported to EPA in the next Annual Report which is due August 30, 2015.

Vapor Intrusion

■ The Vapor Intrusion Characterization Report was submitted to EPA on August 26, 2014. Mr. Don Wiggins (Walter Coke) received a Notice of Technical Inadequacy (NOTI), Vapor Intrusion Characterization Report dated December 19, 2014 on December 30, 2014. Walter Coke will prepare a response to this letter by February 13, 2015.

Interim Measures


- Collect groundwater levels in February 2015.
- Continue to tweak the iron filtration system to achieve optimal flow.
- Continue to explore other options to improve recovery system.
