### **CORE ELEMENT: Regulation**

Goal: Avoid and minimize alterations and losses of wetlands for protection of the important functions and values they provide and facilitate effective restoration. Conduct periodic reviews of wetland regulatory processes to identify opportunities for improving efficiency and effectiveness, including through data system improvements.

**Goal:** Assess the condition of the State's wetlands to understand the cumulative impacts of human activities on wetlands and to improve their protection and management. Continue to refine and apply wetland monitoring and assessment methodologies during the next three years building on projects completed with the Rhode Island Natural History Survey (RINHS), NEIWPCC, and technical advisors during the past six years.

# **CORE ELEMENT: Restoration and Protection**

Goal: Restore the quantity and quality of wetlands and their functions and values. Develop and implement a freshwater wetland restoration strategy with the assistance of advisors and in collaboration with other voluntary restoration initiatives. Collaborate with partners to prioritize restoration opportunities and build capacity for wetland restoration, with emphasis on riparian buffers, stream continuity and restoration of buffers around wetlands of high biodiversity.

Goal: Prevent degradation of wetland functions and values. Integrate non-regulatory wetland protection strategies into state and local (watershed) plans. Work across DEM programs and with other stakeholders involved in watershed-based planning to produce such plans for RI's designated watershed planning areas. Coordinate on outreach and technical assistance provided to communities to promote wetland protection.
