Dear Mr. Adams:

The United States Environmental Protection Agency (U.S. EPA) has completed its review of the following document submitted by Enbridge Energy, Limited Partnership, Enbridge Pipelines (Lakehead) L.L.C., Enbridge Pipelines (Wisconsin), and Enbridge Energy Partners, L.P. (herein collectively referred to as "Enbridge"):

Enbridge Line 6B MP 608, Marshall, MI Pipeline Release, Report of Findings Air Monitoring and Sampling: August through October 2011, Prepared for United States Environmental Protection Agency, Enbridge Energy, Limited Partnership, Submitted: February 24, 2012

Pursuant to Paragraph 18 of the July 27, 2010 Order, U.S. EPA approves, with modifications, Enbridge's above-referenced *Report of Findings Air Monitoring and Sampling: August through October 2011 ("RFAMS")*, including attachments, submitted to U.S. EPA on February 24, 2012. Enbridge shall incorporate the comments below into a revised RFAMS.


1. Section 1: Please provide a list of the "target analytes" referenced throughout the RFAMS.
2. Section 1.1, Bullet 4: Please add the Mill Ponds to the list of community locations monitored, as it was included later in the RFAMS.
3. Section 3.2:
 - a. Page 9: Please clarify that the hierarchy for the selection of the screening levels is for the 2010 Human Health Air Screening Levels.

- b. Please add the selection hierarchy for the 2011 Human Health Air Screening Levels.
4. Section 5.1:
 - a. Please identify the listed non-target analytes as Tentatively Identified Compounds (TICs) where applicable.
 - b. Please identify if you included acetaldehyde as a target analyte during this timeframe.
5. Attachment D, Raw Data: Please revise this attachment as follows:
 - a. Provide a key or legend explaining the columns in the printouts of raw data from the portable weather stations.
 - b. Provide an explanation of which columns should be populated.
 - c. Provide usable date/time stamps of the data.
 - d. Repaginate the tables to prevent having rows span multiple pages, or provide appropriate repeating columns to properly identify rows.
 - e. Please provide a data dictionary referencing a CD/DVD (or a downloadable file) to be included with the report.
6. Attachment F, Sample location figures: Please review and revise the daily figures to ensure that work areas are included and correct. For example, the work zones appearing in Figure C1 (Daily Briefing sheet) do not appear on some of the Attachment F figures (specifically Ceresco Sheet 16 of 81; Mill Pond Sheet 14 of 80; and Baker Sheet 29 of 79).

The revised RFAMS shall be submitted to U.S. EPA no later than 1700 EDT on April 23, 2012. Please submit an electronic copy of the report in Microsoft Word format for text, and in Microsoft Excel for other electronic files (tables, graphs, etc.).
