RE: Applicable Sources Under the SO₂ Data Requirements Rule

Dear Mr. Curry:

On August 21, 2015, the Environmental Protection Agency (EPA) promulgated the "Data Requirements Rule for the 2010 1-Hour Sulfur Dioxide (SO₂) Primary National Ambient Air Quality Standard." The final rule requires the Louisiana Department of Environmental Quality (LDEQ) to "submit a list of applicable SO₂ sources identified pursuant to § 51.1202 located in its jurisdiction to the EPA by January 15, 2016." According to 40 CFR 51.1200 and 1202, applicable SO₂ sources are those that are not located in a designated nonattainment area and have annual actual SO₂ emissions of 2,000 tons or more based on the most recently available annual SO₂ emissions data for such sources.

A list of "applicable SO₂ sources" located in Louisiana is attached. This list is based on actual calendar year 2014 emissions as reported to LDEQ's Emissions Reporting and Inventory Center (ERIC).³
