Dear Mr. Mooney:

The Michigan Department of Environmental Quality (MDEQ) is submitting this letter to identify two companies in Michigan that are subject to requirements in the Data Requirement Rule (DRR). Escanaba Paper in Escanaba, Michigan and Lafarge Cement in Alpena, Michigan have exceeded the emission applicability threshold of 2,000 tons of sulfur dioxide (SO<sub>2</sub>) per year based on the Air Quality Division's (AQD) most recent emissions inventory for 2014. A portion of the inventory containing the largest SO<sub>2</sub> sources in the State is enclosed.

The companies were previously contacted by letter on December 8, 2015, notifying them of the applicability of the DRR to their facilities. A timetable for required actions was included. The AQD will be working with these two companies to assure compliance with the requirements going forward.
