Re: U.S. EPA's Supplemental Notice of Approval With Modifications of Enbridge Energy, Limited Partnership's Waste Treatment, Transportation, and Disposal Plan in response to the Removal Administrative Order issued by U.S. EPA on July 27, 2010, pursuant to §311(c) of the Clean Water Act in Docket No. CWA 1321-5-10-001

Dear Mr. Fridel:

On August 3, I sent you the United States Environmental Protection Agency (U.S. EPA) approval with modifications to the Enbridge Energy, Limited Partnership's Waste Treatment, Transportation, and Disposal Plan. (the Plan). By this Notice, I am supplementing that approval with an additional modification.

As required by my August 3, 2010, letter, U.S. EPA approves, with modifications, this Plan and asks for a revised hardcopy to be submitted to the U.S. EPA Incident Commander (IC) no later than 5 p.m. Eastern on August 8th, 2010. Until the revised hardcopy is available to replace the current version, the Workplan as submitted may be used as long as U.S. EPA's modifications are attached to the Workplan and are adhered to by Enbridge.


Enbridge must make the following supplemental modification for the IC's approval of your plan:

Enbridge shall submit on a weekly basis, beginning on August 9, 2010, a written report to EPA providing the cumulative amount of oil attributable to Enbridge's pipeline spill in Michigan that has been sent to Enbridge's Griffith, Indiana location, or to any other off-site location. For purposes of this report, provide the volume of crude oil after Enbridge has separated it from any water. This shall be done by gauging the volume of oil/water mixtures in each truck that is shipped to the Griffith facility (or any other facility) and then by metering the flow of the oil and water into the facility process. Enbridge shall provide EPA with access to confirm, with independent gauging devices, readings obtained at the Griffith facility. All gauging measurements and petroleum product estimates prior to the establishment of this procedure will be provided as a separate document.

In addition, the above report shall provide a weekly summary of crude oil-contaminated soils and contaminated debris waste streams which have been shipped from the site for off-site disposal. This report shall include detail regarding waste profile and supporting data for each waste stream. Such supporting data shall include total petroleum hydrocarbon content.

Along with the specific comments set forth in the August 3, 2010 approval letter, Enbridge shall incorporate the modification identified above into the revised Plan, pursuant to Paragraph 20 of the July 27, 2010, EPA Order. To the extent that Enbridge has questions or concerns regarding this modification Enbridge shall immediately inform the IC or designated EPA representative.
