By this memorandum, the Technical Support Center (TSC) is updating the scope of certification for the Region 4 Analytical Services Branch (ASB) Laboratory in Athens, GA, based upon our review of an April 2015 assessment of the laboratory by ANSI-ASQ National Accreditation Board/ACLASS (ANAB). This assessment evaluated conformance with ISO/IEC 17025:2005 and chemistry elements in the Fifth Edition of (and relevant supplements to) the Manual for the Certification of Laboratories Analyzing Drinking Water, EPA 815-R-05-004, January 2005 (the "Laboratory Certification Manual"). The Scope of Certification, detailing the drinking water methods and analytes addressed under the certification, is attached.

This certification expires on June 27, 2018, and is contingent upon the continual successful analysis of annual Proficiency Testing samples and continued adherence to the relevant terms of the Laboratory Certification Manual. The laboratory is subject to interim assessments (remote or on-site) and is responsible for addressing any finding identified in such assessments. Reports resulting from any assessments by an International Laboratory Accreditation Cooperation (ILAC) Mutual Recognition Arrangement (MRA) signatory, and responses to any findings associated with such assessments, must be shared with TSC.
