Dear Mr. McLerran:

On behalf of Governor Walker, the Alaska Department of Environmental Conservation provides the following recommendation for the initial designation of areas for the 2015 revised ozone (O₃) national ambient air quality standards. Please accept this letter as an initial designation recommendation in accordance with the requirements of Section 107(d)(1)(A) of the Clean Air Act.

Ozone air quality measurement has occurred at five sites in Alaska and continues at three. Three-year design values recorded at these monitors do not exceed the primary and secondary 8-hour exposure limit of 0.070 parts per million (ppm). A comparison of historical design values to the standards is presented below:

Monitoring also occurred at the Wasilla site (02-170-0013) in 2011, 2012, and 2014, which indicated 4th maximum daily ozone values ranging between 0.045 and 0.049 ppm.

² Not applicable, monitoring began in April 2015.

Ozone monitoring in Alaska indicates ozone design values are unlikely to approach the ambient air quality standard of 0.070 ppm. Based on the current design values at two sites, the historical design values and monitoring data, and the lack of ozone monitoring in other areas of the state, the state recommends that all land within the borders of the State of Alaska be designated as unclassifiable/attainment with respect to the ozone primary and secondary national ambient air quality standards:
