The life of *Kanaka Maoli*, the indigenous Hawai`i people, is linked closely with *kalo*, also knows as the taro plant. *Kalo* is believed to have the greatest life force of all foods. *Kalo* and poi (pounded *kalo*) are a means of survival for the Hawai`i people. By eating kalo as poi, one at a time as a ritual around the poi bowl (`umeke) at the center of the diners, the protocol of Hawai`i is maintained. This is a ceremony of life that brings people together and supports a relationship of `ohana (family) and of appreciation with the `aumakua (ancestors).

# **Environmental Awards**

The new law will help to conserve Hawai'i's limited resources and make beverage producers responsible for their packaging waste.

"Providing Resolutions with Integrity for a Sustainable Moloka'i" is the mission of PRISM students, who look at tough environmental issues as opportunities for learning and developing collaborative partnerships. Each year, fifth- and sixth-grade students select one environmental issue for investigation; gather background information; write research questions; and plan and host a symposium to share their investigations with the community.
