EPA Brownfields, ATSDR & Public Health

- ATSDR and USEPA identified a need to incorporate public health in the brownfields process
- The Brownfield Law allows use of up to 10% of EPA brownfield grants for health monitoring activities
 - health education, identification of community health issues, geospatial analysis
- ATSDR is working with EPA and Grantees to better define health monitoring activities.

DPL Assessment Grant

- Assess the extent of unexploded ordnance (UXO) and munitions constituents (MC) contamination at Marpi Point Village Homestead
- Evaluate actual health impacts associated with UXO in the CNMI with assistance from USEPA and ATSDR

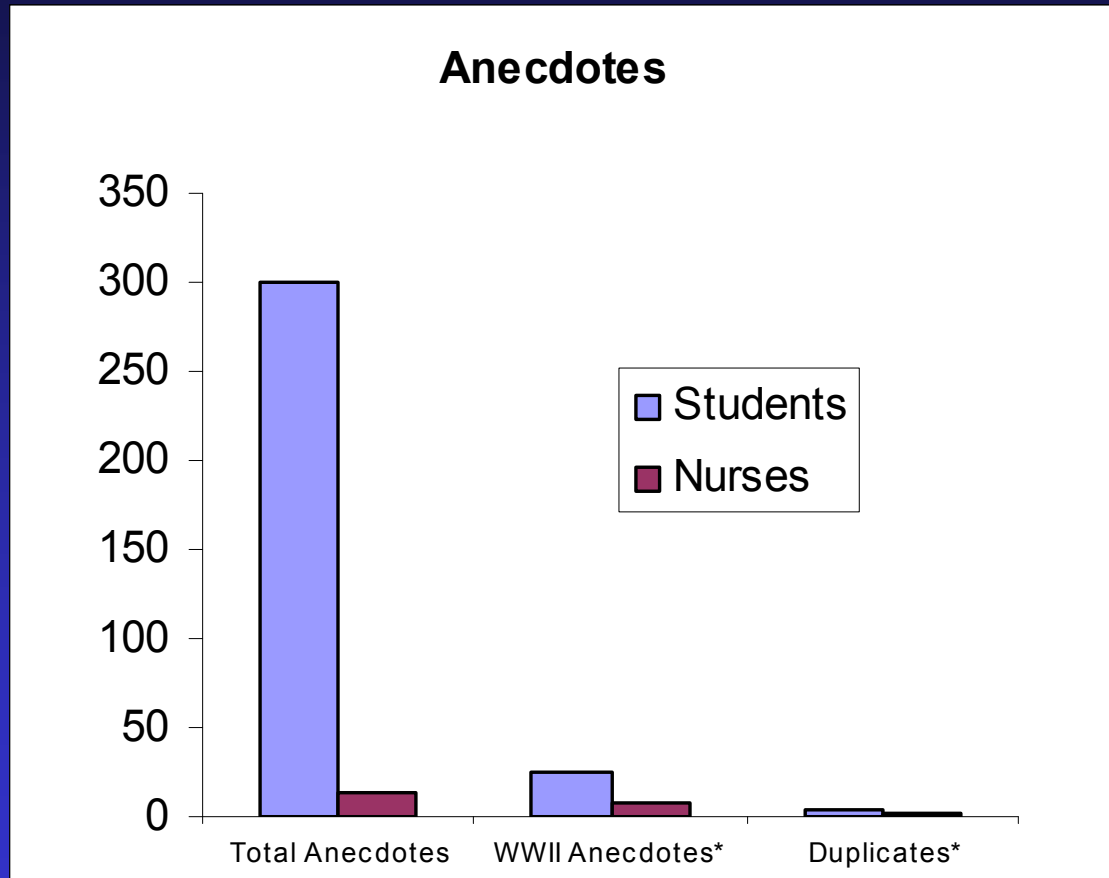

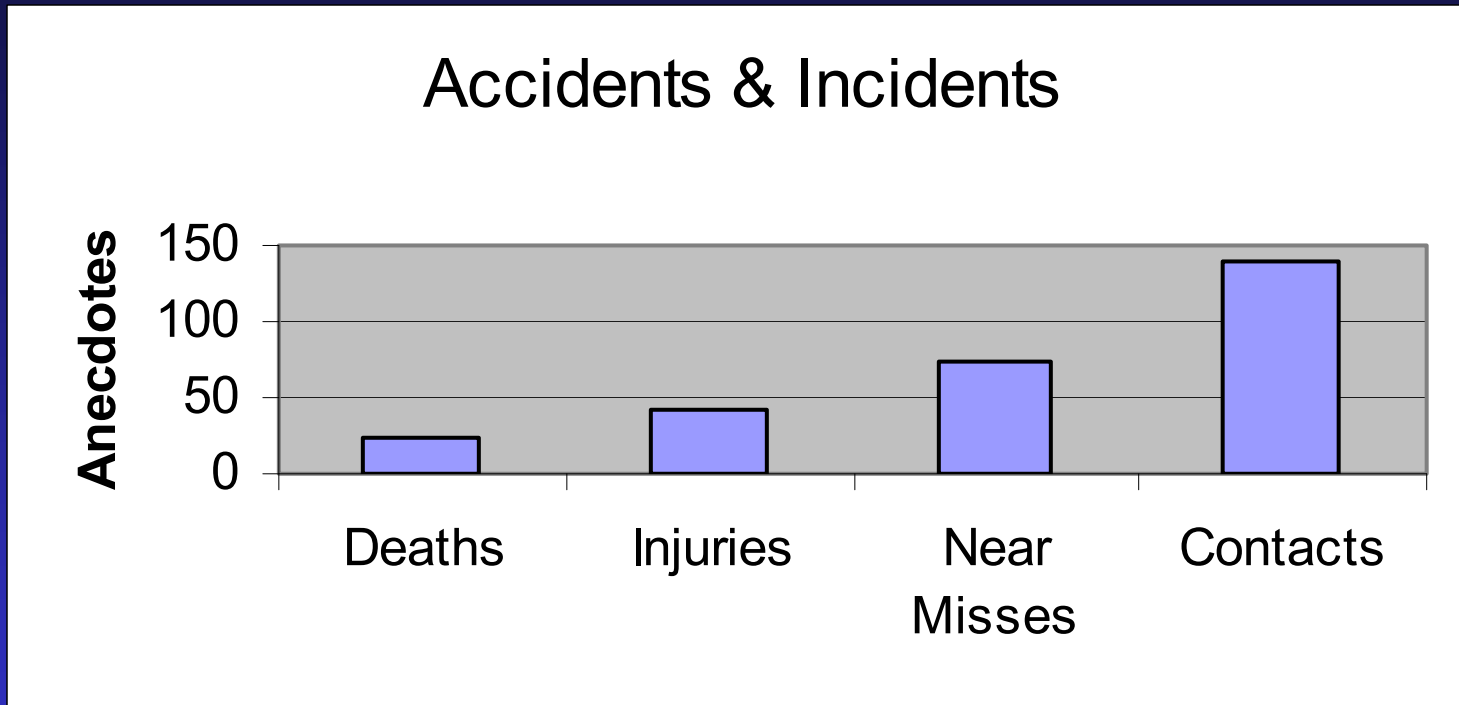

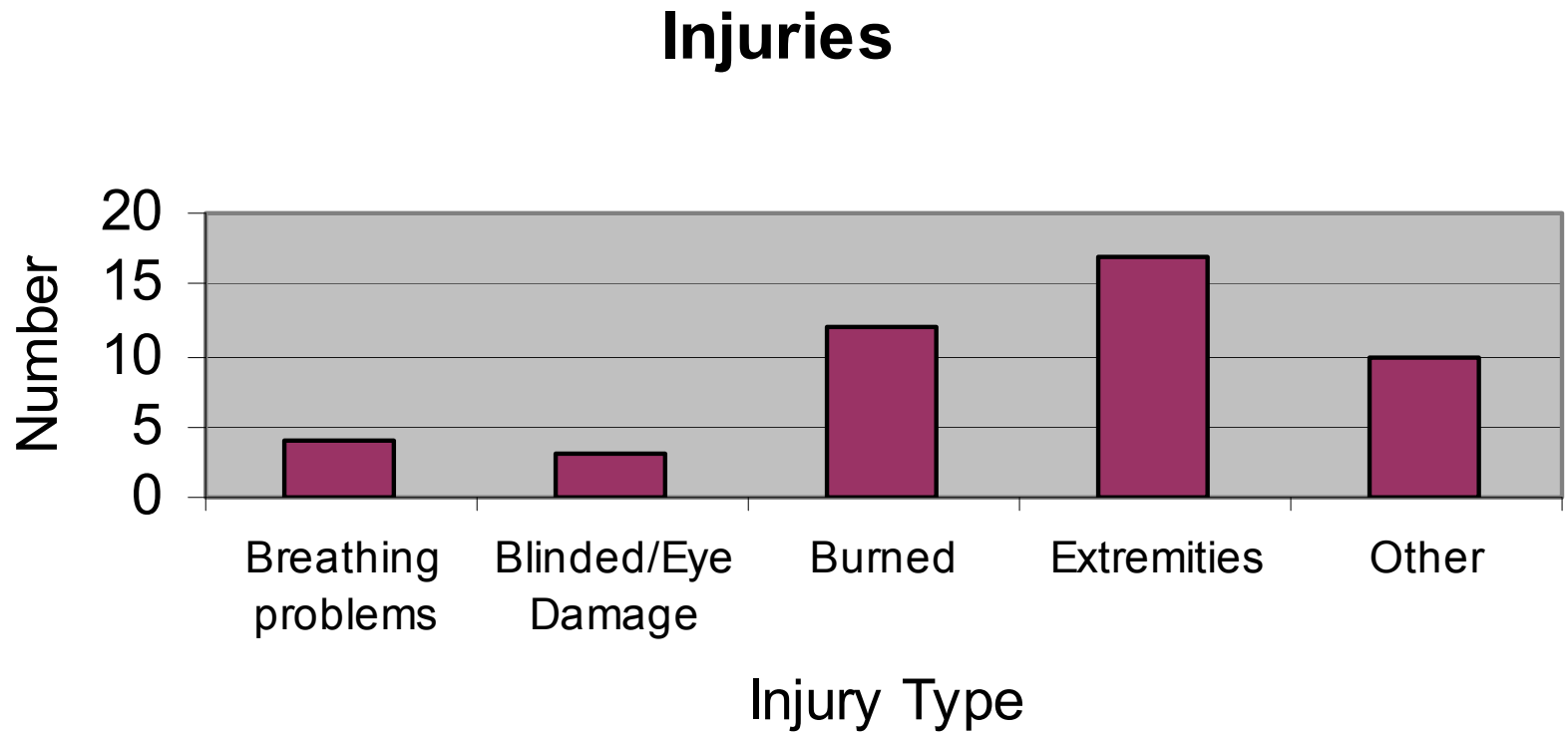
