# What is Electronic Waste?

- Different definitions for different groups
- Federal: Universal Waste & CRT Rule
- <u>AZ & NV</u>: Solid Waste + Recycling programs
- <u>CA</u>: SB20/50 "Covered Electronic Devices"
- Businesses: components, scrap or brand
- Public: no distinction, any circuit-board



#### Federal: Universal waste and CRT Rule

- Determination:
  - Does the device contain mercury or lead?
  - Hg-containing device examples: thermostats, barometers, manometers, temperature/pressure gauges, mercury switches (in cars); lamps: like halide in street lighting or in some video projectors, CFLs.
  - Batteries & pesticides are already u-waste.
  - 40 CFR 273.9: 5,000kg/11,000lbs is divide for size of U-Waste Handler.
  - Pb in CRT glass handled through CRT Rule.



# **EPA's CRT Rule**

- CRT Rule filters further between product & waste
  - Functional systems, components, or "processed" glass cullet are all classified as product, not waste.
  - Export for reuse or recycling?
    - All recycling exports require consent of receiving country, and notification of EPA's Office of Enforcement & Compliance Assurance.
    - Reuse exports require one-time notification to Regional office (Jim Polek, R9)

# **Digital Television Transition (DTV)**

- Signal Switch on February 17, 2009
- Analog TVs with cable and satellite service <u>unaffected</u>.
- Analog TVs with antennas (outdoor & rabbit ears) will need a converter box.
  - Converter Box Coupons, \$40 value, limit 2 per household for purchase of two digital-to-analog converter boxes.



# **DTV (continued)**

- Prevention is Best
- Important Message: Analog TV can still work, and people do not need to junk it. Coupons can help decrease costs of a converter box.
- <u>Getting the word out</u>: If tribal & local governments can increase coupon participation, we can cut down on possible dumping of old TVs.

## **Panel Discussion**

- <u>Household mix</u>: used tires, broken washing machine, old microwave, old vacuum cleaner, used batteries, and a broken TV.
- <u>Recycling company</u>: "buyer beware" use FEC auditing and selection checklists to determine if they are right for you.
- Wal-Mart, Best Buy, Staples, others expanding their collection pilots. Tribal opportunity.

#### **Take Home Messages**

- Different parties define 'e-waste' differently
- Lots of resources to deal with the challenge
  - Focus on federal tools to <u>pick the best solution</u> for you.
- EPA is concerned about the impact the digital television transition will have on tribes.
