The U.S. Environmental Protection Agency, Region 9 (USEPA) is issuing a notice of proposed action under the Clean Water Act (CWA). The USEPA is proposing to issue a National Pollutant Discharge Elimination System (NPDES) permit NN0000019 to:

Four Corners Power Plant
Fruitland, New Mexico 87416

The United States Environmental Protection Agency, Region 9 (USEPA) provides notice of, and requests public comment on, USEPA's proposed action relating to the National Pollutant Discharge Elimination System (NPDES) permit application for renewal of the above reference permit. USEPA is issuing a proposed NPDES permit in Indian Country that would permit the discharge of effluent from Morgan Lake to the No Name Wash, tributary to the Chaco River which eventually drains to Segment 2-401 of the San Juan River in compliance with the provisions of the Clean Water Act (CWA) (Public Law 92-500, as amended, 33. U.S.C 1251 et seq.) to Arizona Public Service Company (APS). The address for APS is P.O. Box 355, Station 4900, Fruitland, NM 87416. The proposed location of the action is at the existing Four Corners Power Plant (FCPP) located at the end of San Juan County Road 6675 in Fruitland, NM.

All comments that are received will be included in the public docket without change and will be available to the public, including any personal information provided, unless the comment included Confidential Business Information (CBI) or other information whose disclosure is restricted by statute. Information that is considered to be CBI or otherwise protected should be clearly identified as such and should not be submitted through e-mail. If a commenter sends e-mail directly to the USEPA, the e-mail address will be automatically captured and included as part of the public comments. Please note that an e-mail or postal address must be provided with comments if the commenter wishes to

receive direct notification of USEPA's final decision regarding the Application and proposed permit.

Before taking final action on the Application, USEPA will consider all written comments submitted during the public comment period, including at the Public Hearings described above. USEPA will only respond to those oral comments that were presented during the scheduled Public Hearings.

USEPA will send notice of our final permit decision to each person who submitted comments and contact information during the comment period or requested notice of the final permit decision. USEPA will summarize the contents of all substantive comments and provide written responses in a document accompanying USEPA's final permit decision. USEPA will also make a transcript of the Public Hearing proceedings available to the public. Within 33 days after EPA issues the final permit, any person who filed comments on the draft permit or participated in the public hearing may petition the Environmental Appeals Board to review any condition of the permit decision (40 CFR Part 124.19).
